NATIONAL BOARD OF CHIROPRACTIC EXAMINERS (NBCE) UPDATE

Report from November 12-14, 2004 Part IV Examinations

Dr. Clark Davis was the board member elected to attend the NBCE Part IV examinations in Portland, Oregon.

Dr. Clark Davis stated that he was impressed with the procedures and objectiveness of the NBCE. He said the examination was performed in a very organized and methodical manner.

FEDERATION OF CHIROPRACTIC LICENSING BOARDS (FCLB) UPDATE

<u>Providers of Approved Continuing Education (PACE)</u> <u>Update</u>

The board has requested regulatory wording to be added to 12 AAC 16.320 reflecting that PACE approved programs will be accepted, provided they meet the criteria set out in 12 AAC 16.320.

The board, upon request, will continue to review continuing education requests for approval from those programs that choose not to go through PACE.

REGULATIONS

The board reviewed and made amendments to several of its regulations and drafted new regulations. The proposed regulations that have been presented to the Division's Regulations Specialist are:

ARTICLE 5 – NEW SECTION UNLICENSED ASSISTIVE PERSONNEL

- (a) A licensed chiropractic physician may delegate to chiropractic assistants/aides the performance of physiological therapeutic modalities.
- (b) The licensed chiropractic physician shall have in possession written treatment plans formulated by the chiropractic physician for each patient under the care of the chiropractic assistant/aide.
- (c) The licensed chiropractic physician shall give the chiropractic assistant/aide supervision and shall be available for consultation with the chiropractic assistant/aide.
- (d) A licensed chiropractic physician who employs a chiropractic assistant/aide shall;
 - (1) determine the frequency and manner of consultations with the chiropractic assistant/aide, taking into consideration the treatment settings being used, patient rehabilitation status, and the competency of the chiropractic assistant/aide:
 - (2) fully document the supervision provided, including a record of all consultations provided, and maintain those records.

12 AAC 16.990 Definitions

New subsection: (6) "physiological therapeutic modalities" means the use of thermotherapy, cryotherapy, high-frequency currents, low-frequency currents, interferential currents, hydrotherapy, exercise therapy, stretching, bracing and supports, trigger point therapy, ultrasound and other forms of therapy.

This does not include the practice of physical therapy as a profession nor does it include the diagnosis, formulation of chiropractic impression or chiropractic adjustment.

12 AAC 16.920 MINIMUM PROFESSIONAL STANDARDS

New subsection: (c) a doctor-patient relationship is established once a consultation, evaluation, diagnosis, opinion, or treatment recommendation about a patient's actual personal health care history occurs in a clinical setting.

New subsection: (d) a doctor-patient relationship is established once a consultation, evaluation, diagnosis, opinion, or treatment recommendation about a patient's actual personal health care history occurs in a clinical setting.

12 AAC 16.030 LICENSURE BY EXAMINATION

New subsection: (a)(5) An applicant who has held a license in any state, jurisdiction, or foreign country will need to submit verification of present license status reflecting the applicant has held a licensed in good standing to practice chiropractic.

12 AAC 16.170 Special Examination

The board unanimously agreed and decided to eliminate section (a) of 12 AAC 16.170. Special Examinations will be offered to Locum Tenens Permit applicants only.

12 AAC 02.150(a)(1) FEES

New subsection: (D) \$25 application fee for Continuing Education Requests for Approval.

The board would like to remind readers that these are proposed changes and not yet in effect. Public comment received regarding the proposed changes prior to and after the public comment period will not be heard.

CE Requests for Approval

A continuing thank you to Dr. Fred Risch for his ongoing review of requests for board approval of continuing education courses.

Requests for CE approval are received by the licensing examiner, who indexes the courses and forwards them to Dr. Risch.

Dr. Risch reviews the "Continuing Education Program Request for Approval" forms, course schedules, course descriptions, credentials of the instructors, number and type of credit hours, and makes a recommendation to the board.

The board, in a mail ballot or at a meeting, reviews Dr. Risch's recommendations and votes on course approval.

DIVISION OF OCCUPATIONAL LICENSING UPDATE

Investigative Report

Margaret McQuaid, Investigator, presented the investigative report to the board, which reflected that there are five open cases, of which two are for the same doctor, and three closed cases. One licensee remains on probation for five years.

All complaints must first go through the Division's Investigator ((907) 269-8184) and not through the board.

Anyone may make a complaint against a chiropractor. The Division investigates all complaints.

The cost of investigations is directly reflected in the licensing fees of chiropractors.

Licensing information is public record (except information which is required to be kept confidential by state and federal law).

There are approximately 235 active licenses.
