#### A. SB74 DRAFT

Alison Osborne, Regulations Specialist went over the DRAFT to be submitted to the Department of Law that has been split into two projects for the board approved combined regulations projects of:

- SB74 Compact licensure;
- 6-month post-graduate internship removal by foreign-educated applicants by examination or credentials;
- clarifying the requirements for licensure for occupational therapy;
- updating the requirements of the 150-hour post-graduate internship listed in 12 AAC 54.600(C), 54.1000(5)(C) and 12 AAC 54.950(c) aka supervised service delivery;
- and NPTE testing, NBCOT Exam requirements, Jurisprudence Exam requirements; Audit Records Retention; CE Exemption for Active Military Duty, Temporary Military Courtesy license verification requirements, Change of Address verification, and update of documentation requirements for current certification from NBCOT.

Committee suggestion to have guidance notes on FP requirements to be posted on PHY FAQs of website due to change in regulation language section.
