1. Call to Order/Roll Call

Committee Members: Tina McLean, Tori Daugherty and Jonathan Gates

The Alaska Physical Therapy and Occupational Therapy Scope of Practices Committee meeting was called to order on Friday, March 7, 2025 at 9:00 am by Tina McLean. Roll call taken. Committee members present were Tina McLean and Tori Daugherty. Jonathan Gates, absent.

Staff member present for the meeting: Sheri Ryan, Licensing Examiner.

2. Review/Approve Agenda

Motion by Tina McLean to accept the meeting agenda as submitted. Seconded by Tori Daugherty. All in favor; none opposed. Motion passes unanimously.

3. Approve Minutes - 12/20/2024 + 02/07/2025

Motion by Tina McLean to approve the meeting minutes from February 7, 2025 as submitted. Seconded by Tori Daugherty. All in favor; none opposed. Motion passes unanimously.

4. Public Comment

5. NEW Board Correspondence

A. PT/OT State Licensure Questions

Insurance guidelines determines many of these requirements. AK PT/OT regulation is silent on. Regulation committee is currently working on regulation

project related to PTA/OTA supervision. No further action needed on this board correspondence past response sent by licensing examiner previously.

6. Draft Correspondence for Committee Review

A. APTA-AK - Referral for Diagnostic Imaging for Physical Therapists in AK - 02-26-2025

Committee discussed that conversation should not be limited to just Physical Therapists ordering imaging but also include Occupational Therapists ordering imaging. Any statutory or regulatory language would need to differentiate between ordering of imaging and taking of x-rays; no intent for PT or OT to actually take x-rays. Discussed X-ray, MRI, Ultrasound - diagnostic imaging. This is not related to e-stim or ultrasound used as therapy in practice treatment. Committee discussed briefly how reimbursement issues may still occur even if scope of practice is revised to include diagnostic imaging as board does not have jurisdiction over insurance payor policies.

Tina McLean motioned to send draft response regarding APTA-AK - Referral for Diagnostic Imaging for Physical Therapists in AK - 02-26-2025 with revision as discussed to the Physical Therapy and Occupational Therapy Board for review and approval. Tori Daugherty seconded. All in favor; none opposed. Motion passes unanimously.

7. Legislative Initiatives

A. DPT/OTD Term Protection Statutory DRAFT Language - revise per discussion 2/7

DPT and OTD are academic credentials issued by an educational institution and not linked to licensing status. Board direction from February board meeting to allow FSBPT/APTA to continue to monitor/address with their lawsuit for national entity that is utilizing Dynamic Personal Trainer. AK Board to take action if it becomes an issue in the State of Alaska. Possible changes to statute included in 5-year strategic plan. Committee to continue to monitor. Topic tabled until such time as additional action needed.
