Call to Order/Roll Call

2. Review/Approve Agenda

Tori Daugherty motioned to accept the agenda as submitted. Motioned seconded by Rebecca Dean. All in favor; none opposed. Motional passes unanimously.

3. Approve Minutes - 05/14/2025

Rebecca Dean moved to accept the May 14, 2025 Regulations Committee meeting minutes as submitted. Tori Daugherty seconded the motion. All in favor; none opposed. Motion passes unanimously.

4. Public Comment

No public comment given.

- 5. Regulations Projects
 - A. Definition of Employment and Professional Reference Requirements for licensure by credentials PT and OT

Draft language reviewed. Added "administrator" in addition to "supervisor". Added limitation of "within the 36 months immediately preceding the date the application is received" to the professional reference relationship so that it reflects current assessment of character and not from 5-10 years ago.

Discussed need for modifying submission of professional reference when applying by examination but determined not necessary. Right touch regulation standards. Recent graduate - limitation already exists when applying by examination that applicant has to pass national exam within last 24 months to qualify.

Mark-up done of Verification of Experience form.

- B. OTA/PTA supervision Question Research
 - Who can write progress reports or discharge notes? FAQ
 - Who can sign off on progress/discharge notes? FAQ no discussion.
 - i. How many can be supervised?

Each member to read 12 AAC 54.500(e) and 12 AAC 54.800(b) and draft language based on meeting discussion from 5/14/2025.

Reviewed draft language submissions and discussed in-depth. Domino effect of PT/OT supervision of PTA/OTA and PTA/OTA supervision of aides and techs. Reviewed MT and ID definitions - states that would be geographically similar to AK in rural health care needs. Discussion on gathering stakeholder input from APTA-AK and AKOTA on this topic. Staff advised that committees are made up of board members only. To have stakeholder involvement in process, would need creation of work group. To facilitate a work group, would required full board approval. Could invite state associations to give public comment on topic without forming work group.

AOTA does not support ratios or limits/caps for supervision as it does not allow for customized situations. Referred to AOTA Guidelines on Supervision document.

Other licensed personnel discussed. Athletic Trainers and Massage
Therapists would be working under their own license and practice act and
not directly supervised by a PT or OT. Patient collaboration is a referral
situation - lateral - not treatment supervised by a therapist.
Committee discussed possibility of clarifying responsibilities of
aides/technicians to perform rehabilitation services and ability of

therapists to delegate billable services to aides/technicians or any unlicensed personnel.

- ii. Clarification around telehealth and supervision
 - Telehealth questions when an assistant is alone?
 - Can an aide or assistant perform evaluations for a PT/OT on the other end of a telehealth visit. Can this be cross professional? Is there a way to write regulations around risk and responsibilities

- iii. Under what circumstances is a co-signature needed/required? no discussion.
- iv. What about PTAs and OTAs supervising aides/technicians (aka unlicensed personnel)?
 - Can a PTA or OTA supervise a technician What about a certified or professional technician and patient care

no discussion.

Previously tabled for SB74 Regulations project completion to use Supervised Service Delivery by Credentials as template. Revisit
