Commission members agreed to have staff make changes to the forms and email those to all Commission members and to review the form at the December 3, 2014 meeting for further consideration and/or adoption.

The Commission members asked that staff send an email to each of the individuals that submitted a public comment to let them know that the Commission reviewed their public comment and took action on those comments that they thought appropriate and thank them for their comment.

Commission members thanked Ms. Bates and Ms. Cartledge for all their work on the comments and forms prior to the meeting.
