continue to increase as the number of new and renewal licensee requests are made. The potential for
meat spoilage will continue to be an issue if game meat is not properly cared for after cutting. Not all
transporters may offer this service, but being a good steward of the resource is critical to industry success.

12 AAC 75.450. TRANSPORTER CONTRACT REQUIREMENTS. (a) A transporter or a registered CBPI guide-outfitter contracting solely to provide transportation services shall deliver a written contract to the client (1) within 90 days after receipt of a deposit, and before transportation services are provided; or(2) as soon as possible, and before transportation services are provided, if a deposit is received less than 90 days before transportation services are to be provided.(b) A written contract to provide transportation services must (1) include the name, license number, and signature of the transporter or guide-outfitter, and must include the name of the transporter's or guide-outfitter's business if it is different from the name of the individual transporter or guide-outfitter; (2) include the name and signature of the client;(3) list each big game animal to be hunted;(4) state the cost, payment schedule, and specific weight limitation, if any;(5) set out the deposit refund or transfer policy upon cancellation; (6) state that services are for transportation only; (7) state that guide services are not provided;(8) state that the client is responsible for salvage of the meat during the hunt; (9) state that the client is responsible for salvage of the meat after the hunt unless the meat is legally transferred to a third party; (10) identify the methods of communication with the transporter during the time clients are in the filed, such as use of a satellite phone, VHF radio, overflight, or signal device; (11) state who is responsible for the cost of extra trips to transport meat if necessary; (12) include the following statement: "A licensed transporter may provide transportation services with accommodations only at a permanent lodge, house, or cabin owned by the transporter or on a boat with permanent living quarters located on salt water. A licensed transporter may not accompany or remain in the field with a big game hunter who is a client of the transporter except as necessary to perform transportation services"; and (13) include the following statement: "A licensed transporter may not provide vehicles, fuel, camping, or hunting, or game processing equipment, or any hunting services such as skinning, caping, or cleaning of game, glassing, and packing in the field, including from a permanent structure or on a boat on salt water."(c) A transporter shall retain a copy of the contract for at least four years.(d) During portions of a hunt, a transporter is exempt from transporter contracting requirements of this section when providing transportation services for a client to, from, or in between specific locations operated by another transporter or registered guide-outfitter who has contracted this same hunt with the same client

Proposal for Professional Development

The subcommittee for Professional Development held two meeting to discuss the value and potential necessity for a professional development standard. The committee was represented by 3 Master Guides and 5 Registered Guides with experience covering the whole of the state. In order to steer focus for this first meeting I offered the following proposal as a starting point. It was vetted and discussed by all, resulting in unanimous consent of the "need" and a 5-3 decision in favor of recommended language. Those in opposition where (3 registered guides) who favored less BGCSB attendance requirements outlined in paragraph (c).

The BGCSB has historically used heavy fines to encourage discipline regarding knowledge of current statutes and regulations. Annual trends in unlawful administrative violations continues to be consistently higher than desired. These trends cause frustration from licensees and a higher workload for the department of public safety, division investigative services and department of law which ultimately results in higher costs to licensees and is the premise for discussion that more should be done by the BGCSB and its licensees to curb administrative infractions.

What infractions could be lowered with implementation of professional development standards?

- 1. Failure to disclose on license applications.
- 2. Failure to disclose a violation of a game or guide regulation.
- 3. Failure to renew bi-annual license.
- 4. Failure to renew Guide Use Area Registration.
- 5. Failure to follow contract regulations.
- 6. Failure to follow hunting regulations.
- 7. Failure to provide supervision as prescribed.
- 8. Failure to communicate as prescribed.
- 9. Failure to properly prepare hunt records and submit.
- 10. Failure to follow UVC requirements.

An argument could be made that simply expecting licensed Registered and Master Guide Outfitters to maintain current knowledge of policies, regulations, proposals and changes is not meeting the demand for self-discipline to mitigate unnecessary infractions. This, coupled with lack of participation and general understanding of the regulatory process, also has a diminishing effect on licensing standards and is thought by many to be a contributing factor in poor mentoring of assistant guides and an overall distrust of the process.

Subcommittee Recommendation

12 AAC 75.150. Professional development for assistant guide, class A assistant guide, registered guide-outfitter, master guide-outfitter, and transporter licensees.

(a) For renewal of any class of license, the applicant must complete a refresher examination prepared by the board under AS 08.54.600.

- (b) An applicant for a registered guide-outfitter license, must provide evidence of attendance to a minimum of three Big Game Commercial Services Board meetings either telephonically, through video conferencing, in person or by another means approved by the board.
- (c) An applicant for a Master Guide-Outfitter license must provide evidence of attendance to a minimum of five Big Game Commercial Services Board meetings and participation as a proctor in at least three regularly scheduled registered guide oral exam sessions. For this requirement; participation refers to the willingness and availability to participate as attested by the chairperson of the board or a board member delegated with this responsibility.
- (d) The requirements listed in this section will be documented on a form provided by the department and signed by the chairperson or a delegated board member at the time of completion.

The intent of the "refresher examination" listed in subsection (a) would be a tool to guide a licensee through the statutes and regulations to point out changes and those which disciplinary action was taken over the last two years. It would be online (or on paper if requested), could be taken as many times as required to successfully complete and posted near the beginning of the second year of the licensing period to provide adequate time for compliance. Once successfully completed the online tool would prompt the user to "submit" to BGCSB for filing. Approximately 20 questions are recommended with the intent of no more than 30 minutes to complete.

- 1. Sec. 08.54.760. HUNT RECORDS; CONFIDENTIALITY OF HUNT RECORDS AND ACTIVITY REPORTS. (a) The department shall collect and maintain hunt records provided by a registered guide-outfitter. A registered guide-outfitter shall submit to the department a hunt record for each contracted hunt within _____ days after the completion of the hunt.
 - A. 20 days
 - B. 40 days
 - C. 60 days
 - D. 90 days

The intent of mandating at least three BGCSB meetings for a registered guide applicant is to ensure they see how the regulatory process works, meet others engaged and gain the experience to make an educated decision of whether participation is in their best interest.

The intent of mandating at least five BGCSB meetings and three proctoring sessions for Master guide applicants is to provide yet another layer of required professionalism to the upper tier of our guide licensing pyramid. Most will agree this license holder should possess an in-depth knowledge of the regulatory process and participating in the registered guide testing program. Not only does this provide an avenue to alleviate some of the burden of testing to the small group that has been taking responsibility for it but also provides current knowledge for mentoring the next generation.

Education and participation could be the answer to a healthier program that can be looked at from the outside-in with high regard. This small change could have a positive impact.
