Ms. Hondolero had forwarded the draft regulation changes from the November meeting to the Board for review. 12 AAC 04.180 and 12 AAC 04.165 required additional review and discussion before being included in the project.

RESOLVED to send the following new regulation out for public comment:

12 AAC 04.180(h) One year of experience shall consist of full or part-time employment that extends over a period of no less than a year and no more than three years and includes no fewer than 2,000 hours of performance of services described in subsection (g) above.




