### Fee Analysis

The board discussed possible effects of raising the fees for new & renewing licenses as well as application fees. It was discussed that due to the different levels of licensure & different pay scales, the fees should vary depending on licensure level. Before coming to an agreement, the board discussed how other boards (i.e. nursing) request a higher fee from the applicants who have a higher level of licensure to absorb some of the extra costs from the individuals with a lower level of licensure.

# A motion duly made by Mr. Paulson, seconded by Ms. Kerr, and approved by unanimous consent, was:

Initial Application - \$100

Initial License - Clinical - \$400

Renewal License - Clinical - \$400

Initial License - Masters - \$350

Renewal License - Masters - \$350

Initial License – Baccalaureate - \$300

Renewal License - Baccalaureate - \$300

Temporary License – Masters & Baccalaureate - \$75

CEU Initial Application - \$100

CEU Renewal Application - \$50

### **SB 98 Amendment**

The Board discussed how the amendment to the Senate Bill could drastically affect the Social Work Board and the practice of Social Workers in the State of Alaska. Marilyn mentioned how we should aim to remain consistent with the national model offered by the ASWB.

# A motion duly made by Ms. Kerr, seconded by Ms. Olson, and approved by unanimous consent, was:

Propose an adopted regulation change to Senator Micciche & Senator Giessel to provide the Social Work Board with the supporting language to adopt restrictive regulations regarding the practice of telemedicine.

Chelsea will be sending additional information regarding the bill & amendment to Mr. Paulson in order for him to draft the proposal as acting chair.
