On April 28, 2017, the Alaska Board of Dental Examiners (Board) adopted a Consent Agreement regarding Dr. Charles Cole, Dental license number DEND628, for violation of Alaska Statute (AS) 08.36.315(6)(B) based on his acts of permitting an unlicensed individual, under his direct supervision, to perform hygiene procedures and direct patient care (e.g. limited teeth cleaning, fluoride varnishing, light scaling, periodontal charting and placement of sealants) on fifteen (15) patients. The Board ordered Dr. Cole to pay \$10,000.00 civil fine (\$5000 of which is suspended) and to receive a reprimand regarding his violations.
