Dear licensees and interested parties:

Alaska's professional licensing statutes (AS 08.01.065) require the Division of Corporations, Business and Professional Licensing (CBPL) to "annually review each fee level to determine whether the regulatory costs of each occupation are approximately equal to fee collections related to that occupation." Alaska's licensing fee statutes go on to say, "If the review indicates that an occupation's fee collections and regulatory costs are not approximately equal, the department shall calculate fee adjustments and adopt regulations...to implement the adjustments."

The Division proposes an increase in licensing fee amounts in order to comply with the statute listed above, as well as to continue to deliver its current level of service for the dietitians and nutritionists licensing program. The program expenses have slowly been using up its surplus for several years and is heading for a deficit at the end of the next biennium if the fees are not increased. Barring any unforeseen circumstances, this increase will stabilize the program and prevent the need for an even larger increase later.

This fee proposal is entering a public comment period. The division encourages all licensees and interested parties to comment on this proposal through the division's Regulations Specialist, whose contact information is enclosed on the public notice. After the comment period closes and the division reviews all comments received, the division may adopt the regulation as drafted, may amend a proposed fee, or may withdraw the regulations in part or in its whole.

All comments received will be reviewed and taken into consideration prior to adopting the final regulations. The final decision will result in the fee to be implemented during this fall's license renewal.

**OCCUPATIONAL LICENSING FEES FOR DIETITIANS AND NUTRITIONISTS:  
NOTICE OF PROPOSED REGULATIONS CHANGES  
DEPARTMENT OF COMMERCE, COMMUNITY, AND ECONOMIC DEVELOPMENT**

<p><b>BRIEF DESCRIPTION:</b> The Department of Commerce, Community, and Economic Development proposes to change occupational license fees charged to dietitians and nutritionists.</p>
--

The Department of Commerce, Community, and Economic Development (Department) proposes to adopt regulation changes in Title 12, Chapter 02 of the Alaska Administrative Code, dealing with occupational licensing fees for dietitians and nutritionists, including the following:

**12 AAC 02.195, Dietitians and nutritionists**, is proposed to be changed to alter the application, license, and renewal fees for dietitians and nutritionists.

Under AS 08.01.065, the Department must establish fee levels so that the total amount of fees collected for an occupation approximately equals the actual regulatory costs for the occupation. The Department has reviewed the income and expenses for the occupational licensing program for dietitians and nutritionists and proposes fee changes that reflect, to the extent possible, the actual costs of the activities related to the program.

You may comment on the proposed regulation changes, including the potential costs to private persons of complying with the proposed changes, by submitting written comments to Jun Maiquis, Regulations Specialist, Division of Corporations, Business and Professional Licensing, P.O. Box 110806 Juneau, AK 99811-0806. Additionally, the Department will accept comments by facsimile at (907) 465-2974 and by electronic mail at [jun.maiquis@alaska.gov](mailto:jun.maiquis@alaska.gov). Comments may also be submitted through the Alaska Online Public Notice System, by accessing this notice on the system at <http://notice.alaska.gov/178157>, and using the “comment” link. **The comments must be received no later than 4:30 p.m. on October 6, 2015.**

You may submit written questions relevant to the proposed action to Jun Maiquis, Regulations Specialist, Division of Corporations, Business and Professional Licensing, P.O. Box 110806 Juneau, AK 99811-0806 or by e-mail at [jun.maiquis@alaska.gov](mailto:jun.maiquis@alaska.gov). **The questions must be received at least 10 days before the end of the public comment period.** The Department will aggregate its response to substantially similar questions and make the questions and response available on the Department’s website at <https://www.commerce.alaska.gov/web/cbpl/ProfessionalLicensing/DietitiansNutritionists.aspx> or on the Alaska Online Public Notice System. The Department may, but is not required to, answer written questions received after the 10-day cut-off date and before the end of the comment period.

12 AAC 02.195 is amended to read:

**12 AAC 02.195. Dietitians and nutritionists.** The following fees are established for dietitians and nutritionists:

- (1) application fee for initial license, **\$100** [\$50];
- (2) license fee for all or part of the initial biennial license period, **\$125** [\$50];
- (3) biennial license renewal fee, **\$125** [\$50]. (Eff. 11/14/99, Register 152; am
