Administrator's narrative:

Since our last meeting, we hired a second licensing examiner, Elton Engstrom, and I also assisted the agency in interviewing candidates for a licensing examiner vacancy (we team interview).

Issues:

LARE examinations:

Exam Irregularity:

We had 2 candidates scheduled to take the exam Dec. 9-10, 2002. As a result of mistakes made in the Anchorage office, the 2nd day candidate was not able to sit for the exam. The Anchorage staff inadvertently returned the exam by traceable means to the Juneau office. Staff attempted to return the exam to Anchorage but fog intervened.

I've continued to work on ongoing issues:

- Proposed regulations: engineer disciplines, land surveyor model law, Board adopted regulations: technical changes in three areas, engineering table, architect education standard, and architect IDP requirement for those registered after 1/1/1990; and one change, a requirement for signature with stamping.
- Proposed statutes: term limits, continuing education authority, and specialty contractor (not performing architecture or engineering.

The bulk of the examiner's effort has been to work on applicant files and will shift to status letters and issuing licenses during the post board meeting, as well as working on the exam administration for April NCEES exams and the AKLS exams.

Board Travel:

Through legislative funding, and strong Division of Occupational Licensing (O.L.) support, Board members and staff have been able to attend several national and regional meetings. We are showing good presence at the meetings, allowing us opportunities to continue to network with other jurisdictions (Board staff and Board members and to participate in leadership roles). Bob Miller has represented us at the Pacific Pacific NorthWest Economic Region meeting in Seattle on Feb 11 and also the NCEES Presidents' Assembly/MBA meeting in Girdwood on Feb 13-14^{th.} (I also attended the NCEES MBA meeting). Additionally, Board members serve on committees and have continued to show our presence.

Exam Security

NCEES has had numerous issues with exam security issues ranging from missing exam booklets or answer sheets and shipping irregularities that have resulted in redoing some examinations at costs in excess of \$500,000. Issues discussed at the recent NCEES meeting highlight the responsibilities and the potential financial liability for jurisdictions.
