Ms. Polley stated a person who guided persons outside the guide use area is an ongoing problem that is coming up in cases and she believes that the policy needs to be put into place to remind people of the area expiration dates. One of the things that is confusing to the general public member on the guide use area registration is the effort that is made to clean up the boundaries and one of the things we should do is have seminars on the registration process. She will vote to accept the agreement. Chairman Vrem stated the department has again begun to mail out expiration notices. There was a gap of time when this did not occur. And he believes that is a contributing factor. It's a courtesy by the state and people should be aware of it. He believes there will be a dramatic reduction now that reminders are going out and he feels bad with the guides who got caught up in this. Mr. Atkins stated he thinks this goes along with the board's intent to reduce paperwork so this is a good step by the state to reinstate this process. Chairman stated that it was a dropped because of a change of personnel and supervision and after some brief discussion from the board it was reinstated.

Mr. Mumford offered an amendment that the board directs the investigators to not take any further action on this case. Ms. Polley accepted the amendment. This is one he does not agree with that was investigated. It was an incidental trapping case and

the guide did not have time to turn in the cat after it was caught in a coyote set. It was pointed out to him and he was cited. It's not an action we want our investigators to spend their time on. The only time he could see this jumping up is if the person fails to disclose it during renewal. Chairman Vrem stated that it will add to investigations workload to remind these guides to disclose it; although this guide had done so on his own. His option to self-report was removed by enforcement and the board does not wish to hold this gentleman accountable by voting to reject the consent agreement. Mr. Mumford agreed.
