39	On a motion duly made by Ms. Mielke and seconded by Ms. Bigelow-Hood, the Board approved by

48	3. Investigations Update

50	On a motion duly made by Ms. Mielke and seconded by Ms. Bigelow-Hood, the Board approved by

1 roll call vote to that the Alaska State Medical Board enter into executive session in accordance with AS

2 44.62.310(c), and Alaska Constitutional Right to Privacy Provisions, for the purpose of discussing Case

- 3 number 2023-00013 with Board and Investigative staff to remain during session.

11 On a motion duly made by Ms. Mielke and seconded by Ms. Bigelow-Hood, the Board approved by roll call vote to grant Dr. Megan Aspelund a full license. 12

17 4. Special Topic: Pharmacy Agreements and Proposed Regulation Changes

18 Chair Wein initiated an introduction to this topic by identifying and explaining the requests from the

- 19 Board of Pharmacy outlined in a letter to the State Medical Board dated November 21, 2022. The
- 20 requests include 1) a repeal of the requirement for a physical exam of the patient as currently required
- 21 in 12 AAC 40.983. (d); and to change in regulation the title of from "Cooperative" Practice Agreements
- 22 with Pharmacists to "Collaborative" Practice Agreements with Pharmacists.
- 23 Chair Wein also provided a general overview of pharmacy agreements as outlined in Medical Board
- 24 regulations 12 AAC 40.983. Most Board members acknowledged having no knowledge of Pharmacy
- 25 Agreements, prompting a discussion regarding the scope of services, informed consent and health
- 26 emergency protocols provided by pharmacists under such agreements. Chair Wein invited Board of
- 27 Pharmacy Chair, Dr. Ashley Schaber to address guestions and concerns raised by Board Members. A
- 28 question was raised as to whether pharmacies are providing informed consent specifically for COVID
- 29 vaccinations. Chair Schaber advised that pharmacies should be able to provide copies of informed
- 30 consents for any vaccines administered. As a follow up, it was suggested the Executive Administrator
- 31 should request copies of the informed consents provided by pharmacies for vaccines. Dr. Schaber noted 32 that pharmacy agreements were originally created and intended as clinical agreements for pharmacies
- 33 embedded in clinics. Yet, as in the example pharmacy agreement provided to Board members, it was
- 34 pointed out by Ms. Norberg that the context for the majority of agreements currently in operation are
- 35 not embedded clinics. No decision was made with respect to the proposed regulation changes as
- 36 presented. Chair Wein recommended Board members independently consider desired edits to the
- 37 regulations and for this matter to be addressed again at a later date.

39 5. Discussion on Proposed Legislation

41 HB 85 / SB 83: Universal Temporary Licensing

- Chair Wein provided an overview of the bills and opened the floor for discussion. Several members 42
- 43 voiced support for the bills, citing the measures designed to help board staff expedite initial licensure
- 44 and the ability to extend temporary licensure for an additional 180 days as being especially favorable for
- 45 licensees.
- 46 On a motion duly made by Ms. Mielke and seconded by Ms. Bigelow-Hood, the Board approved by
- 47 roll call vote to request the Executive Administer to draft a statement of support for HB 85 / SB 83 -
- 48 Universal Temporary Licensing and this for this position statement to be transmitted to the
- 49 legislature as soon as possible.

6 • SB 91: Telemedicine and Multidisciplinary Teams

7 Chair Wein provided an overview of the bill and opened the floor for discussion. Several members

8 noted that the language of the bill is confusing, and the intent is unclear. Ms. Mielke read the bill's

- 9 sponsor statement out loud to help provide clarity for the type of professionals that comprise a
- physician's multidisciplinary team. It was further recognized that the bill is intended to expand the
 flexibilities of the 2022 telemedicine legislation to allow midlevel healthcare professionals, not licensed
- 12 in Alaska, the ability to provide services to Alaskans. It was suggested that a meeting with the bill's
- 13 sponsor, Senator Claman, may be needed before the Board takes a position on whether to support or
- 14 propose the bill.

16 • SB115: Physician Assistant Scope of Practice

17 Chair Wein provided an overview of the bill and opened the floor for discussion. Chair Wein reminded the Board that draft regulations intended to modernize the practice of physician assistants were 18 19 approved and forwarded for legal review and public input. This bill goes much farther with respect to 20 expanding the scope of practice for physician assistants than the draft regulations Ms. Bigelow-Hood 21 advised that she is scheduled to meet with McKenzie Pope, staffer for the bill's sponsor, Senator Tobin, 22 to gather more information regarding the intent of the bill. A decision regarding whether to support or 23 oppose the bill was postponed until Ms. Bigelow-Hood reports back to the Board regarding the 24 sponsor's intent.
