Smith, Melinda S.	2019-001037	127882	<p>On February 4, 2021, the Alaska Board of Nursing adopted the Order of Default to revoke Melinda Smith's registered nurse license No. 127882 after a default proceeding in accordance with AS 44.62.530. On October 26, 2020, the Division filed an Accusation against Ms. Smith's registered nurse license alleging violation of AS 08.68.276, 12 AAC 02.960(e), and 12 AAC 44.600 et seq. The central issue of the Accusation was Ms. Smith's failure to prove completion of continuing competency as required, and her failure to comply with the requirements of a random audit. The Accusation was properly served on November 6, 2020, in accordance with AS 44.62.380. Ms. Smith failed to respond within 15 days of service as required by AS 44.62.390, and the Division proceeded to present its case of default to the Board on February 4, 2021. The Order of Default was mailed by certified mail to Ms. Smith's address of record in accordance with AS 44.62.530, which was delivered on February 20, 2021, and the revocation became effective on March 22, 2021, 30 days after the decision was mailed or otherwise delivered (AS 44.62.520). Under AS 44.62.550 and 12 AAC 44.785, Ms. Smith may apply to reinstate her license after one year from the effective date of its revocation.</p>	Order of Default Revocation
