Agenda Item 3: Yuut Elitnaurviat Provisional Approval Proposal for APU LPN program

Agenda Item 6 AANP Letter on Home Health Regulation Changes

Shannon Hilton-representative for the AANP, and APRN Alliance and Marissa Bune with the APRN Alliance lead the discussion on the upcoming regulation changes for home health and how they are going to affect the current APRN regulations. This change would allow APRN's to be able to certify home health patients in Alaska. Shannon Hilton asked the board to consider writing a letter of support to DHSS to consider this regulation change and remove barriers to home health care.

Division Director Sara Chambers also offered to reach out to DHSS on the matter.

Possibly removing sections 1-7, changing the timeframe for the one-time renewal of this application. Additionally, changing the title for Courtesy license to Emergency courtesy license, and the definition of 'urgent situation' to include specialized education. Will present the regulation changes to the board after the lunch break.

Agenda Item 8: PDMP report

Lisa Sherrill, Program Manager for the Prescription Drug Monitoring Program (PDMP) presented her report. She also discussed the idea of potentially adding the MME guidelines into regulations. She informed the board that the review compliance rate and registration with Aware has gone up for this program. Ms. Monrad offered to put some educational information together for the nurses in assisting them in the registration process and achieving a higher compliance rate.

Agenda Item 9: LNA/CNA II update

Joan Green, Renee Steffen, Denise Smith, and Tine Rein reported back to the board that discussions have slowed down due to the increase in COVID-19 cases and their focus' have been taking care of patients at their facilities. There has been discussion as to the possibility for having certified medication aides, in addition to having LNAs/CNA IIs. Dr. Steffen also addressed the need for medication aide in

their facilities. Ms. Smith and Ms. Rein expressed interest in LNAs and the ability for an RN to delegate administration of medications to a CNA. Ms. Rein indicated that NCSBN has established curriculum for this type of practice. Ms. Green addressed questions from the board regarding LNA and CNA variation in duties.

Agenda Item 10: Medication Course for UAP

Craig Baxter, DHSS Assisted Living Program Manager, spoke to board regarding the current UAP medication course maintained by the board. The UAP medication course has not been updated since 2013. Nurse Consultant Joan Green offered to review what is available for training and bring back at the February meeting with options for keeping the course updated. The board wants to make sure this is not a program that they will have to maintain.

Agenda Item 11: Licensing report and approval of Mat-Su CNA Training Program

The Board reviewed the licensing reports and the proposal allowing the Mat-Su CNA training program be an approved nurse aide training program.

On a motion made by Ms. Connelly, seconded by Ms. Tisdale and carried with 5 yeas it was,

RESOLVED that the Board of Nursing in the State of Alaska approves Mat-Su CNA Training

Program provisional status be removed and they become a State of Alaska approved nurse aide training program.

Agenda Item 11: Ketamine Advisory Opinion

Ms. Monrad presented her proposed an advisory opinion on the use of low dose Ketamine infusions in non-acute out-patient care settings. The board discussed the changes made to the advisory opinion presented at the August board meeting. The board will consider this opinion at a future meeting.

Agenda Item 12: Division report and Update on COVID -19 Board Chairs Meeting and COVID- 19 Response.

Division Director Sara Chambers presented letters from ASHNHA and DHSS to address the concerns on the needs of the health care work force. SB 241 is due to expire, and the Division is working to put a plan together with the health care boards to still meet the needs of COVID-19.

Division Director Sara Chambers discussed the board finances and went over the fourth-quarter financial report and gave an overview from the Guide to Excellence in Regulation for Professional Licensing Boards and Commissions, which provides for a deep-dive into the allocation methods applied for direct and in-direct costs to each division program.

changes for 12 AAC 44. 315 and 12 AAC 44.318

12 AAC 44.318

On a motion made by Ms. Monrad, seconded by Ms. Lafferty and carried with 5 ayes it was, **RESOLVED that the Board of Nursing in the State of Alaska**, finds that an emergency exists under AS 44.62.250 requiring an immediate expansion of courtesy licenses, and that an emergency regulation change is necessary to 12 AAC 44.318, dealing with an emergency courtesy license, for the immediate preservation of the public peace, health, safety, or general welfare. The facts constituting the emergency include the following:

Facilities are unable to maintain staffing levels due to the current and ongoing spike in COVID-19 hospitalizations and the increase in nursing staff unable to report to work due to COVID-positive tests, quarantine awaiting test results, or caring for a COVID-positive relative—especially in rural areas and in facilities serving special needs populations. The Commissioner of the Department of Health and Social Services has specifically requested health care boards implement emergency measures to allow qualified providers in other jurisdictions to become licensed quickly in Alaska to fill these gaps.

12 AAC 44.318. Emergency courtesy license. (a) In an urgent situation, the board will issue an emergency courtesy license to practice nursing to an applicant who meets the requirements of this section. The board may restrict the license to only those nursing services required to respond to the urgent situation. The licensee may not practice nursing outside the scope of the limited purpose for which the emergency courtesy license is issued.

- (b) An applicant for an emergency courtesy license under this section must submit to the department a completed application on a form provided by the department. A complete application includes the applicable application and licensing fees established in 12 AAC 02.280
- (c) An emergency courtesy license issued under this section is valid for the period specified by the board and may not exceed 120 consecutive days. An emergency courtesy license may be renewed for one additional period specified by the board, not to exceed 120 consecutive days, and provided the additional period expires within 18 months of the date the emergency courtesy license is first issued.
- (d) The board will not issue, and an emergency courtesy license holder may not use, an emergency courtesy license as a substitute for a temporary license or other license required under

- (e) While practicing under an emergency courtesy license issued under this section, the holder of the emergency courtesy license must comply with the standards of practice set out in AS 08.68 and this chapter.
- (f) The board may refuse to issue an emergency courtesy license for the same reasons that it may deny, suspend, or revoke a license under AS 08.68.270. it may deny, suspend, or revoke a license under AS 08.68.270.
- (g) In this section, "urgent situation" means a health crisis requiring an increased availability of nurses or nurses with specialized education

12 AAC 44.315

On a motion made by Ms. Monrad, seconded by Ms. Lafferty and carried with 5 ayes it was, **RESOLVED that the Board of Nursing in the State of Alaska**, finds that an emergency exists under AS 44.62.250 requiring an immediate extension of the current licensing period under 12 AAC 44.315 dealing with license renewal, and that an emergency regulation change is necessary for the immediate preservation of the public peace, health, safety, or general welfare. The facts constituting the emergency include the following:

The impact of COVID-19 on health care facilities has placed an additional burden on skilled nursing staff, resulting in delays in submitting applications for license renewal. Due to an increase in the volume of initial and renewal applications, plus COVID-related demands on administrative staff, it is probable that nursing license renewal applications will not be processed before the November 30 deadline, causing nurses to be unable to work when their licenses lapse on December 1. The commissioner of the Department of Health and Social Services has specifically requested health care boards implement emergency measures to ensure there are no gaps in service.

12 AAC 44.315 is amended to read:

12 AAC 44.315. License renewal. (a) A practical nurse license must be renewed biennially on or before September 30 of even-numbered years. A registered nurse license and advanced practice registered nurse license must be renewed biennially on or before <u>a date set by the department</u>

[NOVEMBER 30 OF EVEN-NUMBERED YEARS]. A renewal reminder document will be mailed to each currently licensed nurse at least 60 days before the renewal date.

(b) A license not renewed on or before the last day of the biennial licensing period lapses on the first day of the new licensing period. An applicant whose license has lapsed must meet the requirements under 12 AAC 44.317
