- Jen Twito, Program director for CNA program from Bartlett Regional Hospital Juneau wants to bring attention to the ongoing issues with Credentia testing. States they have problems with attempting to schedule exams through Credentia and have been having only three exams per year. They have been able to secure a local proctor who can test a lower number of students, but the exam is automatically cancelled if there are less than two students registered. Experiencing struggles with online written exam (students are being "kicked out" of exam, despite reliable internet). Takes dozens of email communications with them to complete these tasks. She says she recently became aware that WA state ended services with Credentia and she would also be interested in pursuing other options for testing.
- Beth Farnstrom speaks on behalf of Alaska Nurses Association asking if licensees have been notified if they are audited. Says she is against adding an additional APRN position on the board (because it would no longer be equal), feels that a CNA position could be added instead.
- Trisha Pavlicek states this is her first meeting attending and asks if NLC will be on the agenda as she has
 questions surrounding compact licensure in the state of Alaska. The questions are as follows:
 - o If we were to join NLC, how would the fees change and affect the ability of the AK BON to run.
 - Has questions about how disciplinary action would work if they were disciplined in another state, how they
 would be investigated to ensure they are safe to practice.
 - What is the process of moving forward after joining the NLC, and would other states have the ability to join our meetings and participate in decision making.
- Kimberly LaForce, RN, discusses shortage of nurses and asks how the BON will navigate the upcoming predicted shortage and what creative ways will be used to address the issue.

 the parent figure for the youth and are the ones to pass medication. All staff have to pass the required medical
 training to pass medication
 - o Ages between 11-17
 - o Detention and treatment facilities: Every facility has detention, but not every detention facility has treatment.
 - Part-time & PRN employees are not able to pass medication.
- Here today to request approval of oversight changes. Added competency checks every 6 months and refresher classes in person per unit. No changes have been made to distribution policy
- Incident tracker is used to track medication error, documentation error, medical error, missed medication, etc.
- NO intervention has yet been required by Department of Health for incidents that have occurred.
 - Incident reports are reviewed by Director of Nursing, Supervisor, and Superintendent of unit. Performance improvement plans are required for the nurse at fault depending on the number of incidents that have occurred.
- Will report to Patty Wolf/the Board on how the implementation of these oversight changes goes, so that these changes may be implemented in other facilities (per board request).

 - Regarding the concerns about NLC brought up during public comment:
 - Licensing fees would not be increasing
 - Other compact states have not seen an increase of cost due to joining the compact
 - There would be a decrease in workload on board of nursing staff
 - o If an applicant has had discipline in another state, they do not qualify for compact licensure
 - The board has the authority to take disciplinary action against privilege to practice
 - Nothing in the compact impacts the states sovereignty
 - No state has ever left the Nurse Licensure Compact after joining
 - 43 jurisdictions and 41 states are part of the NLC currently
 - o 6 of the 9 states that are not already have legislation introduced to join NLC
