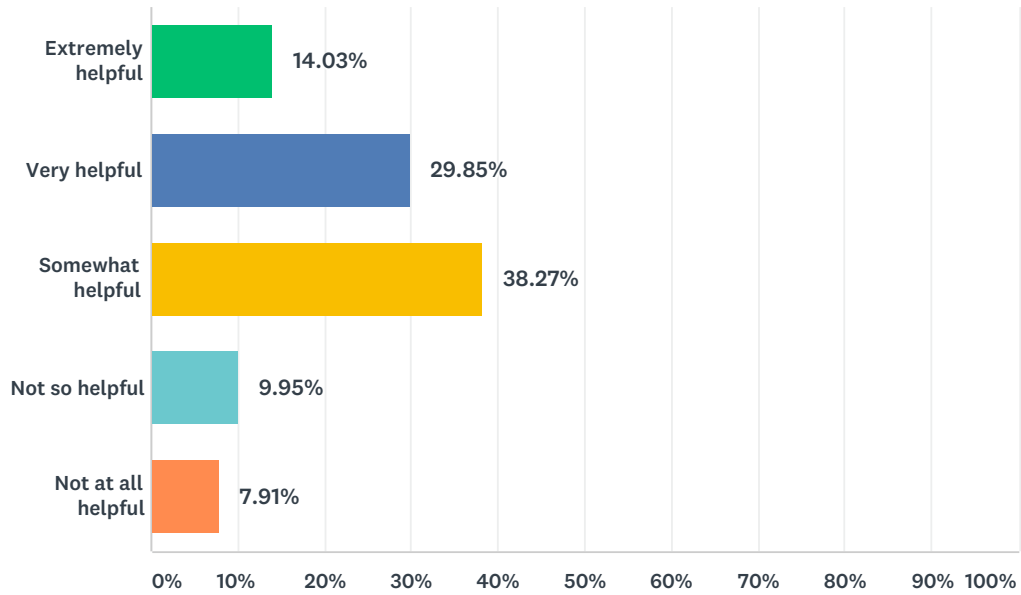

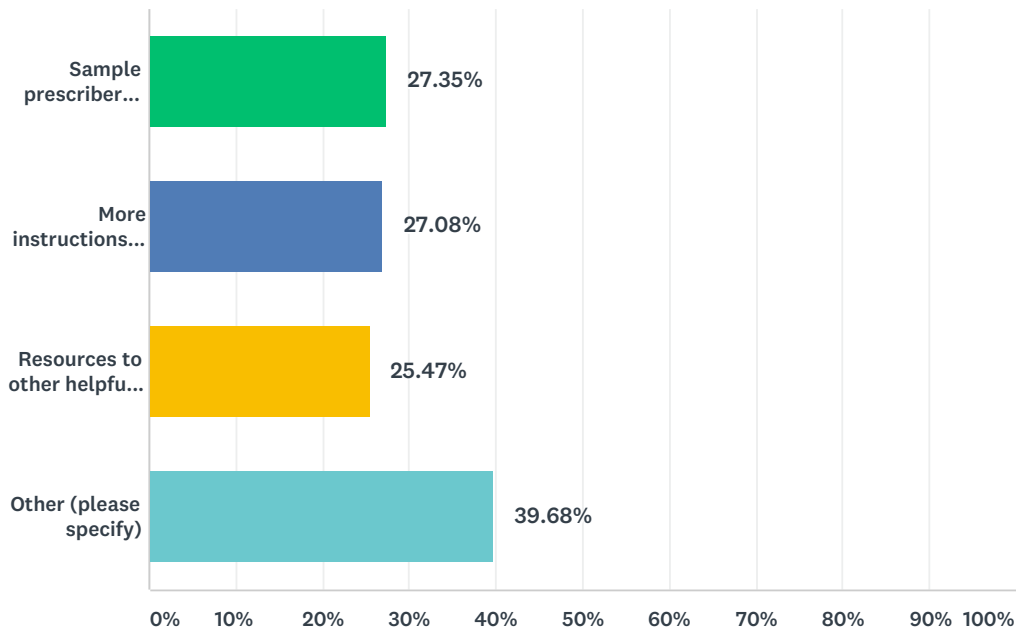

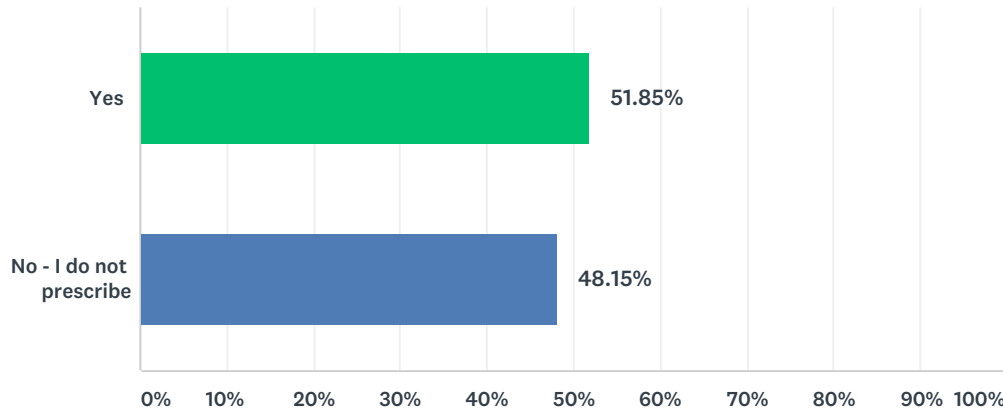

Q7 Do you regularly receive a prescriber report card?

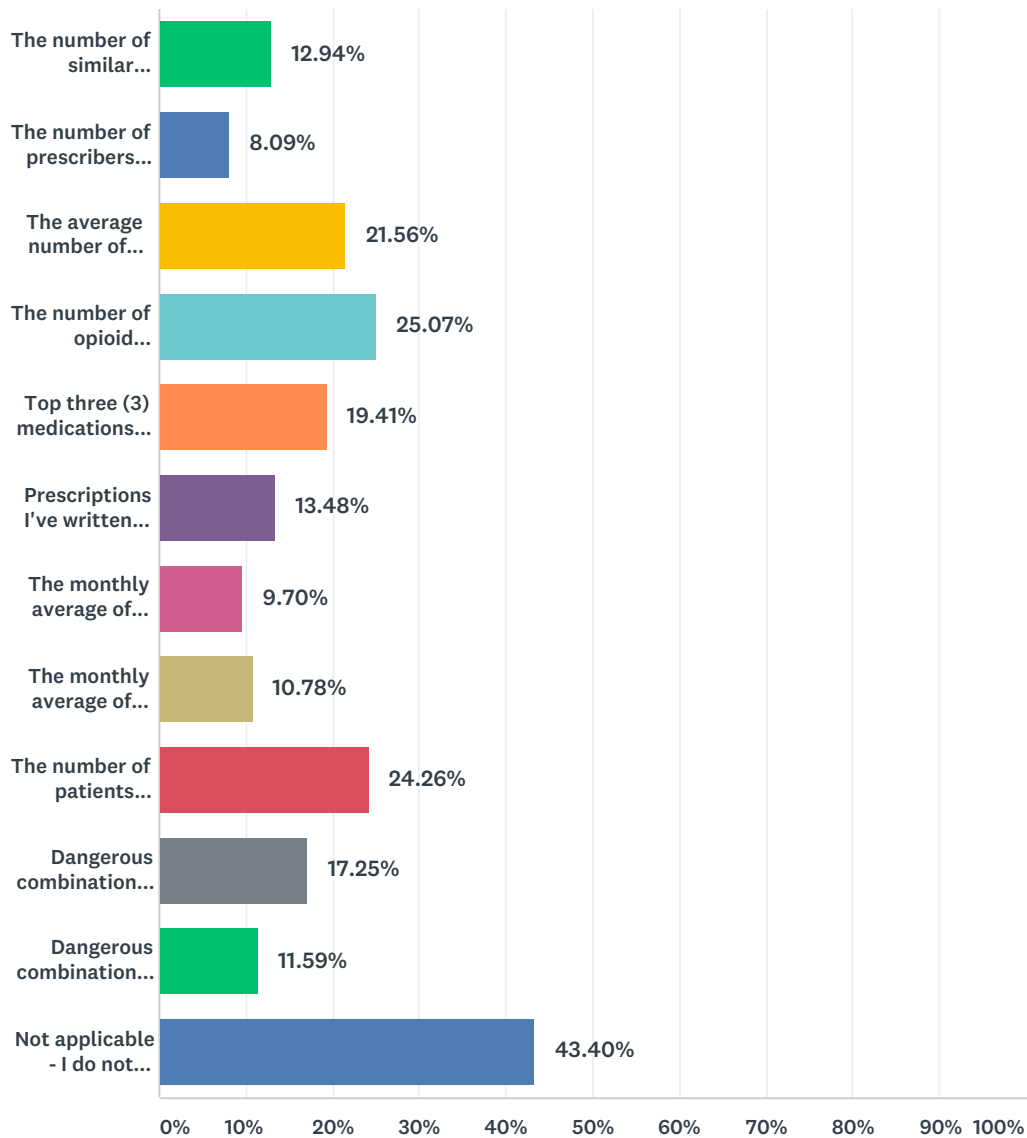

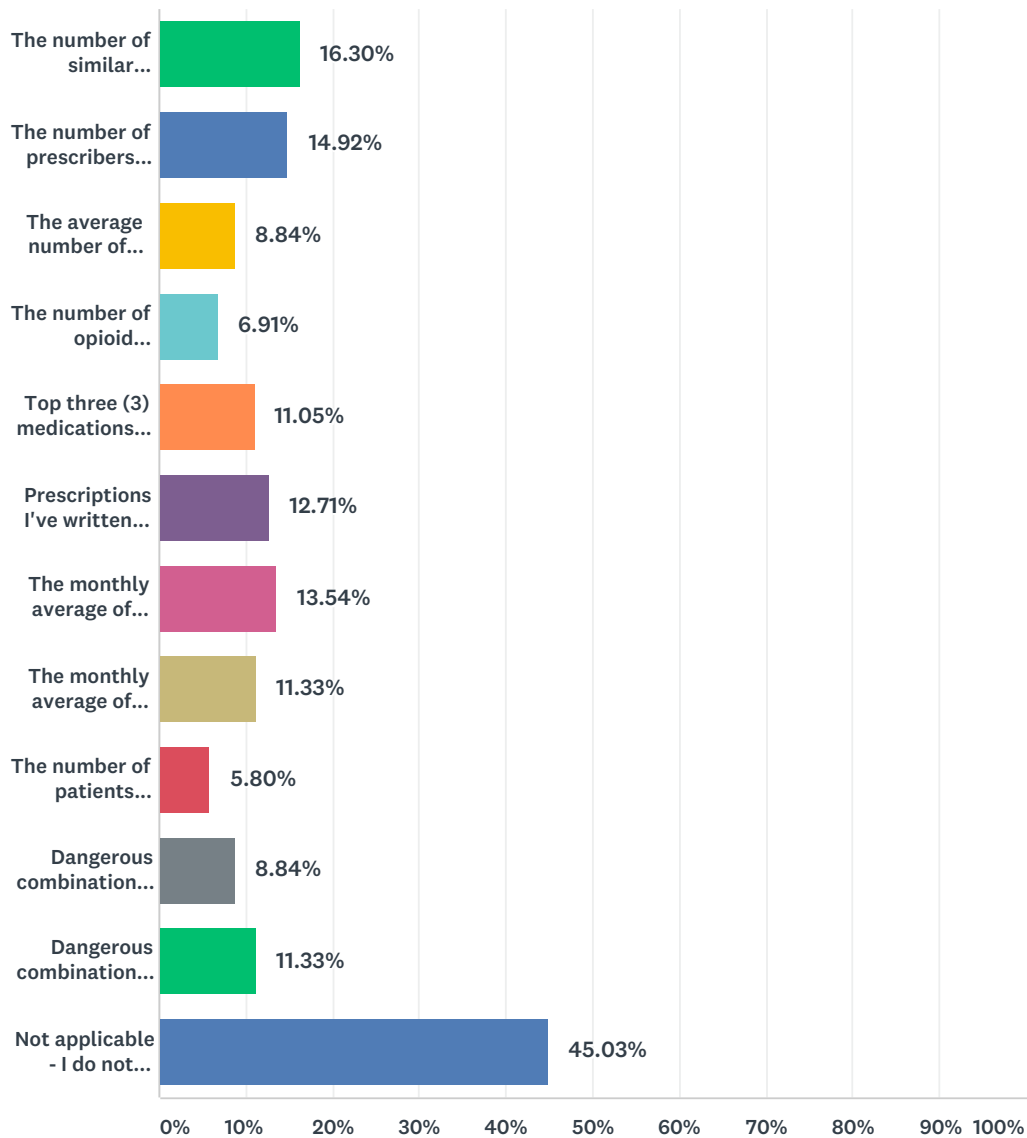

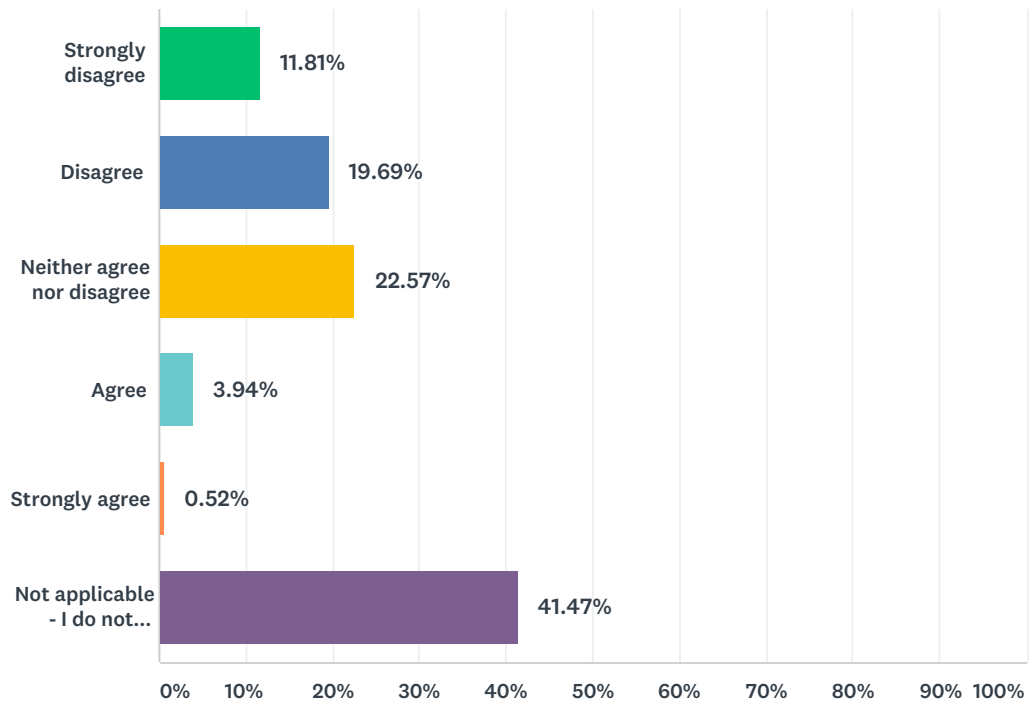

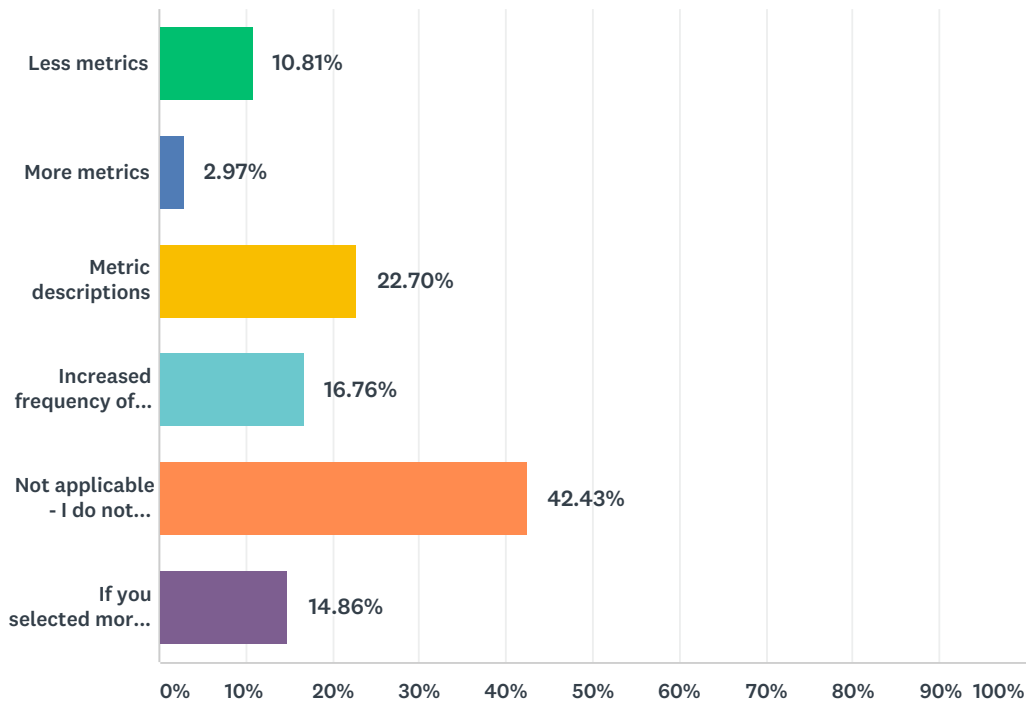

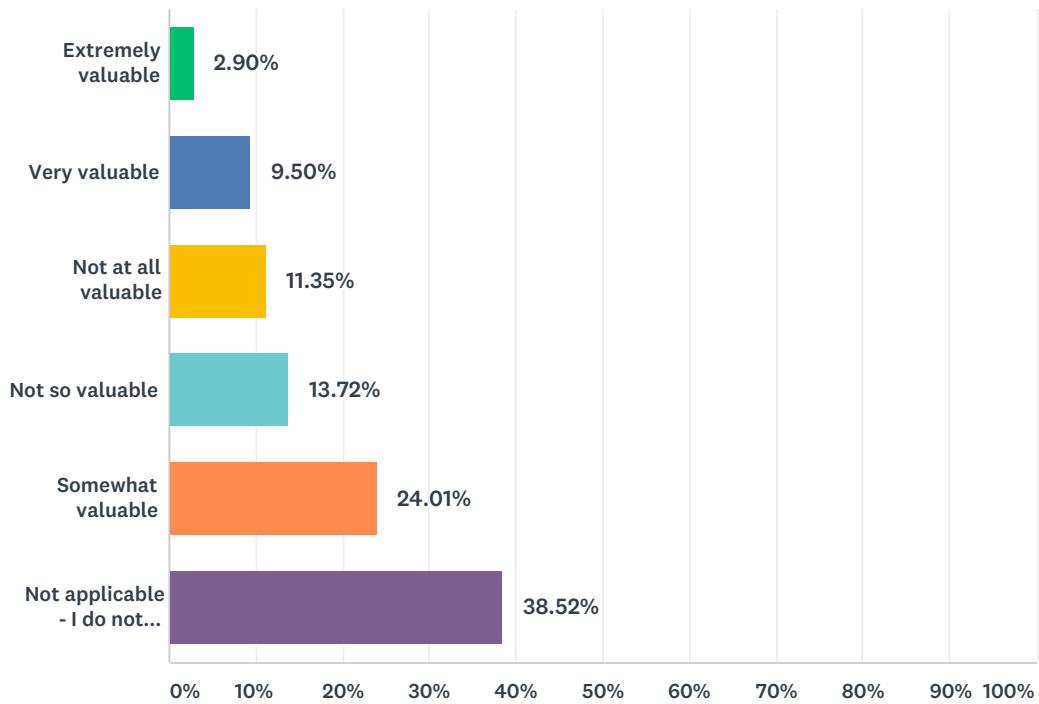

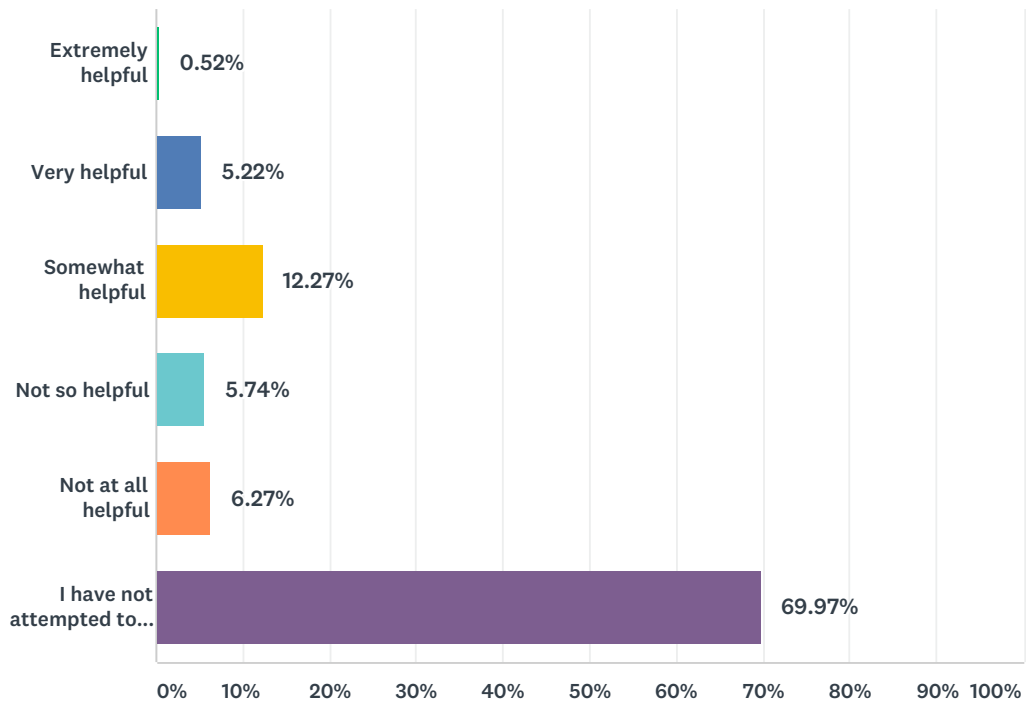

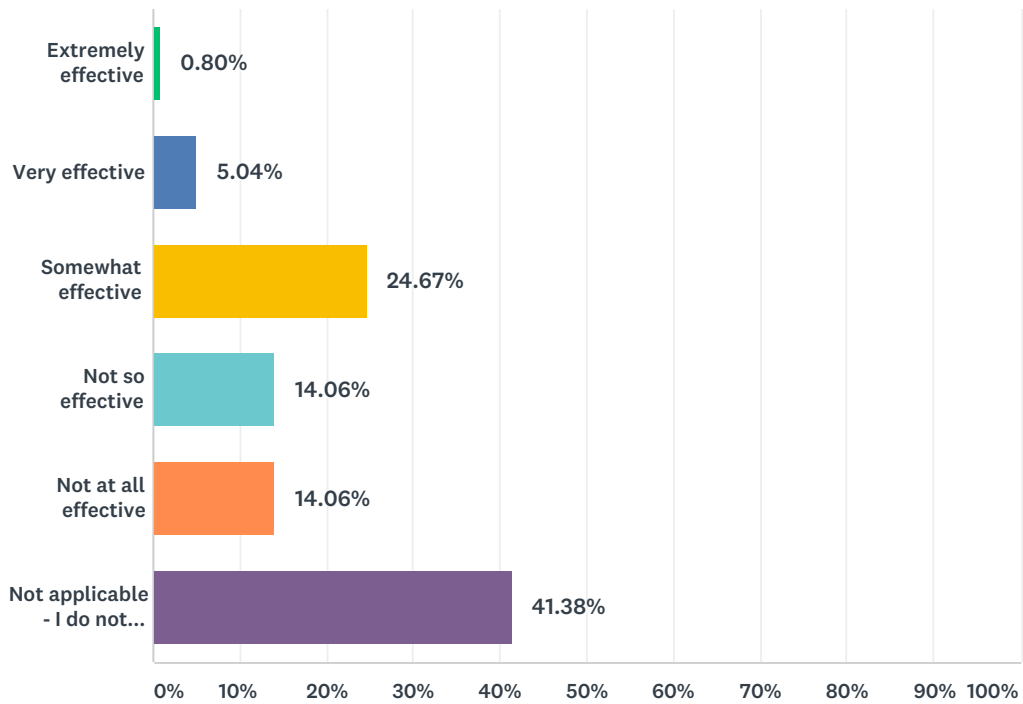

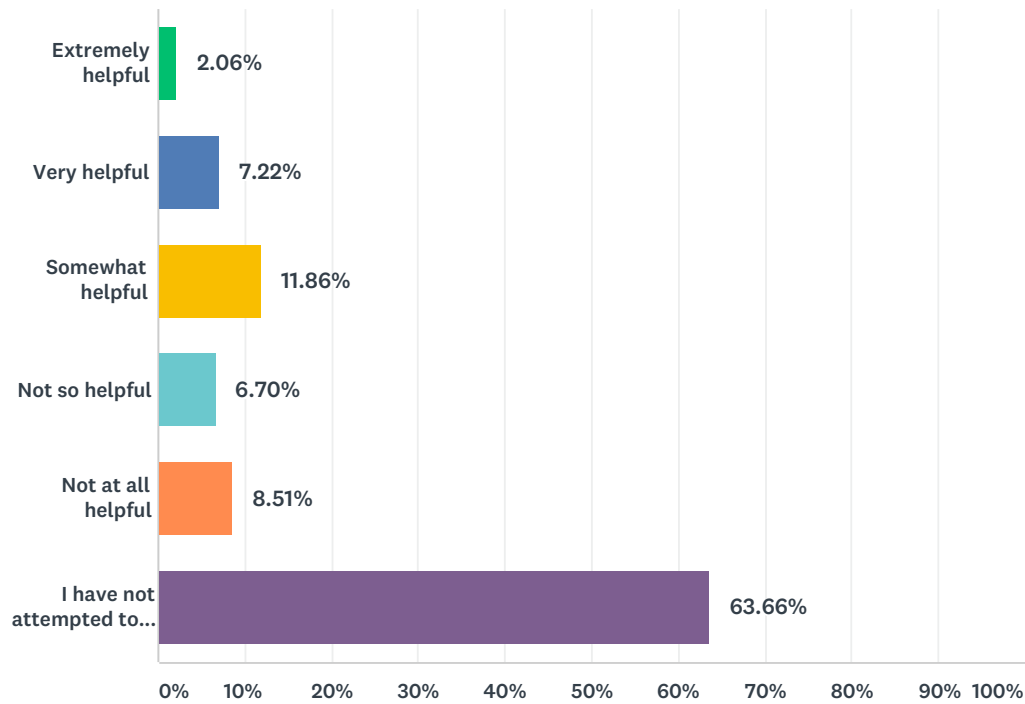

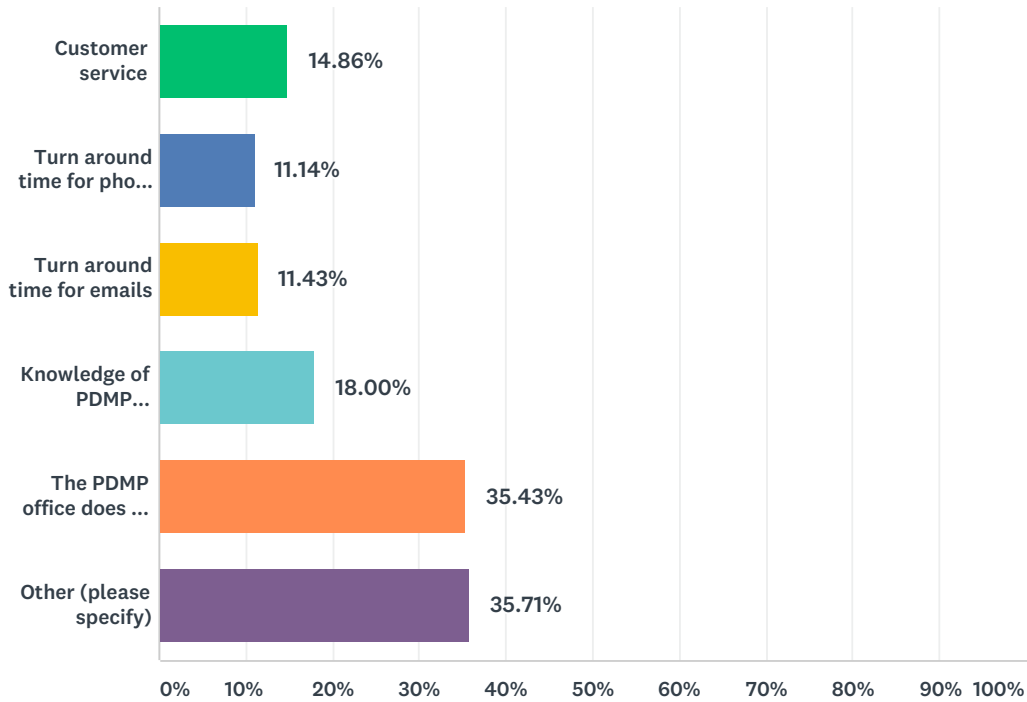

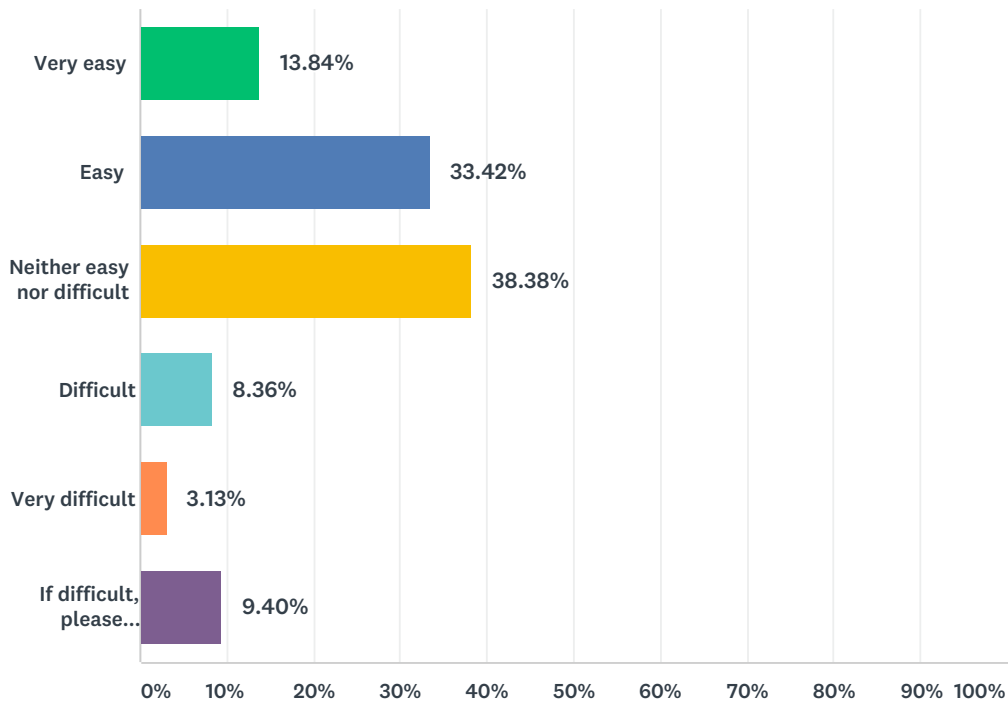

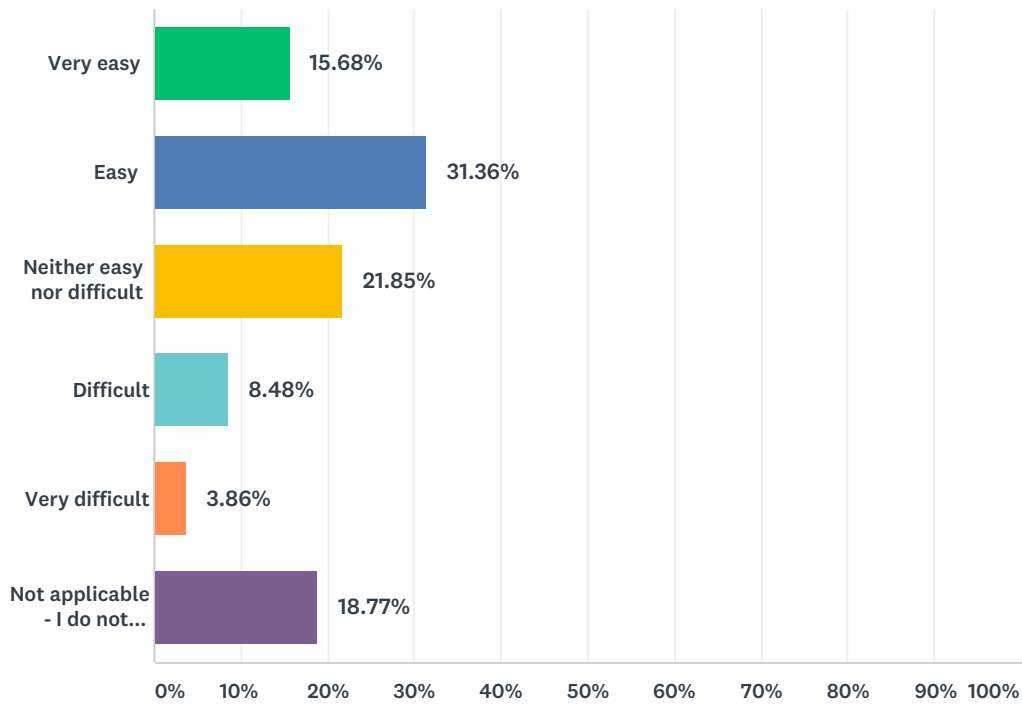

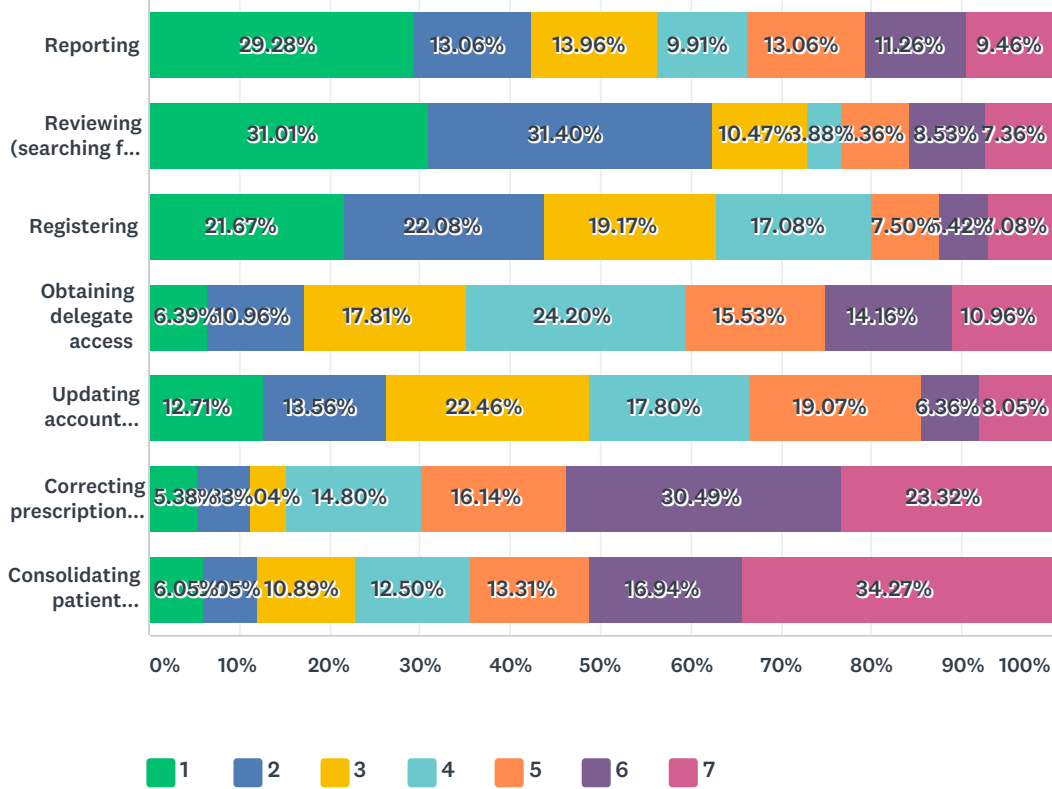

Q20 Rank the most challenging aspects of the PDMP (1 = least challenging, 7 = most challenging).

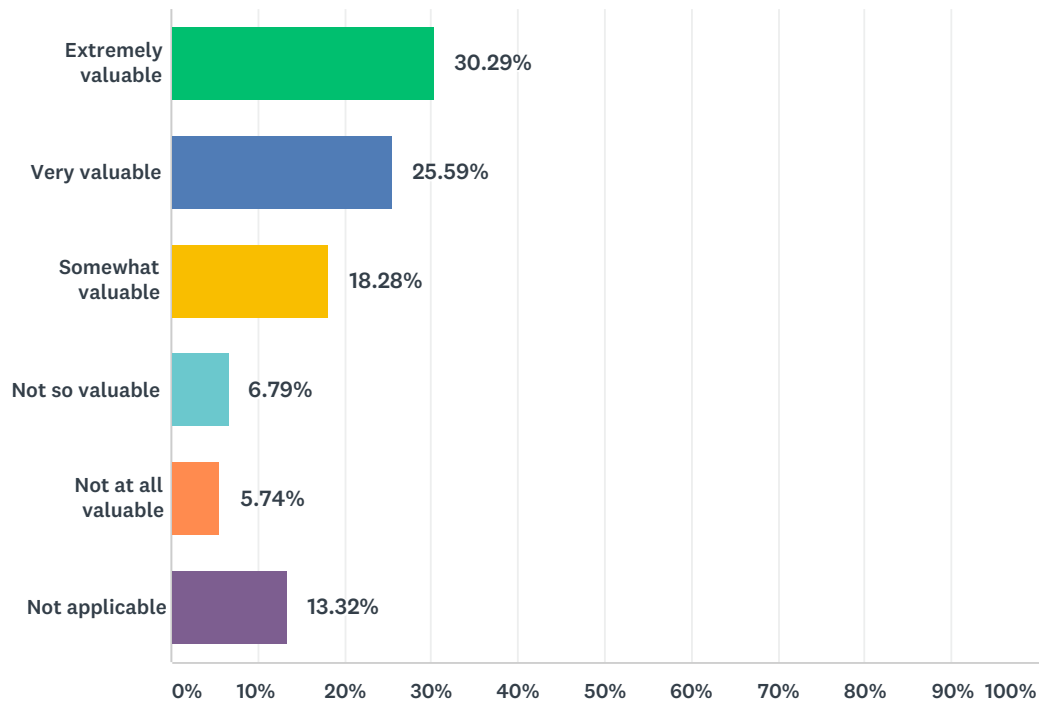

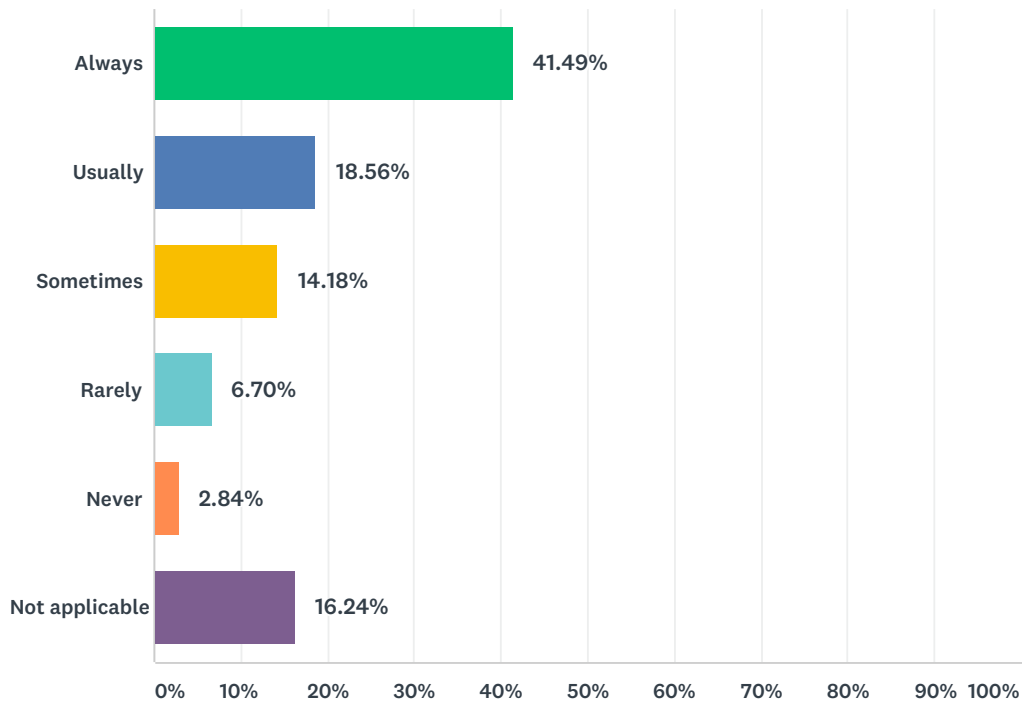

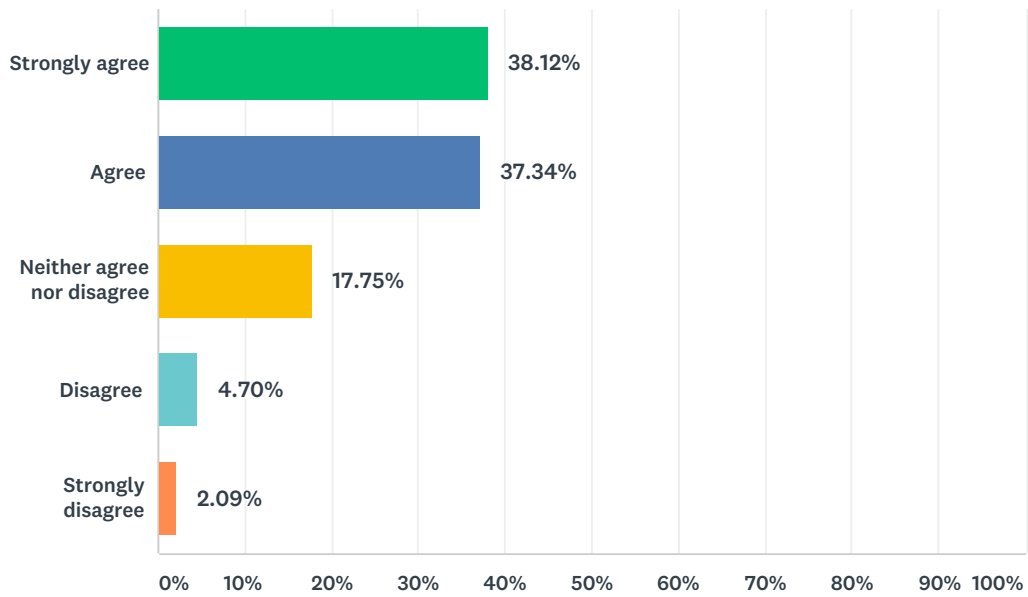

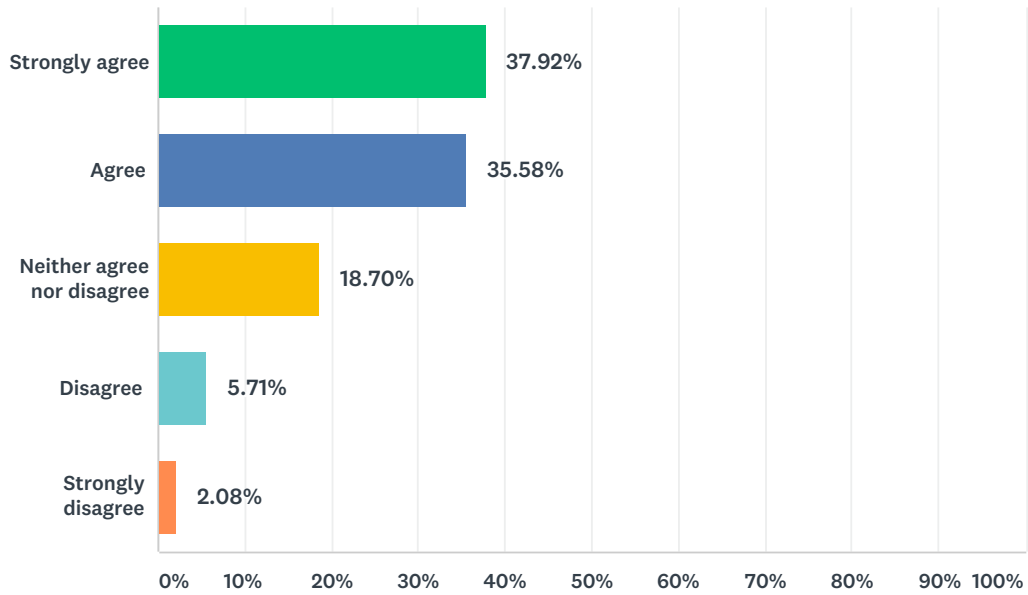

Q24 Reviewing patient prescription history helps reduce misuse.

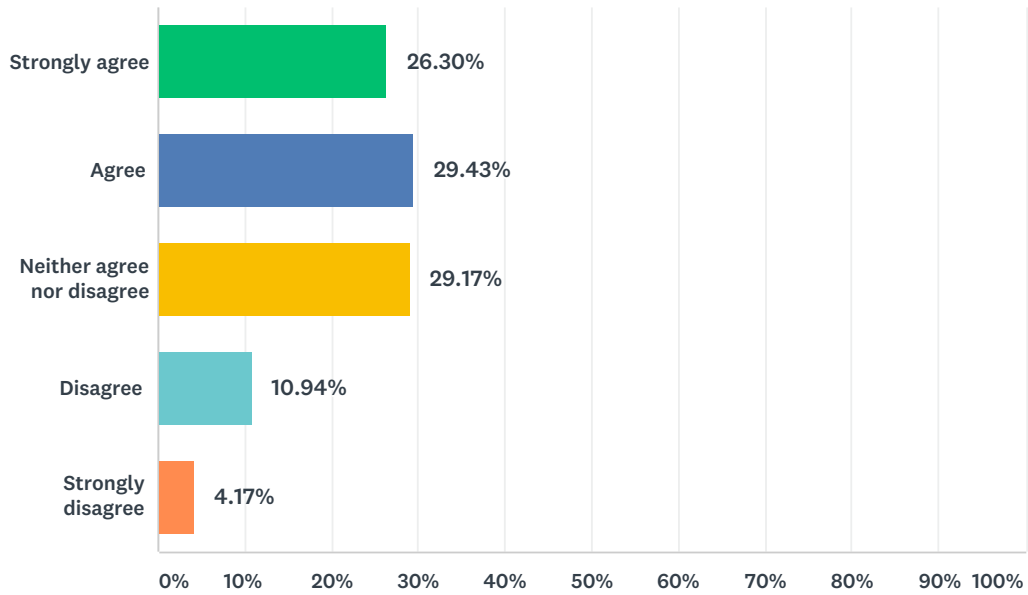

Q25 Reviewing patient prescription history helps reduce overdose.

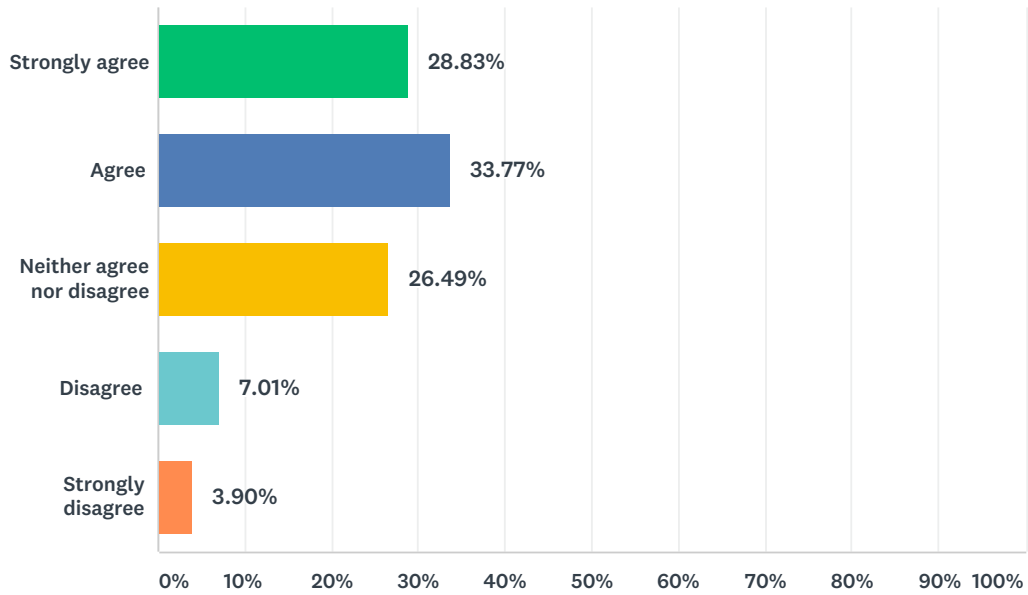

Q26 Reviewing patient prescription history helps reduce drug diversion.

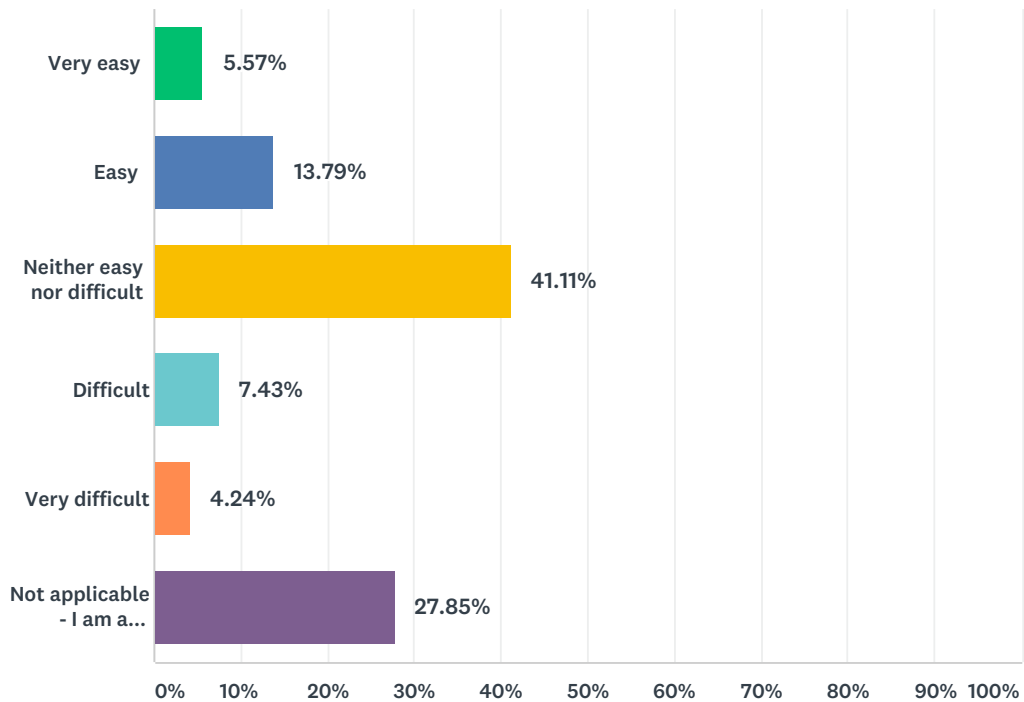

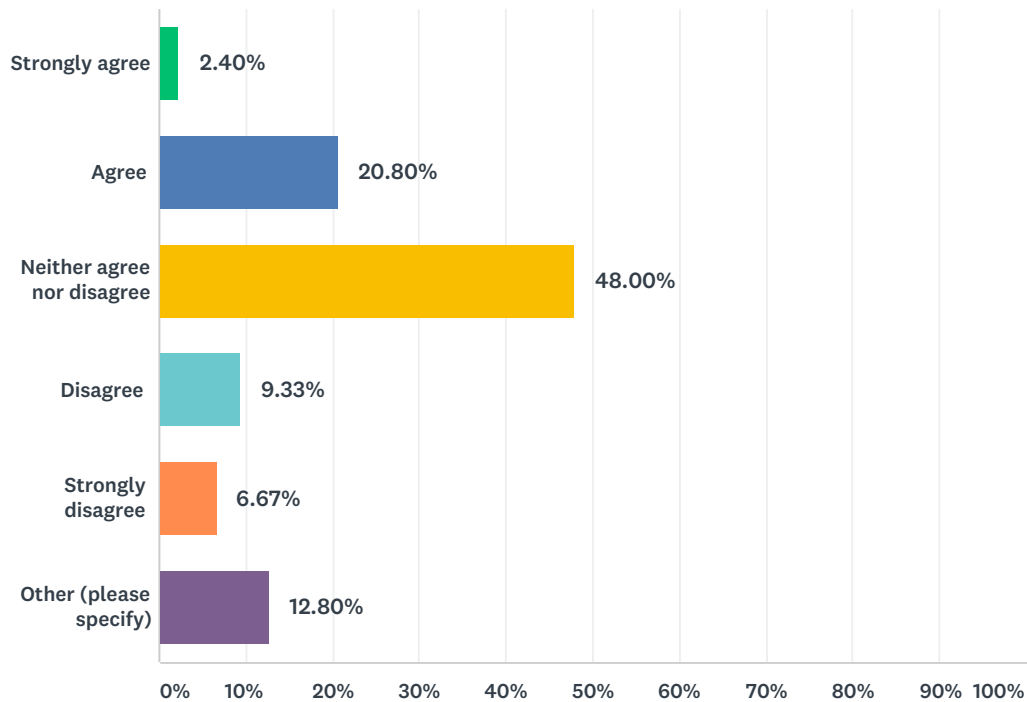

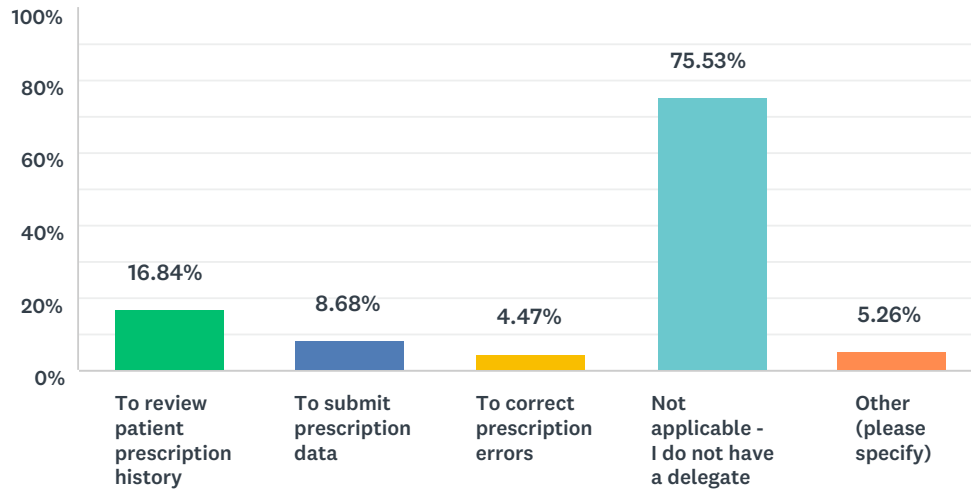

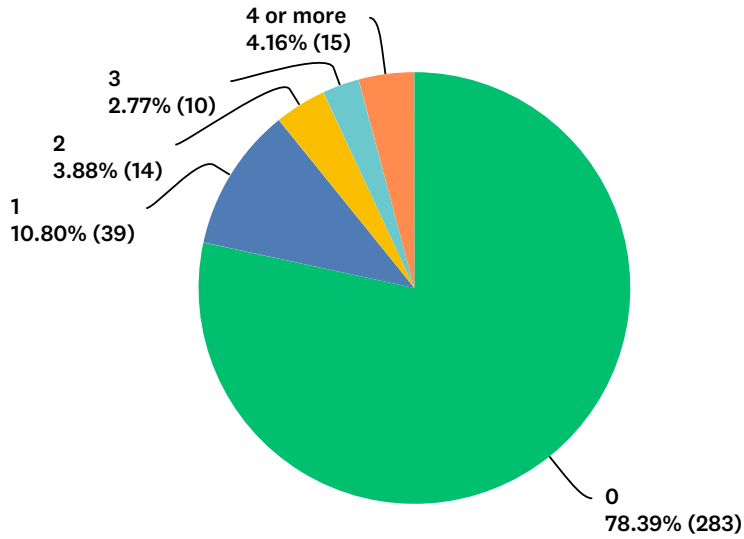

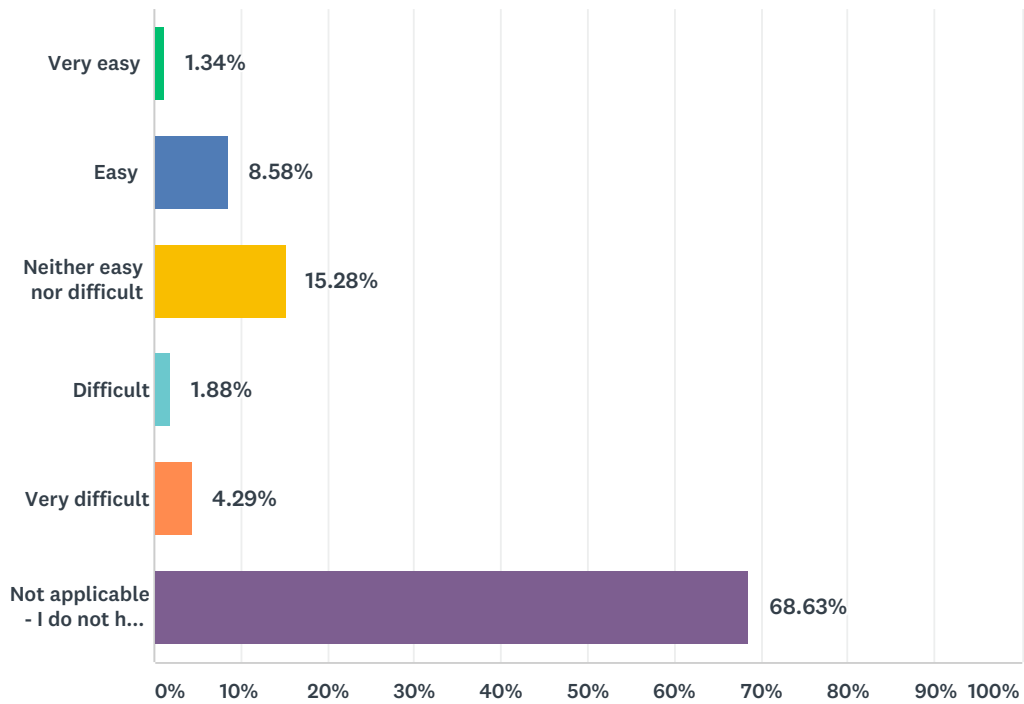

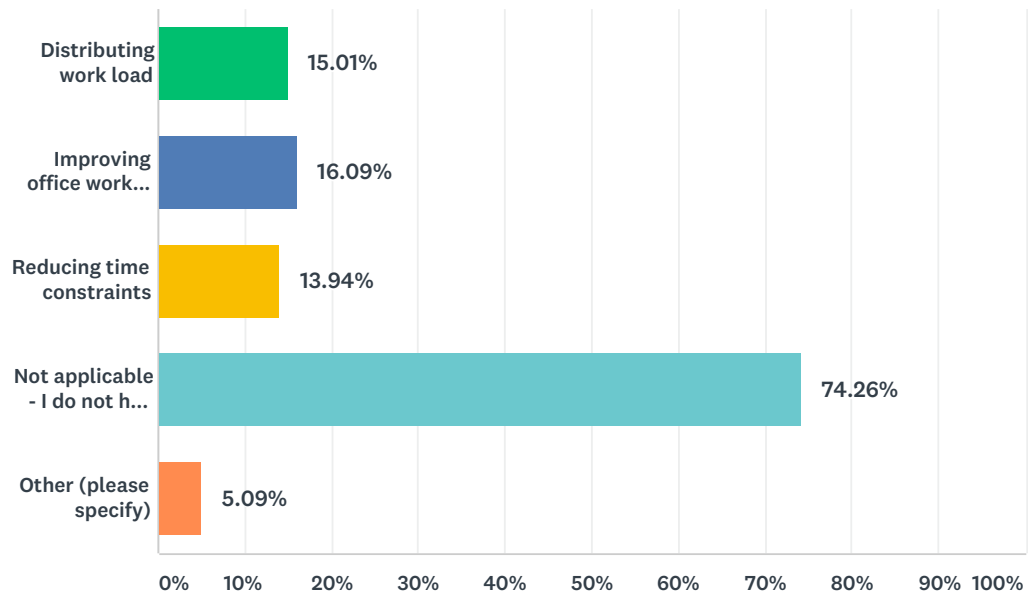

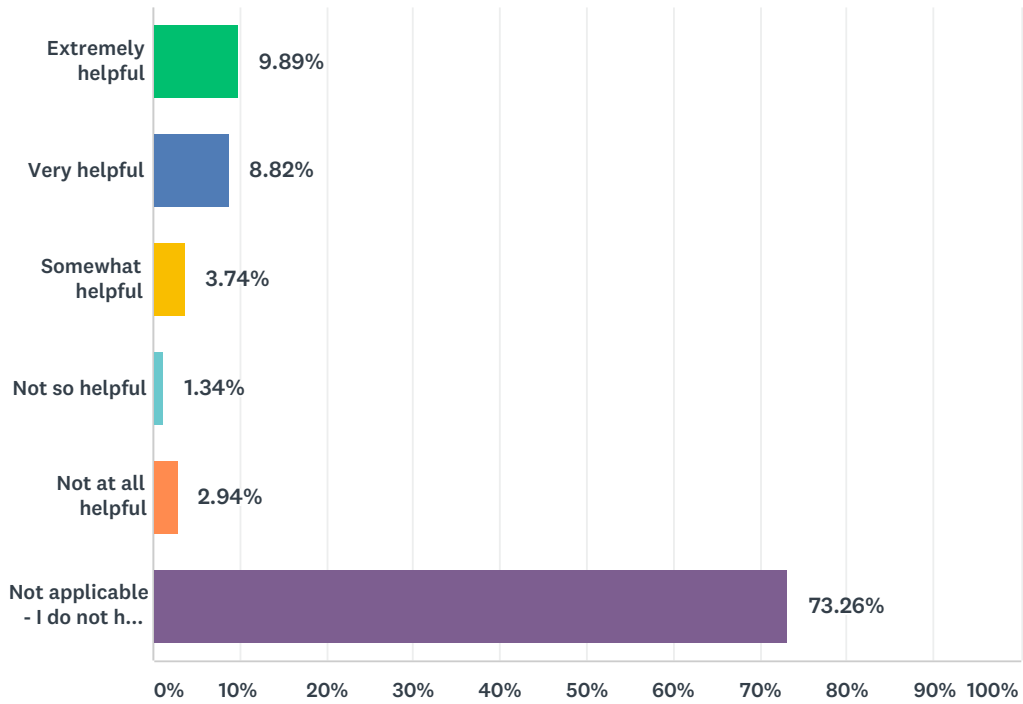

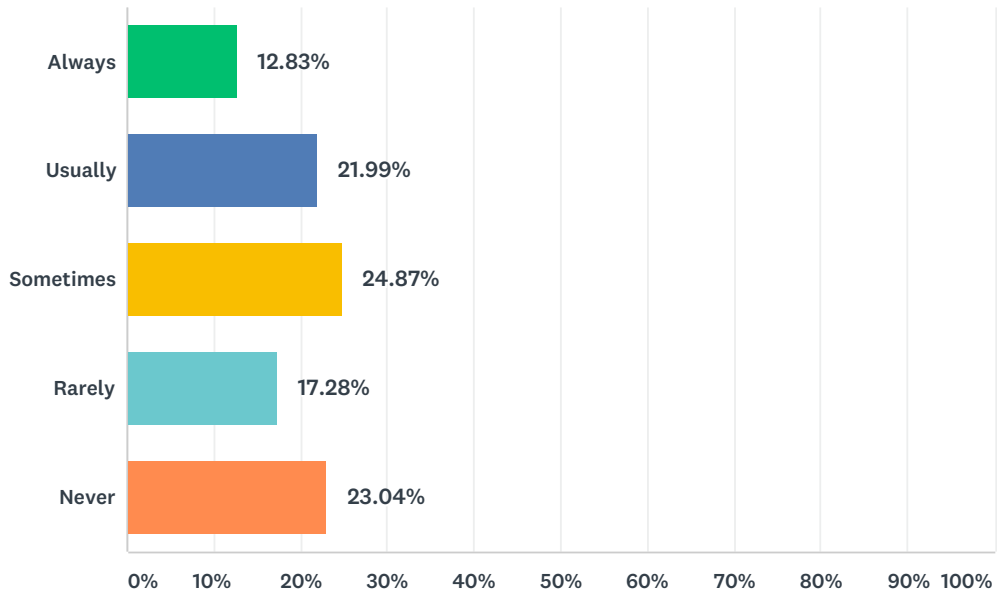

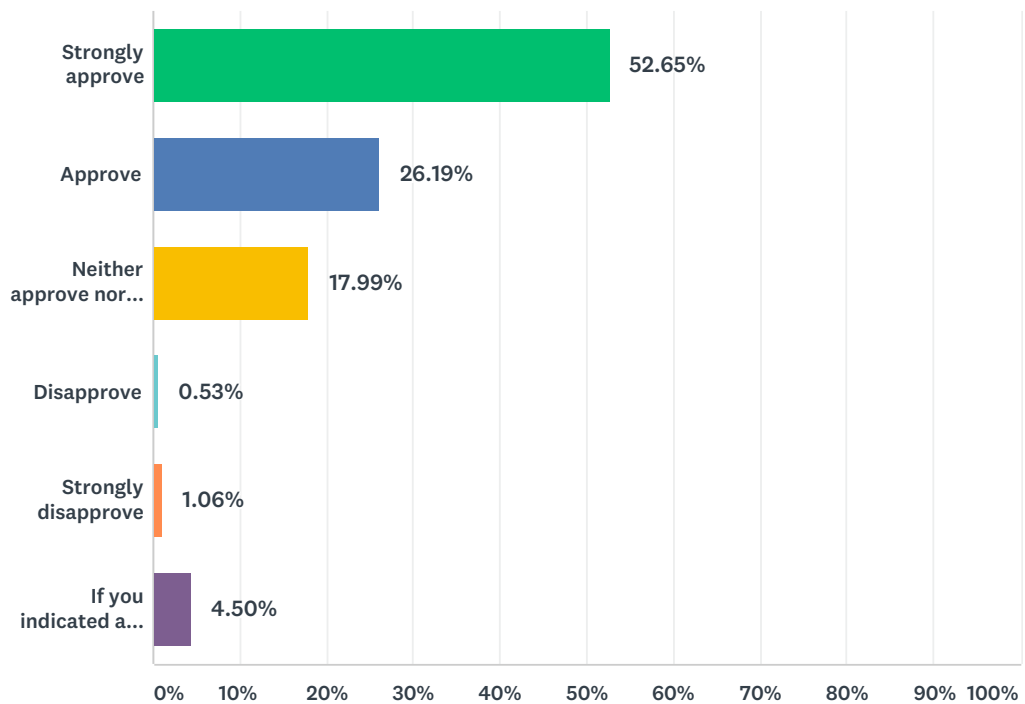

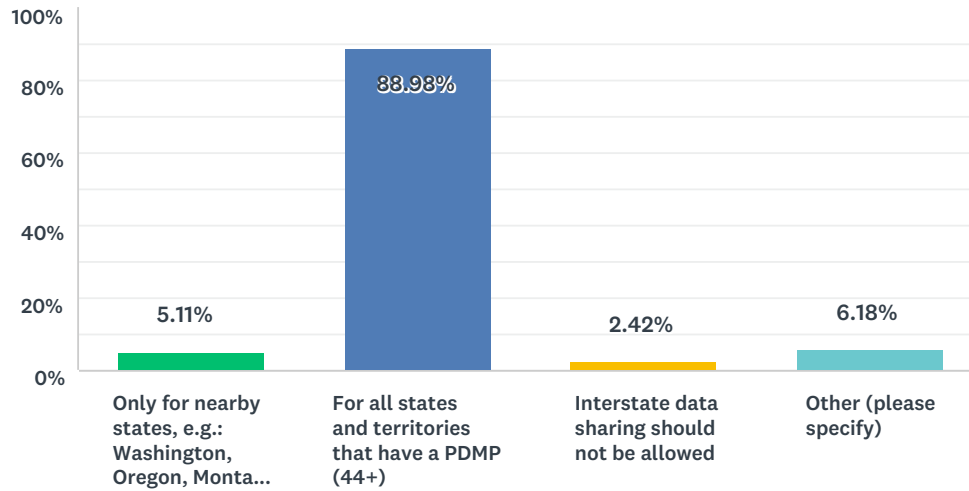

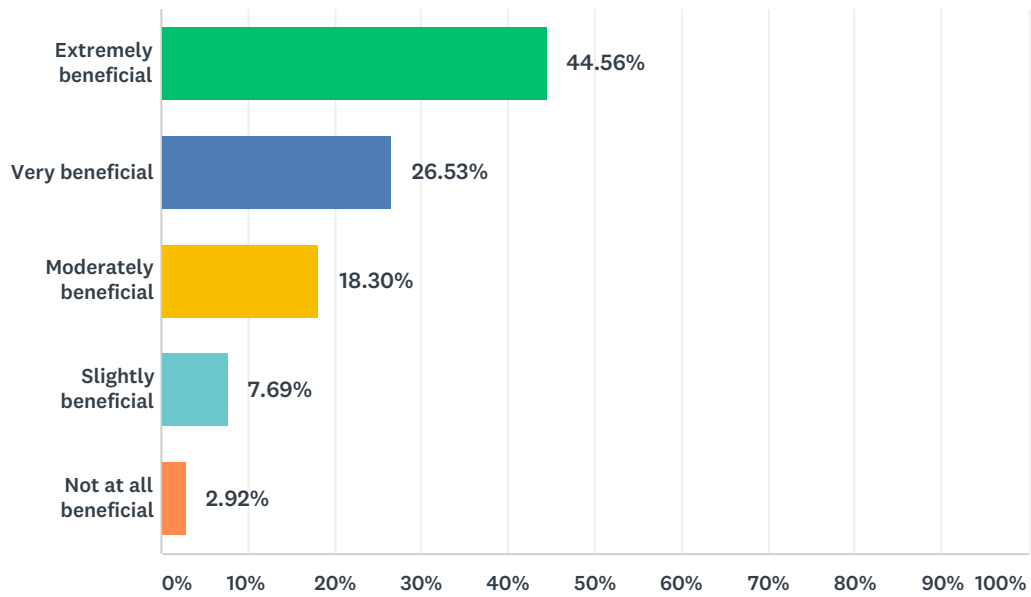

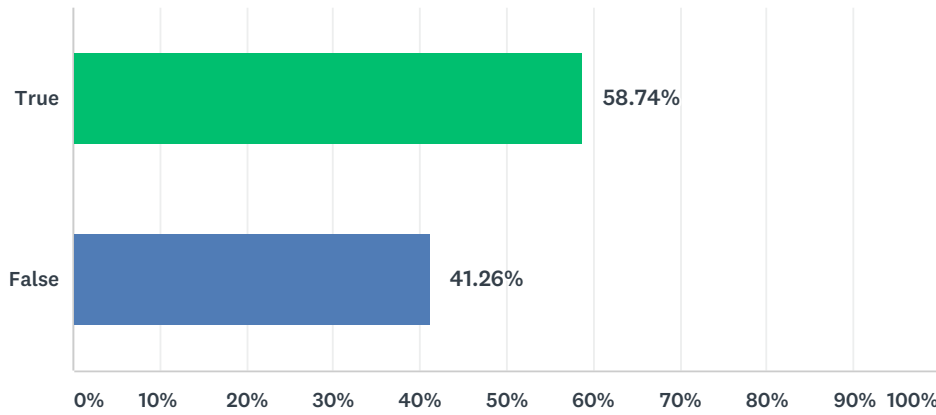

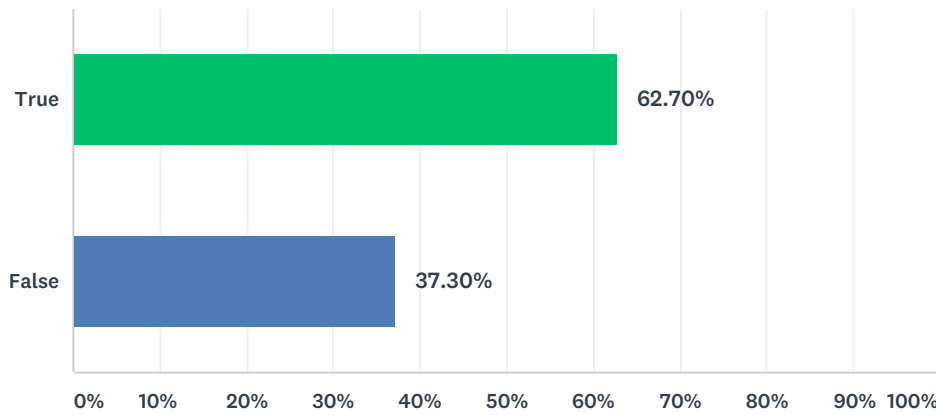

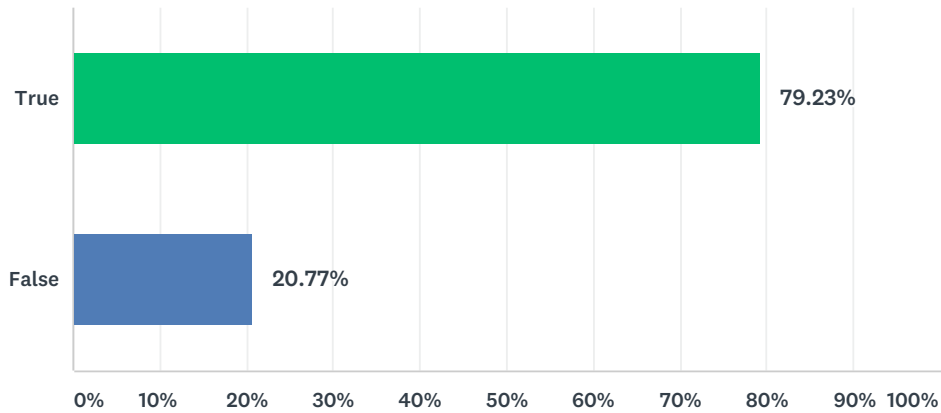

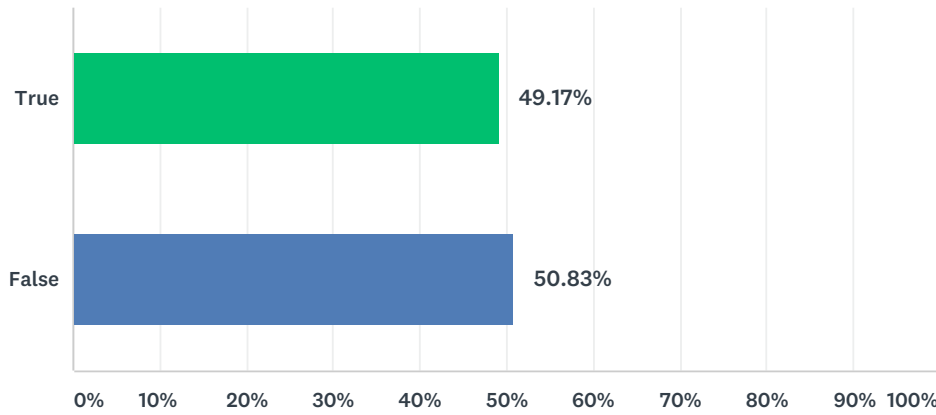

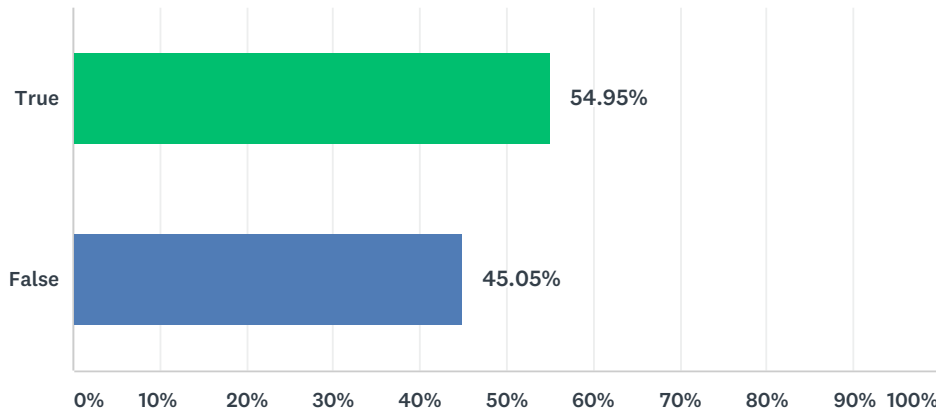

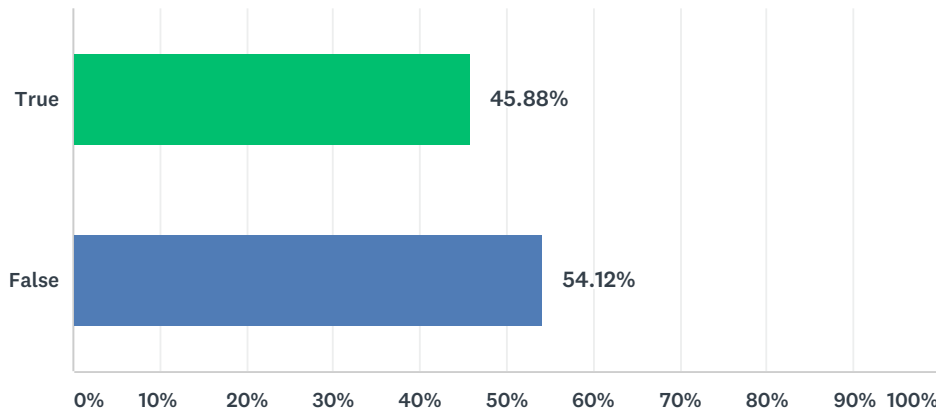

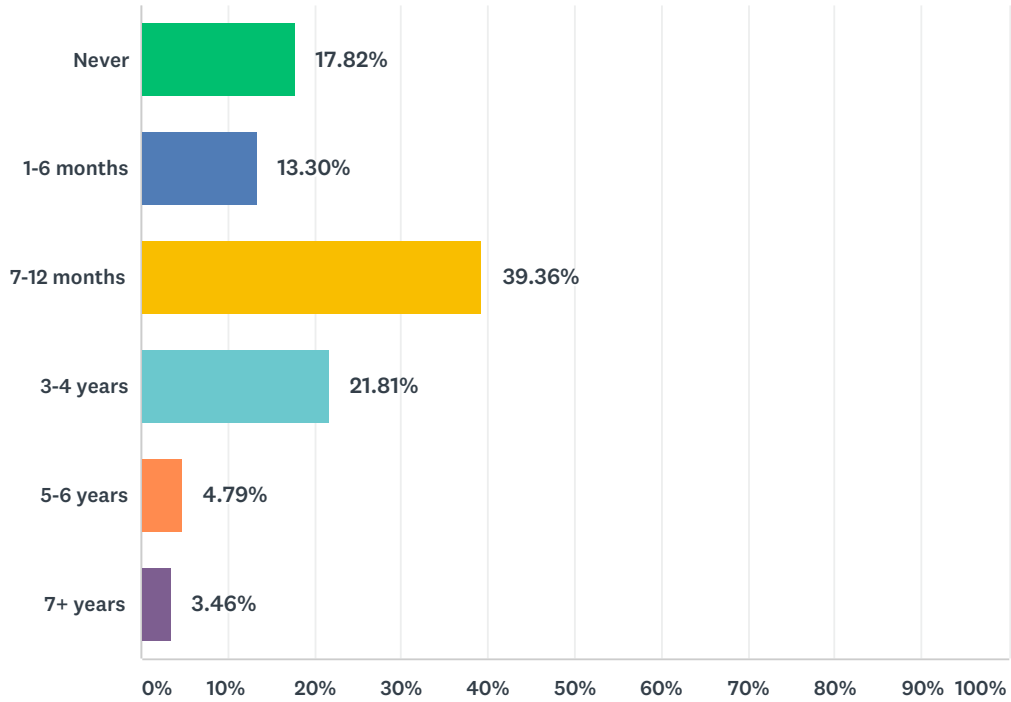

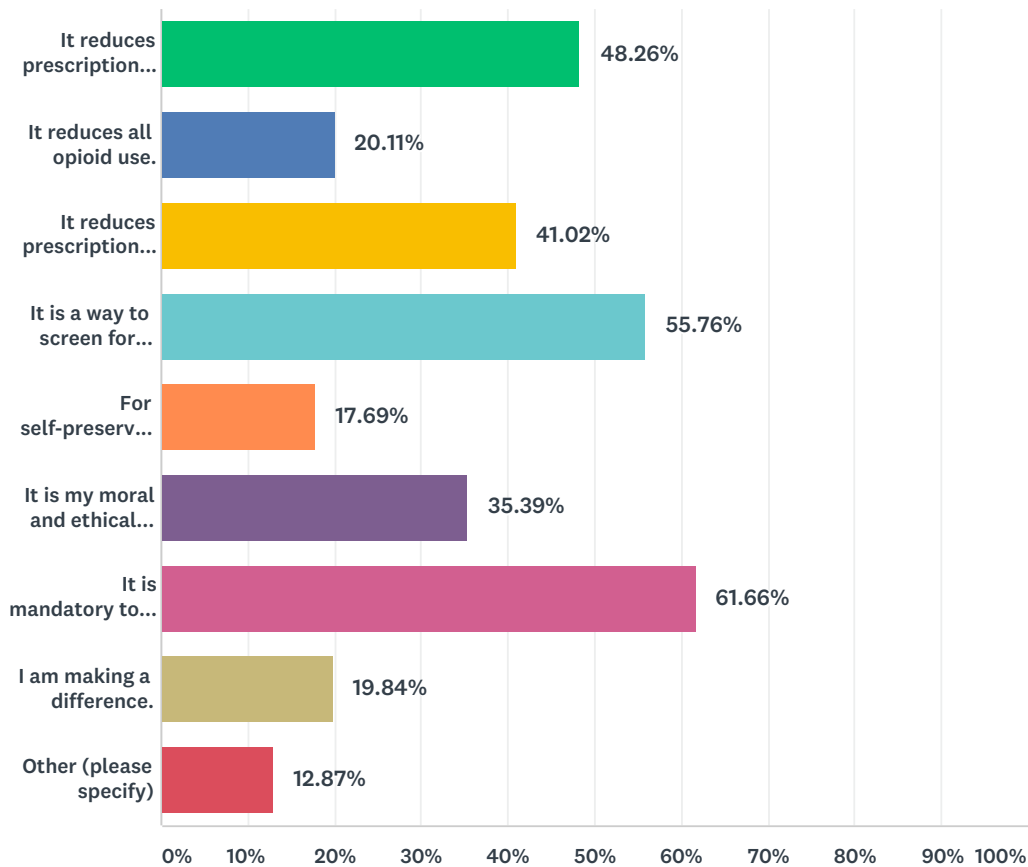

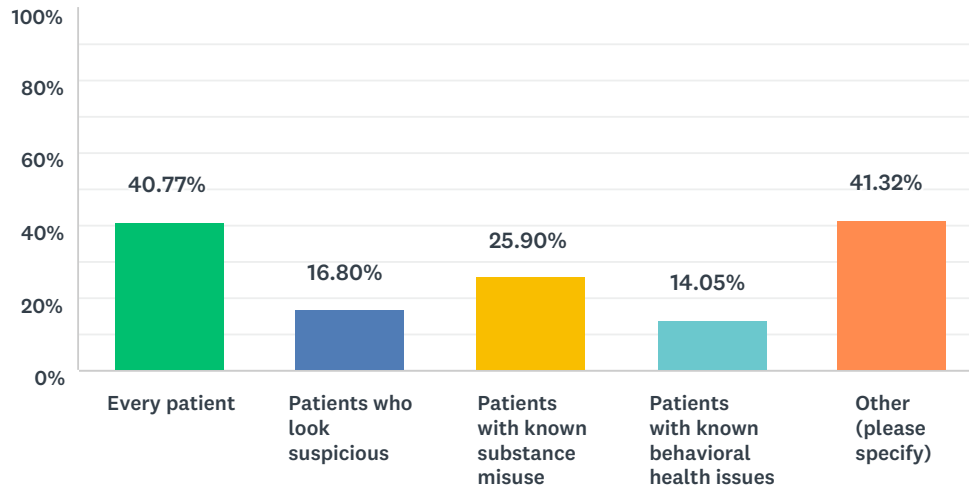

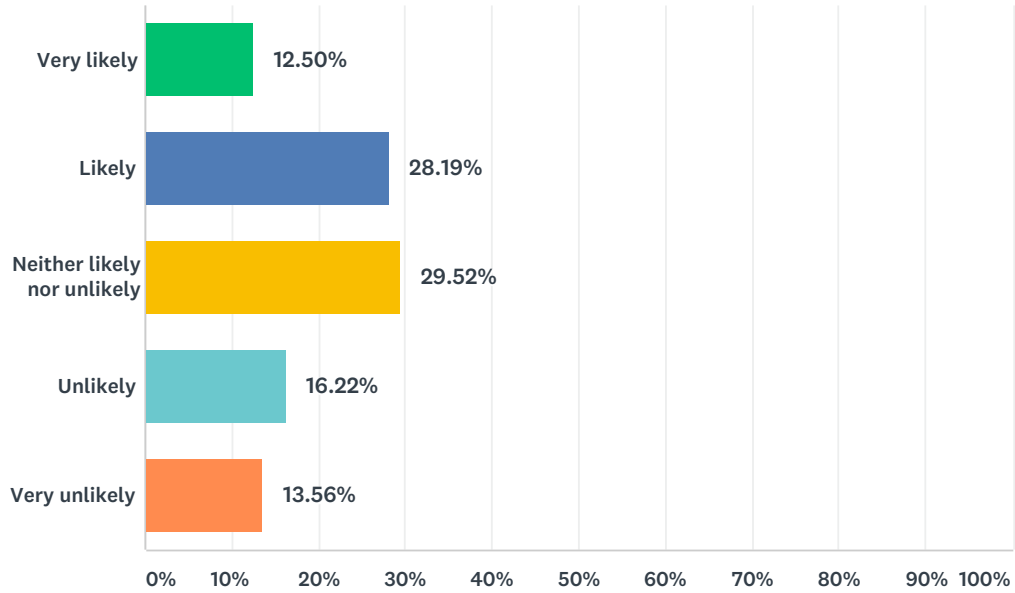

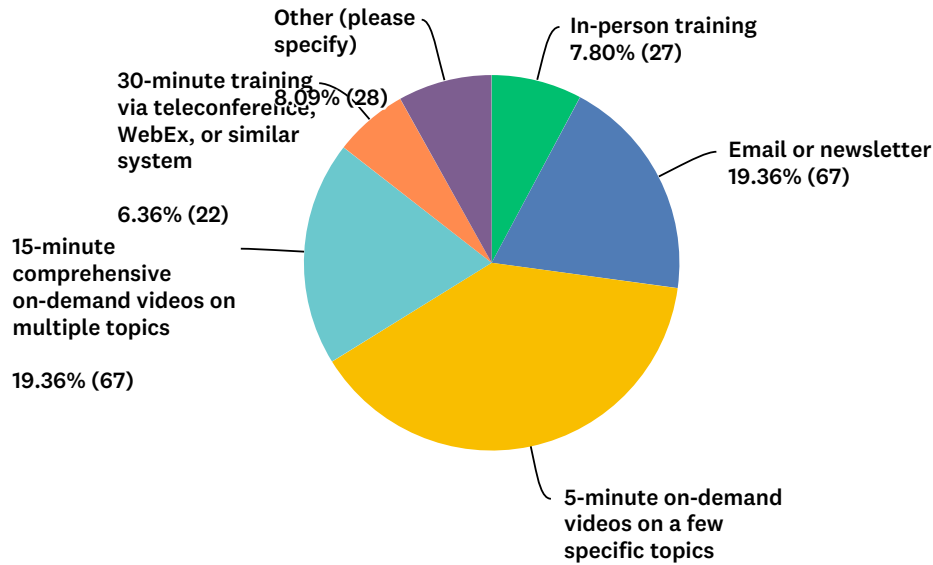

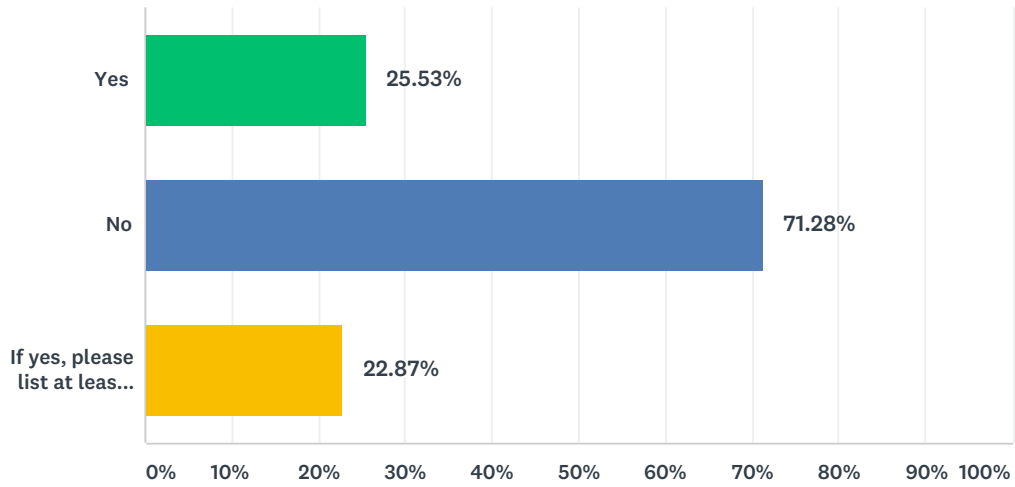

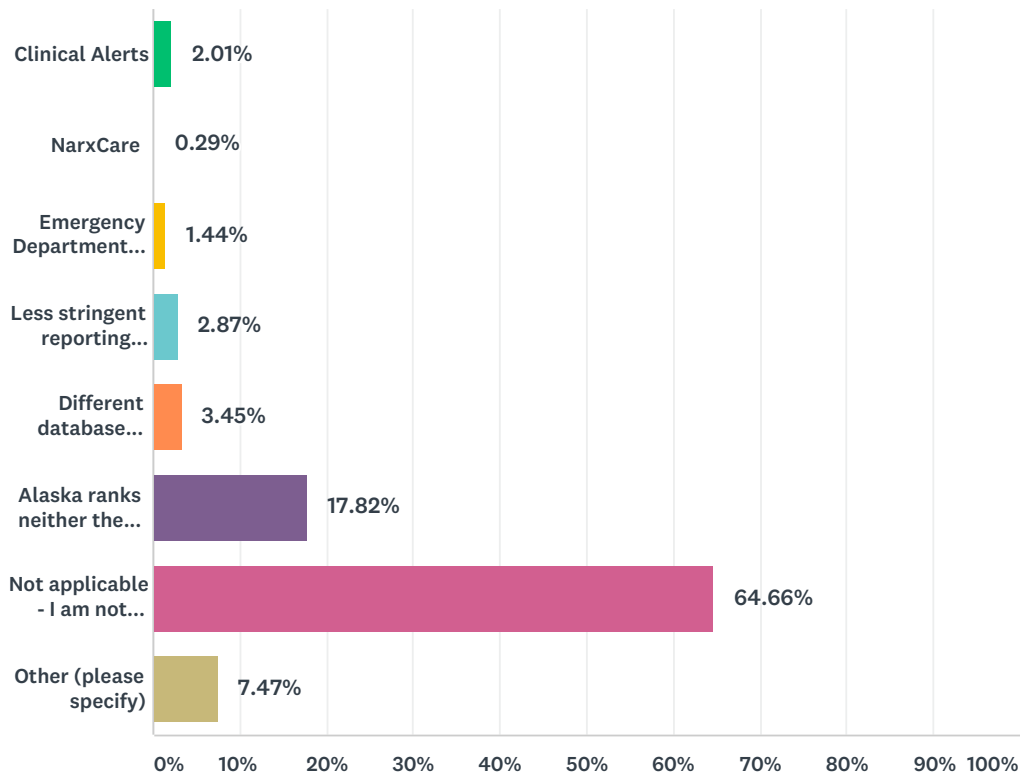

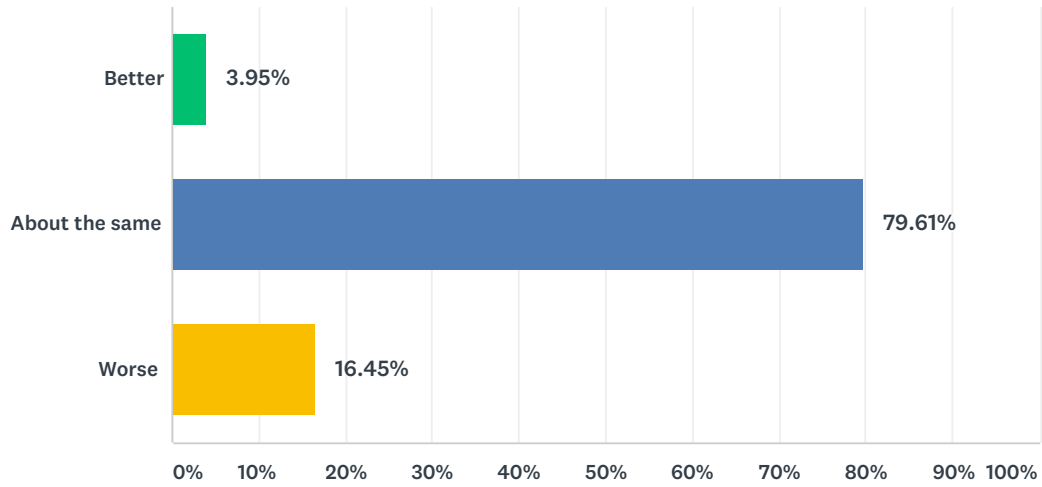
