Accomplishments

Regulation:

Goal 3.A Enact Compact Licensure

- SB74 enacted 08/31/2024. Regulations Project drafted language completed 02/2025, and currently with Department of Law for review.
- The Physical Therapy Compact Licensure program went live May 1, 2025.

Goal 3.B Investigate PT licensing requirements to create streamlining, particularly related to eliminating the transcripts requirements, as successful graduation from a CAPTE school is required to sit for the NPTE.

- Regulations Project drafted language completed 02/2025 and currently with Department of Law for review.

Goal 4.A The Board will revise continuing education requirements as needed, based on relevance to expand options for demonstrating continuing professional development.

Statutory:

Goal 1.A The board will develop an updated statutory scope of practice for Occupational Therapy.

- New workgroup established by the board 10/2024 to move language forward - convened 02/2025 to assess language for updates needed, and champion bill introduction. Meetings held 03/25, 4/8, 4/22, and 5/13 to gather input, update language and create strategies for bill introduction.

Goal 1.B The board will develop an updated statutory scope of practice for Physical Therapy.

- Workgroup established by the board 10/2024 to write draft language and champion bill; Workgroup convened 02/2025 with stakeholders; meetings held 03/25, 4/8, 4/22, and 5/13 to gather input, draft language and create strategies for bill introduction.
- The Board filed a Letter of Support 04/21/2025 for HB 173 and SB 172 – Occupational Therapy Licensure Compact registering their unanimous support of compact licensure for occupational therapists and occupational therapy assistants in Alaska and will continue to testify at the legislative hearings to answer questions from state representatives and senators.

Goal 3.C Seek statutory change to add an Executive Administrator for the board

- Draft statutory language approved by the board 02/28/2025. - Board currently seeking sponsorship and introduction of bill to create Executive Administrator position.

Goal 3.D Seek statutory change in 08.84.150 to exempt Foreign Educated physical therapist applicants (PT/PTA) from licensure when performing 150-hour internship.

- Regulations Project drafted language completed 02/2025 and currently with Department of Law for review.

Goal 2.A The board will work to engage licensees to better access information available to assist in clarifying statutory/regulatory guidelines as it applies to public safety.

- Board member Rebecca Dean attended the FSBPT Leadership Issues Forum Workshop July 12-14.

- Board Chair Tina McLean attended FSBPT August Dry Needling Competencies Task Force August 2024.

Goal 5.C The Board continues to monitor work force data development options and tools to respond to current and future trends impacting access to care and patient safety.

- In Process

The Board has delegated authority to staff to streamline license application process utilizing “approved pending” status allowing for advance Board review of applications pending the background checks and for efficient timing to approve licenses for the licensees to enter the workforce upon completion of verified clear background check without negative findings.

The Board, Staff and Department continue to investigate the most cost-effective method to provide for automated digital Jurisprudence testing to meet PT Compact requirements.

The Board has initiated a PT Scope of Practice Modernization Work Group to bring the Board and Stakeholders within the State and State Associations together to investigate the trends in Physical Therapy Scope of Practice and to recommend any changes as appropriate.

The PT OT Board is continuously monitoring and updating the Strategic plan developed in 2024 to ensure the Board is effectively responding to public and licensee needs while carrying out the intent of the legislature through statutes, regulations and policies.
