TELECONFERENCE MEETING
February 25, 2013

By authority of AS 08.01.070(2) and in compliance with the provisions of AS 44.62, Article 6, a teleconference meeting of the State Physical Therapy and Occupational Therapy Board was held on February 25, 2013 at the State Office Building, Conference Room A, Juneau, Alaska.

Monday, February 25, 2013

Kathy Lind, Chair of the Board of Physical Therapy and Occupational Therapy called the meeting to order at 4:20 p.m. This teleconference was called for a quasi judicial meeting regarding case # 2013-000212.

The Board of Physical Therapy and Occupational Therapy had been provided a copy of the consent agreement for case # 2013-000212. All board members had read the agreement prior to the teleconference and there were no questions.

The applicant has agreed to meet all conditions of the proposed decision and order conditions and signed a consent agreement on February 22, 2013 for licensure as an occupational therapist with mandatory audit for two license renewal periods.

This teleconference was called in order to vote on adoption of the consent agreement.

Kathy Lind called for a motion:

ON A MOTION BY, MELISSA ROBINSON, SECONDED BY VALERIE PHELPS, THE BOARD EXAMINED THE CONSENT AGREEMENT AND PROPOSED DECISION AND ORDER FOR BOARD CASE # 2013-000212. THE BOARD ADOPTS THIS ORDER AS WRITTEN AND SIGNED BY THE APPLICANT FOR THE MANDATORY AUDIT FOR TWO LICENSE RENEWAL PERIODS.

ON A VOICE ROLE CALL VOTE – MELISSA ROBINSON VOTED YES, VALERIE PHELPS VOTED YES, JUDY BOGARD VOTED YES, KATHY LIND VOTED YES. MOTION PASSES.

The board adopted Case # 2013-000212 for mandatory audit for two license renewal periods for Laura Kimberling. Kathy Lind stated on the record she was signing the original Board Order document and she will deliver it to Jasmin Bautista in the Anchorage investigative unit.

Kathy Lind then called for a motion by voice roll call vote to issue an occupational therapist license with a mandatory audit consent agreement to Laura Kimberling.

ON A MOTION BY, MELISSA ROBINSON, SECONDED BY VALERIE PHELPS, THE BOARD APPROVES TO ISSUE AN OCCUPATIONAL THERAPIST LICENSE TO LAURA KIMBERLING WITH A MANDATORY AUDIT CONSENT AGREEMENT.

ON A VOICE ROLL CALL VOTE - MELISSA ROBINSON VOTED YES, VALERIE PHELPS VOTED YES, JUDY BOGARD VOTED YES, KATHY LIND VOTED YES. MOTION PASSES.

Motion passed and the Board approved issuing an occupational therapist license to Laura Kimberling with a consent agreement for mandatory audit.

The Board having no further business to discuss adjourned the meeting at 4:28 p.m.
