# Agenda Item 3 State Lands Subcommittee Report

Bobby Fithian, Chair of the State Lands Subcommittee provided the Board with a report concerning the progress made since the subcommittee last met in March 2006.

Below is a summation of Mr. Fithian's report.

- 1. Department of Natural Resources has the authority to administer and develop guide-outfitter lease programs.
- 2. Developed a team of state agency personnel who are in support of the initiative.
- 3. The final program will be resource based, not just land based. The concerns of wildlife, wild land, industry, consumer and social stewardship will all be contained within the proposed program.
- 4. The effect of development and implementation of proposed program will lead the industry into an era where the industry use on state lands is sustainable for the long term.

Mr. Johnson asked Mr. Saxby if he had any comments concerning Mr. Fithian's testimony. Mr. Saxby recommended beginning a pilot program in areas with greatest conflict.

Mr. Johnson stated that the state lands subcommittee will meet after agenda item 5 before lunch. Meeting is open to the public.

# Agenda Item 5 Supervision Subcommittee Meeting

The Supervision Subcommittee did not meet during this meeting.

Mr. Johnson asked the industry and Board to provide feed back as to how it felt about 12 AAC 75.240 and 12 AAC 75.250. Mr. Johnson stated that he has heard from Registered Guide-Outfitters that the

current regulation concerning supervision of their guides is hard to comply with.

Mr. Johnson requested Alaska Bureau of Wildlife Law Enforcement, Liaison Dave Lorring to come forward and provide the Board with his observations concerning 12 AAC 75.240 and 12 AAC 75.250.

Mr. Lorring stated the each Registered Guide-Outfitters operation is different, therefore for some Registered Guide-Outfitters are able to comply with the requirements of 12 AAC 75.240 and 12 AAC 75.250, while others it is impossible for them to comply.

# Agenda Item 6 Public Testimony

1:07 p.m. to 3:08 p.m. the following persons testified before the Board, followed by a summation of their testimony:

#### **Brain Peterson**

- Informed the Board that there have been court rulings and federal legislation changing the professional hunting, game management and nonresident hunting environments.
   Senator Reid introduced a bill (SB2978) which passed and created an exception to the commerce clause in order to give each state the right to regulate access to hunting and fishing.
- Requested the Board to pass regulations requiring Alaska residency in order to qualify for a Registered or Master Guide-Outfitter license.
- Requested the Board to send a resolution to the state legislature requesting a guide to accompany all nonresidents who are hunting any big game.

# Kelly Vrem

 Need to be careful to not bind ourselves so tightly that we can not operate in the state.

- Feels the hunter has responsibility to research the Registered Guide-Outfitter he/she is interested in hiring before submitting a deposit.
- Too many Registered Guide-Outfitters in too small and area.
- Return sole use or joint use areas.
- Experienced guides should be able to waive the 60 days in-field guide experience to receive certification in a Game Management Unit.
- Registered Guide-Outfitters should not be authorized to provide transportation services only under their license. They need to hold the appropriate license.
- It is very difficult for Registered Guide-Outfitters to receive insurance in Alaska to cover their operations, especially if they are using horses.

## Frank Dinello

- Requirements are becoming too difficult, which will make guides loose interest and decide to not pursue a Registered Guide-Outfitter license. This will make it difficult for Registered Guide-Outfitters to obtain help.
- Does not support species specific requirements.
- A person should not be permitted to guide or transport in an area that he/she has surveyed game.

#### Tom Shankster

 Would like to see the number of Registered Guide-Outfitters restricted to a specific area.

# Tony Lee

- Believes hunt records and contracts, contains redundant information.
- Supports exclusive use areas. Will promote stewardship of the resources.
- Does not support species specific licensing.

## Brian McJunkin

- Noted the Board has a tuff job, had to deal with many issues quickly and appreciates its position.
- Does not support 60 day in-field guide experience in order to receive certification in a Game Management Unit.

#### Steve Perrins

- Too many Registered Guide-Outfitters on state lands.
- Looking to the Board to start implementing sanctions to eliminate problem guides.
- Concerned about the requirement of having to keep the hunt records in the field.

# J. Erickson

 Would like the Board to require a US Coast Guard license if operating a boat.

#### Dale Adams

- Would like the Board to consider an Assistant Guide applicant taking the Registered Guide-Outfitter examination in lieu of time in the field.
- Establishment of corporations has created loop holes, which has been allowing many Registered Guide-Outfitters to work together and utilize each others guide use areas and splitting off permits. Recommends restricting corporations to three guide use areas.
- Recommends the Board amending Transporter statute which authorizes the licensee to provide accommodations to big game hunters in the field on a boat with permanent living quarters living on salt water.

# **Brad Dennison**

- Concerns regarding Transporters providing accommodations to big game hunters in the field on a boat with permanent living quarters living on salt water. The word "permanent" living quarters means not being able to move from one place to another as it applies to a permanent lodge or cabin.
- Supports raising the bar for all class of guides.
- Recommends a passing score of an examination higher than 75%.

Mr. Johnson asked Mr. Saxby if it was in the Boards purview to define "permanent living quarters." Mr. Saxby stated that it would be fine with in reason.

# Sue Entsminger

# Aaron Bloomquist

- What happen to the regional examinations that were proposed in March?
- Frustrated that he is required to have more time in the field and demonstrate harvests of animals, when his employing Registered Guide-Outfitter received his license with minimal time and can provide services for all species.
- There should be an Assistant Guide on the Board.

## Chris Erickson

- Supports the Board in raising the bar for Assistant Guides to become a Registered Guide-Outfitter.
- Would like the Board to require proof of a US Coast Guard license if operating on water.
- Agrees with earlier testimony that a corporation should be limited to three guide use areas.

# Agenda Item 9 State & Federal Agency Testimony Regarding Recently Public Noticed Regulations

9:15 a.m. to 11:48 a.m. the following State and Federal agencies had representative(s) present to testify, followed by a summation of the agencies testimony.

Commander Arlow, Department of Public Safety, Alaska Bureau of Wildlife Enforcement (ABWE)

 Supports 12 AAC 75.150 and 12 AAC 75.155. Assigning hunt records to a specific Registered Guide-Outfitter will prevent a rewrite of the hunt record, using a hunt record to cover a violation that has occurred, hide a contract that may have occurred or an Assistant Guide who committed a violation while on the guided hunt.

Assigned numbered hunt records will make it almost impossible to have pre-signed hunt records in the field. The numbered hunt records will assist ABWE with investigations, preventing Assistant Guides from taking clients on their own.

Control the problem of the hunter not meeting and/or being in communication with the contracting Registered Guide-Outfitter.

ABWE is concerned about the support group that will be implementing, monitoring and keeping this process.

Kim Titus, Deputy Director, Division of Wildlife Conservation

- Department appreciates the work of the Big Game
   Commercial Services Board and staff over the past year.
- The Department foresees within a year or two that the Board will take regulatory action which will be helpful in raising the bar of the industry and protecting resources; in terms of lands and wildlife.
- The Department is looking at permits and the coordination of permits. The agency is heading towards permitting other areas of the state as it currently does in Tok and Kodiak.
- The Department has developed questions for the Registered Guide-Outfitter examination.

Clark Cox, Division of Mining, Land and Water

- No specific comments concerning the proposed regulations.
- · Supports the efforts of the Board.
- Questions: 12 AAC 75.230 concerning 5,000 contiguous acres of uplands.

"What is acceptable proof to the Board for landowner approval? It is the agencies opinion that the piece of paper we issue is acceptable and the on-line registration is not acceptable as there is no oversight by agency staff. The agency is not going to change its permitting language to fit the Boards regulation. Does the chart we created work for you?"

Mr. Johnson asked for Ms. Gabier, Mr. Rohrer, Mr. Cox and anyone from the public who has a permit issued through the Division of Mining, Land and Water to get together later during the meeting to workout how a Registered Guide-Outfitter will prove they have authorization from Division of Mining, Land and Water for 5,000 contiguous acres of uplands.

 Agency would like to confirm that a Registered Guide-Outfitter is required to submit proof of land use authorization from only one landholder regardless the number of land managers in the area. The Board said yes, however all Registered Guide-Outfitters are required by law to obtain land use authorization from every land owner/manger for which they intend to access.

No representative from BLM was present.

Brian Anderson and Leann Aires, US Fish and Wildlife

 Supports the Board and its efforts. "Looking forward to working with the Board and the associate goals." Big Game Commercial Services Board Minutes of Meeting December 11 – 13, 2006 11 of 37

- AS 08.54.790(10), definition for transportation services should apply to all persons who provide transportation services in the field regardless if advertising.
- Recommends the Board delete the exception outlined in AS 08.54.790(10).
- Recommended defining "incidental."
- Recommends inserting into definition exceptions a "Registered Guide-Outfitter" as a cross reference since it is in AS 08.54.610 and AS 08.54.750(8).
- Agency likes the idea of Transporters informing the Department 60 days before transporting the use area in which the Transporter will be providing services.

- How is a person who is applying for certification in a Game Management Unit to document species experience for past years'?
- Why not all species? Proposes an affidavit to document experience and provide for a cut-off date as to when experience would be accepted.

• 12 AAC 75,260 - Where are the contracts to be kept?

#### Todd Kuster

 Asked what is an appropriate buffer area? Looking to Board for suggestion. One days walking distance? Nine, 16, 19 miles?

## Jimmie C. Rosenbruch

- Do not exclude certain species, require experience with all species.
- Some Registered Guide-Outfitters have the experience harvesting Mt. goat, sheep, moose, caribou and/or brown bear, but can not document through hunt records that they have been involved in a guided hunt, that the species have been harvested because files are destroyed 10 years' after a license lapses. Recommends the Board to grandfather currently licensed Registered Guide-Outfitters.

#### Rich Guthrie

- Guide use are boundary changes are good idea.
- Personal experience should not be excluded from the 60 day infield requirement for certification in a Game Management Unit.
- Concerned about species specific licensing requirements.
- Multi year guide use area registration a good idea.

- 12 AAC 75.145(e) Recommends Transporter applicants must provide proof of appropriate FAA or US Coast Guard licenses.

#### Tom Kirstien

- Registered Guide-Outfitter applicants should have experience with all big game before being eligible to test.
- What happens to the Registered Guide-Outfitter who has land use authorization that doesn't contain 5,000 contiguous acres of uplands? Does the Registered Guide-Outfitter get registered there?
- The 60 day experience requirement to apply for certification in a Game Management Unit can take years to achieve.

#### Frank Danford

- Initial Assistant Guide applicants should be required to take a test before receiving a license.
- Why should currently licensed Registered Guide-Outfitters have to show experience in harvesting specific species?

# Rick Metzger

 Would like to rent his cabin to big game hunters without having to obtain a Registered Guide-Outfitter or Transporter license.

# Game Management Unit Subcommittee Report

Mr. Rohrer stated that "the subcommittee had several recommendations to demonstrate or meet the 60 days in-field experience, such as being a master guide; five years of active guiding; instead of using hunt records to calculate the 60 days use the contracts instead, because sometimes the hunt ends before it was scheduled too."

# Ethics Subcommittee Report

Mr. Brown stated that "the subcommittee determined that airplane scouting is unethical, unless specifically authorized by other applicable laws, or in units that are under intensive management identified by the Board of Game."

# Agenda Item 11 Review Application

# A. <u>Staff Request for Board Direction Regarding Application Processing</u>

<u>In-Field Experience</u>: Ms. Roccodero asked the Board if staff could award Registered Guide-Outfitter and Game Management Unit certification examination applicants two extra days per hunt for precamp and after camp activities, which are part of guide duties.

Mr. Johnson asked the Board if it had objections to Ms. Roccodero's request in awarding applicants two extra days per

hunt for pre-camp and after camp activities. There were no objections. Mr. Johnson directed staff to award all examination applicants an additional two days for each hunt.

<u>Verification of Species Specific Experience</u>: Ms. Roccodero informed the Board that multiple Assistant Guides can be listed on the hunt record as accompanying the client in the field. Since the hunt record does not identify which Assistant Guide was with the client during the harvest, staff has been awarding the applicant credit for the harvested species identified on the hunt record.

Mr. Johnson asked the Board if it had objections concerning Ms. Roccodero's procedure in awarding credit to applicants for species specific licensing. There were no objections. Mr. Johnson directed staff to continue the process of awarding applicants credit for the species identified on the hunt record as being harvested.

# Criminal History/Fish and Wildlife Violation Reports

Ms. Roccodero requested direction from the Board concerning criminal justice information and fish and wildlife violation reports received from applicants, which reflect that the applicant has a criminal record and/or fish and wildlife violation.

The Board directed staff to bring to its attention applicant files which reflect a criminal record and/or a fish and wildlife violation that occurred within the last five years.

# Consideration of Past GMU Experience

Ms. Roccodero informed the Board that prior to the late 1970's Registered Guide-Outfitters were certified to provide big game commercial services in multiple Game Management Units.

In the late 1970's the law changed, restricting Registered Guide-Outfitters to holding three certified Game Management Units at any given time. Registered Guide-Outfitters did not loose their certified Game Management Units and could withdraw and exchange units by submitting application to the Board.

Ms. Roccodero stated with the establishment of 12 AAC 75.112(a)(3), she has received numerous telephone calls from licensed Registered Guide-Outfitters who were licensed during the three certified Game Management Unit restriction. Licensees are requesting that the Game Management Units for which they are certified to be placed back on to their license.

Mr. Johnson asked the Board if it agreed to add the certified Game Management Units back on to Registered Guide-Outfitter licenses. The Board unanimously agreed.

Ms. Roccodero informed the Board that staff will add pre-existing certified Game Management Units to a license upon receipt of a written request.

# B. Assistant Guide License Application

Mr. Saxby stated that if the Board is requesting specific information to be submitted with an application for a portion of a guide use area, the required information will need to be placed into regulation.

The Board upon unanimous consent requested staff to submit to the Regulation Specialist for public noticing and take oral testimony at its March 2007 meeting, the following proposed regulations:

## 12 AAC 75,230. Guide Use Area.

- (c) A registered guide-outfitter who is registered in three guide use areas may register for an conduct big game services in a portion of at least one additional guide use area on federal land adjacent to a guide use area for which the registered guide-outfitter is already registered if the applicant meets the requirements of (a)(1)-(4) of this section and submits
- (1) a photocopy of the guide use area map that identifies the portion of an additional area is located on federal land and is adjacent to a guide use area the applicant is currently registered; and
- (2) a letter from the federal landholder that states the area would otherwise remain unused by a registered guide-outfitter because the boundaries do not coincide with boundaries of federal big game guide concession or permit area.

# 12 AAC 75.250 Participation In A Hunt.

- (f) A registered guide-outfitter who contracts to outfit a hunt shall
- (1) before leaving a client in the field, advise the client of the date, time, and location at which the registered guide-outfitter will

pick up the client and the course of action the client should follow if the registered guide-outfitter is unable to pick up the client as planned;

- (2) transport the client either personally or through an assistant or licensed transporter into and out of the field at the planned date, time, and location, unless prevented by weather, mechanical problems, or other safety concerns; and
- (3) check on or communicate with a client in the field as agreed to before transporting the client.

# Michael Hayes

- Two nonresident Assistant Guides guided each other for a species that requires them to be accompanied by a licensed guide in the field. Is this legal?
  - Ms. Roccodero stated that approximately four years ago, legislation was passed which requires any nonresident hunter who intends to hunt brown/grizzly bear, mountain goat or Dall sheep to enter into a contract with a licensed Registered Guide-Outfitter. Ms. Roccodero stated that this means if you are a licensed nonresident Registered Guide-Outfitter who intends to hunt a mountain goat, you must enter into a contract with a licensed Registered Guide-Outfitter, you can not accompany your self in the field. Ms. Roccodero stated this requirement is a Department of Fish and Game statute and to receive the proper interpretation of the statute to contact the agency.
- Recommended that the Board survey clients to learn how the guides are doing. This would assist the Board with creating and/or amending regulation.

#### Steve Perrin

- Thanked the Board for being here and doing the job it does.
- Too many hunters in areas, resulting in lack of stewardship of state resources.
- Encourages the Board to draft and sign the letter mentioned earlier in the meeting concerning DNR.

Mr. Perrins read a letter from Mike Cowan concerning transporters being able to take as many animals as they desire. Transporters move to where the game is until not much game is left then on to the next. They can move anywhere in the state without restriction.

Bobby Fithian read a letter from two licensees who were unable to attend the meeting. Staff was unable to take notes fast enough to obtain all the specific details concerning the letters including who the letters were from. After listening to the meeting recording staff was unable to obtain much information (testimony is indiscernible) other than what is presented below. Both letters are regulation proposals.

- Recommends policing of Assistant Guide workforce.
- Assistant guide leaves during the hunt and then falls through the wood work.
- 3 complaints against an Assistant Guide from an employing.
   Registered Guide-Outfitter would result (indiscernible).
- Transporter issues (indiscernible).

Much of Mr. Fithian's testimony is indiscernible too. Below is the information staff was able to extract from the meeting recording.

- Need to restrict Transporters to areas.
- Thank you to the Board and staff for what you have done for the industry.

Dick Rohrer read letters in to record for the following persons:

Eric Stirupp: Strongly encourages the Board to address Transporter issues with up most priority. Having no control over Transporter geographic scope of operations, people will see future season and bag limit changes, as a result of this more drawing permits. Transporters need to take stewardship of the resources, not the number of hunters they move.

Ken Newman: The Kodiak Association of Charter Operators (KACO) expressed its desire to make Game Management Unit 8 an exclusive registration for big game Transporters. KACO feels it would improve the quality of services offered and give local residents some control over local lands and game. KACO is requesting the Board to deal with land issues before it becomes a crisis.

<u>Jake Jacobson</u>: Limit Transporters to a specific area. Create regulations preventing a single entity from operating as a Registered Guide-Outfitter and Transporter in the same Game Management Unit.

#### Nate Turner

 Policing of Assistant Guides, file complaints on Assistant Guides, 3 complaints not eligible to apply for a Registered Guide-Outfitter license.

- · Concerned about Transporters.

- 6 closed complaints. When investigating a compliant the Division finds that the licensee has violated a statute or regulation under AS 08.54 or 12 AAC 75 the complaint is closed and becomes a case.

The following are the draft proposed statutes and language that the Board approved.

# **Amendment**

AS 08.54,770 LICENSE AND EXAMINATION FEES.

- (a) The Department shall set fees under AS 08.01.065 for each of the following:
- (5) license and unit certification application fees;
- (6) examination fees;
- (7) species endorsement fee; and
- (8) guide use area registration fee.

# AS 08.54.600 DUITES OF THE BOARD.

- (c) The Board may adopt regulations as the board considers appropriate to
- (4) require disclosure of booking agents authorized to act on behalf of a licensee; and
- (5) accommodate for medical emergencies.

Mr. Johnson asked Mr. Rohrer to work with Ms. Gabier on the language for medical emergencies.

Mr. Johnson assigned the task of writing a letter to Safari Club International concerning vendors booking Alaska hunts to Mr. Spraker. Mr. Johnson stated that he would work on the letter with Mr. Spraker.

Mr. Spraker stated that the Alaska Professional Hunters Association (APHA) is the ideal venue to take this on. Mr. Spraker stated that he is "not passing the buck, but they are the ones who should take this on."

# AS 08.54.760 USE AREA REGISTRATION

(a) At least 30 days before conducting big game hunting services within a guide use area, a registered guide-outfitter shall inform the department, in person or by registered mail on a registration form provided by the department <u>and submitted the applicable</u> <u>registration fee</u>, that the guide-outfitter will be conducting big game hunting services in the use area. <u>Once the application has been processed, a</u> registered guide-outfitter may not withdraw or amend a guide use area registration.

# AS 08.54.710 DISCIPLINE OF GUIDES AND TRANSPORTERS.

(i) The board may summarily suspend a licensee from practice of the profession under this chapter, [for a period of not more than 30 days] before a final hearing is held or during an appeal if the board finds that the licensee poses a clear an immediate danger to the public health and safety. A person is entitled to a hearing before the board to appeal the summary suspension within seven days after the order of suspension is issued. A person may appeal an adverse decision of the board on an appeal of summary suspension is issued. A person may appeal an adverse decision of the board on an appeal of summary suspension to a court of competent jurisdiction.

# New Section

AS 08.54. \_\_\_ GROUNDS FOR DENIAL, SUSPENSION, OR REVOCATION.

The board may deny, suspend, or revoke the license of a person who has obtained or attempted to obtain a license under this chapter by fraud, deceit, or misrepresentation.
