Type of Mark	Definition
Trademark	A trademark includes any word, name symbol, or device, or any combination, used, or intended to be used, in commerce to identify and distinguish the goods of one manufacturer or seller from goods manufactured or sold by others, and to indicate the source of the goods. In short, a trademark is a brand name.

A person may renew their mark by submitting the Application for Renewal of Trademark, together with three (3) specimens, showing the actual use of the mark on or in connection with the stated goods with applicable fees.

ITEM 3: Signature

The signer must be the applicant or a member of the firm or an office of the corporation, partnership or association applying for the mark.

NOTE: If the name of the name registrant has changed but the ownership remains the same, pursuant to Alaska Statutes 45.50.125 complete the Registrant Name Change form 08-555.

NOTE: If the registrant has changed a new mark registration may be completed, or an Assignment of Registration form 08-556 may be completed.

Refer to Alaska Statutes 45.50.. If you need assistance in completing your filing, it is advised that you seek legal counsel. Please be aware that this filing will become public information.
