### **INSTRUCTIONS** (Please retain for your records):

**NOTE:** You must attach a certificate of good standing from the state or territory of domicile of the corporation. The certificate must have been issued within last 60 days.

Pursuant to Alaska Statutes 10.06.135 persons who wish to register a foreign corporate name must complete the application furnished by the department and include a certificate of good standing from the state or territory of domicile.

The registration is effective until the close of the calendar year in which the application for registration is filed unless terminated earlier by involuntary dissolution in accordance with AS 10.06.633. The registration is renewable at one-year intervals by reapplying between October 1st and December 31st of the year of expiration.

**ITEM 1**: Provide the full legal name of the entity as registered in its state of domicile.

**ITEM 2**: Provide the name of the state or territory of domicile and the date the entity was incorporated.

**ITEM 3**: Provide the principal office address of the corporation.

**ITEM 4**: Describe the nature of business that the corporation is engaged in.

**ITEM 5:** The signer must be an officer of the corporation.

**NOTE:** Persons who sign documents filed with the commissioner that are known to the person to be false in material respects, is guilty of a class A misdemeanor.

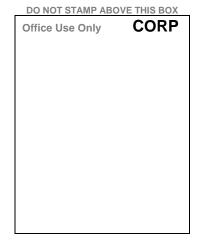
