

Order No. 2 - Notice of Opportunity to Intervene

As ordered in the director’s July 7, 2003 Scheduling Order, a public hearing will be held on the Form A Statement of Premera Blue Cross (PBC) pursuant to AS 21.06.180 and AS 21.22.030. The procedures in AS 21.06.170, 21.06.200, and 21.06.210 will apply. Under AS 21.06.210(b), a person may become a party to this proceeding by filing a timely request or motion to intervene establishing that the person’s “pecuniary interests are to be directly and immediately affected by the director’s order made upon the hearing.”

THEREFORE, IT IS HEREBY ORDERED:

1. Any person wishing to participate as a party in this proceeding must file a motion or request to intervene with the director in Anchorage office no later than August 25, 2003. This motion or request must include a memorandum and supporting affidavit setting forth the factual and legal basis for intervention. Any motion or request for intervention should be served on the division staff and Premera Blue Cross.
2. Opposition to a person’s motion or request for intervention must be filed with the director on or before September 5, 2003. Any replies must be filed by September 10, 2003.
3. Filing or service by facsimile is acceptable.
4. Notice of opportunity to intervene will be published by display ads in local newspapers throughout Alaska and in Seattle.
