
1 (a)(2), that Certificate of Authority No. F-8050 issued to **ICM INSURANCE**
2 **COMPANY** to transact the business of insurance in the State of Alaska shall be
3 suspended until such time as it has returned to full compliance with Alaska
4 Statutes unless terminated sooner as permitted by statute. Pursuant to AS
5 21.09.160 (b), this suspension shall automatically suspend the authority of all of
6 its agents to act as agents of **ICM INSURANCE COMPANY** in this state.

8 **IT IS FURTHER ORDERED** that during the period of suspension **ICM**
9 **INSURANCE COMPANY** shall not solicit or write new business in the State of
10 Alaska but shall file the annual statement, pay fees and any taxes due as provided
11 by AS 21.09.170(b).

13 **IT IS FURTHER ORDERED**, that Certificate of Authority No. F-8050
14 will continue to be held in safekeeping by **ICM INSURANCE COMPANY** until
15 such time as this order is replaced by an Order of Revocation, the Certificate of
16 Authority is surrendered or the Certificate of Authority expires.
