Club Caterer's Permit Application

Eligible License Types: Club license

Event Requirements: Permit Fee: \$100 for the first two days and \$50 for each additional day.

Event Requirements: Sec. 04.09.630. Club caterer's permit. (a) A club caterer's permit authorizes the holder of a club license to sell or dispense alcoholic beverages at an event held off the club's licensed premises.

(b) The application for a club caterer's permit filed under AS 04.11.260 must be signed by two officers of the organization.

(c) A restriction or prohibition under AS 04.09.220 regarding a club member or a guest of a club member applies at the premises covered by the permit.

(d) The director may not issue more than three club caterer's permits to the holder of a club license in a calendar year.

Permit Restrictions: The permit may only be issued for designated premises for a specific occasion and for a limited period.
