Music Festival Permit Application

Permit Fee: \$100 for up to two days, \$50 for each additional day. **Event Requirements:** A music festival permit authorizes the holder of a restaurant or eating place license to sell or dispense brewed beverages and wine for consumption at a festival with multiple live music performances held off the holder's licensed premises. The board may issue a music festival permit to the holder of a restaurant or eating place license only if the licensed premises of the restaurant or eating place is located in the unorganized borough. The director may issue a music festival permit only for designated premises for a specific occasion and for a limited period during a single day between the hours of 9:00 a.m. and 9:00 p.m., as in AS 04.09.645 and 3 AAC 305.365. The board may issue a music festival permit only for: (1) a designated premises and for a

limited period, not to exceed four calendar days; (2) a music festival that has existed at the same location for a period of at least 10

Permit Restrictions: The director may not issue more than one music festival permit to the holder of a restaurant or eating place license in a calendar year.

- If your premises include multiple floors, please include a separate diagram of each floor. You must identify the stairs between each floor, and each hallway/corridor that leads to each set of stairs.
- Any permit applications that include outdoor space are required to submit a security plan that includes information about the barriers, practices, and personnel that are to be used to ensure that alcohol is not introduced or removed from the permitted premises and to prevent the access of alcohol by a minor during the permitted event. A security plan may be requested for other proposed locations on a case-by-case basis.
