REGULATIONS OF MARIJUANA CONTROL BOARD

The attached single page of regulations, dealing with licenses issued late in the year, is certified to be a correct copy of the regulation changes that the Alcoholic Beverage Control Board adopted at its July 29 meeting, under the authority of AS 04.06.090 and after compliance with the Administrative Procedure Act (AS 44.62), specifically including notice under AS 44.62.190 and 44.62.200 and opportunity for public comment under AS 44.62.210.

This action is not expected to require an increased appropriation.

On the record, in considering public comments, the Alcoholic Beverage Control Board paid special attention to the cost to private persons of the regulatory action being taken.

The regulation changes described in this order take effect on the 30th day after they have been filed by the lieutenant governor, as provided in AS 44.62.180.
