Is there an application?	Not at this time, however, it is the licensee's responsibility to make sure there is adequate supervision on the premises to ensure that a person under 21 years of age will not obtain alcoholic beverages, except as provided under AS 04.16.049(d). The board may adopt regulations, and/or an application, in the future.
Can I employ an 18, 19, 20-year-old behind the bar?	An 18, 19, 20-year-old may be employed for the service or alcoholic beverages.
Alcohol Server Education	

Who does not need an alcohol server education card.	<p>If you are <u>not listed</u>, you need it.</p> <ul style="list-style-type: none"> • A brewery manufacturer license, unless the licensee holds a manufacturer sampling endorsement or a brewery repackaging endorsement. • A winery manufacturer license, unless the licensee holds a manufacturer sampling endorsement. • A distillery manufacturer license, unless the licensee holds a manufacturer sampling endorsement. • A general wholesale license. • A limited wholesale brewed beverages and wine license. • A manufacturer direct shipment license
Signs	
How do I get the sign?	Our office will mail you the new sign before August 1, 2025. You are welcome to create your own, but the sign must meet the requirements of AS 04.21.065(b).
When do I need to post the new sign?	August 1, 2025.
Clubs	
What is the change for club licenses?	Members of a patriotic organization holding a club license may enter into a reciprocity agreement with another patriotic organization holding a club license to allow each organization to sell alcoholic beverages to members of both organizations.
How is a reciprocity agreement created?	The decision to enter into a reciprocity agreement shall be made by a majority of members present at a general meeting of each patriotic organization.
Theater	
A theater licensee can now allow the sale, service, and consumption of alcoholic beverages two hours before, during the event, and one hour after the event. Do I need to do anything with my premises diagram?	Yes, you need to file an application to change your licensed premises that includes the expansion of your service area.
