Rita Leake – constant crime, fights, guns, beatings; licensee cleans up the lot, but not the street where there is much debris; asking the Board to require doors to be closed.

Christine Robbins – bar has been known to serve to under age persons (teens); a little girl got hit by a beer bottle tossed out of a car; Mike got hit by a beer bottle; inebriants driving up and down – it's a dead end street. Prostitution ring run out of the bar; curse on neighborhood; isn't safe for the kids; vandalism – car windows broken out by bottles & rocks; police called; hope that the Board will consider closing the bar.

Mike Moore – 38 year resident; bar owned by several different owners over the years; kids cannot cross the road (he will not allow them); would like to see the license suspended pending a location move; would not like to see the license revoked, but definitely suspended pending a move by January; prostitution, massage out of the bar are both unknown to him personally; future operation should be described in detail and surrounding residents should be given an opportunity to speak. Prior to current ownership, early years – quiet country bar, then disco bar, then biker bar, then underage (no alcohol). He did get hit by a bottle and then returned the bottle to the person(s) that threw it; this is not a "neighborhood" bar; would like to see the bar gone, license suspended.
