

At the board of director's meeting held in Anchorage on May 30, 2013 the issue of waivers was on the agenda for discussion. Several people testified that having waivers follow the license was not a fair policy. No person testified that waivers should follow the licensee. The issues came down to two as you, Mr. Klein pointed out, 1) providing an incentive to licensees to operate his or her licenses, and 2) protect licensees' investments. Ms. Ganley recommended that if a licensee applies for a transfer after receiving three or four waivers then steps should be taken to ensure no relationship between the buyer and seller exists.

Whereas, you were prepared to entertain a motion, Assistant Attorney General Milks suggested that the board take the time before the next meeting to reflect on it before entertaining a change in policy.

#### The questions:

1. Should the waivers follow the license as was done in the past, or should the waivers follow the licensee as is current practice?

If you decide the waivers remain with the license:

2. What is the best way to communicate a licensee's rights and obligations, both to existing licensees and transferees of licenses that may have had waivers in the past?

Licenses

Every year ABC Board staff deal with licensees who for various reasons do not renew their licenses before the final deadline of February 28<sup>th</sup>. Alaska Statute 04.11.270(b)(1) states that on or before November 1<sup>st</sup> the director shall mail a renewal application to each licensee whose license will expire on December 31<sup>st</sup> of that year. In accord with the same statute, the application is mailed to the licensee at the mailing address furnished by the licensee. AS 04.11.430(b) states the mailing address of a licensee must be kept current and on file in the main office of the board.

Each year 20 to 30 licenses are allowed to expire. Two or three of those are not intentional. The Board, in accord with 3 AAC 304.160(e), has required the licensee to come before the Board to request reinstatement of the license. Also under 3 AAC 304.160(e) the licensee must submit a complete application, all required fees and penalty fees, and proof of good cause for the failure to file and pay by February 28<sup>th</sup>. This process gives the Board the opportunity to instill in the licensee the importance of being responsible for the renewal of their license.

For the most part, licensees who allow their license to expire continue to operate but stop the sales of alcoholic beverages until they can come before the Board. However, when the licensee holds a beverage dispensary license they must essentially close the business which affects the livelihood of innocent parties. In 2010 staff allowed a licensee in Anchorage to cater to a second premises in Wasilla where the licensee unintentionally allowed the Wasilla license to expire. This justifiably required the licensee to clear his bar in Wasilla and have the alcohol catered from Anchorage. It did not seem like a good solution then and when it became an issue in April of this year with the Blue Loon it became apparent it was even less of a good solution. In the case of the Blue Loon, another licensee volunteered to cater over an eight-week period but did not provide the services and responsibility expected under a caterer's permit.

During the process of dealing with this licensee it came to light from Assistant Attorney General Harriet Milks, assigned to the ABC Board, that this situation could be handled through the



Board's delegation of authority given to the director in AS 04.06.090. Therefore, I request that delegation of authority to temporarily renew a license that was unintentionally allowed to expire, and that you approve the following procedure:

- 1. As soon as is practical and as close to possible as February 28th, the Records and Licensing Supervisor will notify investigators of those licenses that expired.
- Investigators will respond, or request assistance from state or local police to respond to the licensed premises to ensure the licensee is not operating on an expired license.
- If the licensee is operating the licensee will be advised to immediately cease the selling of alcoholic beverages.
- 4. The investigator will have posted on the premises a sign stating that no sales of alcoholic beverages are allowed.
- 5. If the licensee expresses a desire to operate prior to the next Board meeting (where the licensee will have an opportunity to request resurrection and renewal of his or her license) the licensee will be directed to contact the Director.
- 6. The licensee will be required to submit his or her renewal application along with the \$500 late fee (AS 04.11.280(b)(3)), and an explanation for the failure to renew on time.
- 7. In accord with AS 04.11.520 the Director will notify the local governing body within 10 days of receipt of the renewal application.
- 8. If the local governing body does not protest the Director may issue a temporary license until the next board meeting.

**RE: Recreational Site License** 

The recreational site license was discussed during public testimony at the board of directors' meeting held on May 30, 2013. You decided a special interim meeting was in order to take additional testimony and to decide the appropriate step to take to deal with requests for recreational site licenses that do not fit perfectly the examples given in statute.

#### Sec. 04.11.210. Recreational site license.

- (a) The holder of a recreational site license may sell beer and wine at a recreational site during and one hour before and after a recreational event that is not a school event, for consumption on designated areas at the site.
- (b) The biennial fee for a recreational site license is \$800.
- (c) In this section, "recreational site" includes a location where baseball games, car races, hockey games, dog sled racing events, or curling matches are regularly held during a season.

The special meeting of the board was held on June 11, 2013 where the policy written April 11, 2011 was discussed. The policy (copy attached) evolved from two applications before the board at the December 13, 2010 board meeting. One was for a billiards establishment and the other an athletic club. The policy had been objected to from various people from different walks of life.

At the end of the June 11, 2013 meeting you decided the Chair and the Director would work together to develop a draft proposal for regulation for discussion at the July 23, 2013 meeting. The draft proposal is attached for discussion and approval.

3 AAC 304 is amended by adding a new section to read:

#### 3 AAC 304. Recreational Site License

- (a) A recreational site license authorizes the licensee to sell beer and wine on licensed premises located on the recreational site.
- (b) A license may be issued only if an application is approved by the local governing body and the board, and the applicant does not hold a beverage dispensary license or a restaurant or eating place license.
- (c) A recreational site license must be based upon a competitive spectator sporting event with a designated sport season, and with a starting time and an ending time.
- (1) A competitive spectator sporting event includes baseball games, softball games, football games, soccer matches, dog sled races, hockey games, basketball games, curling matches, gymnastic meets, volleyball meets, car races, boating races, snow machine races, skiing races, and leagues or tournaments that includes golf, bowling, and billiards.

Subject: Policy on Recreational Site

Licenses

At the Board of Directors' meeting held in Anchorage, December 13-14, 2010 a discussion took place regarding recreational site licenses. Two separate applications were considered and approved at that meeting (The Summit, license #5004 and Beluga Billiards, license #5009). The recreational activities did not fit neatly under AS 04.11.210; however, the Board of Directors approved the licenses and requested that Assistant Attorney John Novak draft proposed changes to the statute.

Mr. Novak provided language for a proposed change that was considered by the Board at the meeting held in Juneau, March 24, 2011. After discussion by the members Mr. Novak offered his suggestions as policy as opposed to initiating a statute change. The members of the board agreed. The following is the policy by which we will consider recreational site license applications that includes the language of AS 04.11.210.

A recreational site license authorizes the licensee to sell beer and wine on licensed premises located on the recreational site. A license may be issued only if an application is approved by the local governing body and the board, and the applicant does not hold a beverage dispensary license or a restaurant or eating place license.

An event-based recreational site license will allow the licensee to sell beer and wine one hour before and one hour after an event. An event based recreational site license includes the following spectator sporting events, or other spectator sporting events having substantially similar characteristics - baseball games, softball games, football games, soccer matches, running events, skiing events, dog sled races, hockey games, basketball games, curling matches, gymnastic meets, volleyball meets, car racing events, and snow machine races.

An activity-based recreational site license will allow the licensee to sell beer and wine during times the recreational activity is taking place. An activity-based recreational site license includes the following recreational activities, or other recreational activities having substantially similar characteristics - baseball, softball, football, soccer, running, skiing, skating, dog sledding, curling, gymnastics, zip lines, volleyball, climbing, hiking, fitness activities, golf, bowling, billiards, hiking, rafting, and boating.

A recreational site license may not be issued if the licensed premise is within 200 feet of the property line for real property that is owned by, leased to, or rented to any public or private school, church, college, or university.

We have reviewed the attached regulations from the Alcoholic Beverage Control Board. I have reviewed this project under a specific delegation dated June 28, 2013 from the Regulations Attorney. A duplicate of this memorandum is being furnished to Shirley A. Coté, the director, along with a copy of the regulations.

The Department of Law has reviewed the attached regulations against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This memorandum and the attached duplicate memorandum dated June 28, 2013 constitute the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations.

The regulation changes were adopted by the Alcoholic Beverage Control Board after the close of the public comment period. The regulations establish requirements for a package store licensee that enters into a standing shipment order agreement with a purchaser for the periodic shipment of wine of the licensee's choice to the purchaser.

The certification order for the regulations states that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.195 is not required.

We have made a few technical corrections to conform the regulations with the drafting manual under AS 44.62.060 and 44.62.125. The corrections are shown on the attached copy of the regulations.

RE: Municipal Refunds

#### Introduction:

During the legislative audit of 2009 the auditors pointed out on page 10 (copy attached) under 3. Licensing and Administrative Procedures, bullet seven that staff was not confirming and enforcing reports that should be filed by municipal law enforcement agencies prior to refunding municipal license fees. In 2010 the auditors returned and we discussed the issue of municipalities enforcing alcoholic beverage laws and at that time they seemed to accept my explanation that from my experience and contacts with police across the state for many years that part of the everyday function of the police included the enforcement of alcoholic beverage laws. This issue was not addressed in the follow-up report of September 28, 2010. However, I took steps to ensure this issue does not arise in the next audit of late 2014 or early 2015 (the ABC sunset is June 30, 2015).

#### Relevant statutes and regulations:

Alaska Statute Sec. 04.11.610. Refund to municipalities states the following:

- (a) Biennial license fees, excluding annual wholesale fees and biennial wholesale license fees, collected within a municipality shall be refunded semi-annually to the municipality.
- (b) If the officers of a municipality fail to actively enforce local ordinances, laws of the United States and the state, and the regulations relating to the manufacture and sale of alcoholic beverages in the state, the commissioner of commerce, community, and economic development may deny the refund provided for under (a) of this section until the board finds the enforcement of the ordinances, laws, and regulations is resumed.
- (c) The Department of Commerce, Community, and Economic Development shall recover any amounts erroneously refunded under (a) of this section. The



Department of Commerce, Community, and Economic Development shall schedule repayments of erroneously refunded amounts over a sufficient period of time to minimize financial hardship to the municipality involved.

#### Regulation 3 AAC 304.610. Refunds to municipalities states the following:

- (a) For the purposes of AS 04.11.610 a municipality's failure to actively enforce local ordinances, laws of the United States and the state, and the provisions of this chapter relating to the manufacture and sale of alcoholic beverages in the state includes the failure of the municipality's peace officers to comply with AS 04.21.070.
- (b) The director shall recommend that the commissioner of commerce, community, and economic development deny the refund of biennial license fees under AS 04.11.610 if the director determines that the municipality's peace officers have not provided the director with quarterly reports of violations of AS 04 occurring on licensed premises within the municipality.

Alaska Statute Sec. 04.21.070. Enforcement states the following:

Peace officers shall investigate and report to the board violations of this title.

#### Actions taken:

I developed a simple report form (copy attached) for police departments to use to capture their quarterly statistics. Most of the departments use this form, or one fairly similar. I continue to accept e-mails and letters. Several departments report more frequently by sending their police reports as the violations occur. At the end of each quarter I send an e-mail reminder to the chiefs, or their designee.

In 2012 at the end of the first quarter six municipalities failed to report; second quarter – 10; third quarter – seven; fourth quarter – seven. Attached is an Excel spreadsheet containing the names of the 36 cities with and X to indicate a quarterly report has been submitted. It is not always the same municipalities failing to report consistently and at the end of the third quarter I called each police department personally that had no report filed and still seven did not report.

#### Questions:

- 1. During 2012 every municipality reported for at least one quarter. Biennial license fees are refunded semi-annually. Shall we divide the semi-annual fees by two and if the municipality reports for one quarter but not the other then should I request that the Commissioner withhold one half of the semi-annual fee?
- 2. Two communities with a high number of liquor licenses report no violations or even warnings in the last quarter of 2012. If a police department provides a quarterly report should that be interpreted that the laws are "actively enforced?"

- 2. <u>Licensing Revenues</u>. Licensing fee revenues recorded in the ABC Board's database does not agree with nor is reconciled to the same revenue as it is recorded in the State accounting system. The failure to reconcile has resulted in overpayments to municipalities and missed payments by licensees. Timely, complete, and accurate reconciliation between the two systems would likely resolve these problems and provide information for the board and director to take immediate action regarding noncompliant licensees.
- Licensing and Administrative Procedures. The ABC Board members and director are not
  providing appropriate guidance and oversight to staff to ensure compliance with state
  laws, and with its decisions.

The ABC Board does not consistently adhere to the statutory requirement of notifying the local governing body within ten days of receipt of an application per AS 04.11.520. This important requirement allows time for the local government to review and possibly protest the issuance, renewal, relocation or transfer of a license.

The ABC Board is also not enforcing the law requiring the return of caterers and special event permits within 48 hours. Other deficiencies in the ABC Board's licensing files, recordkeeping, database, and administrative processes include:

- No current written policy and procedures to give guidance in situations where licensees are involved in bankruptcy proceedings.
- Staff routinely failed to properly use existing checklists for verifying the completeness of licensing applications.
- Instances where staff had not submitted local government protests in a timely manner to the board for review and action.
- Significant occurrences of expired and/or unpaid licenses being incorrectly listed as active license holders.
- Failure to detect instances where required wholesale affidavits had not been filed by wholesale licensees.
- Municipalities being over or under paid for municipal license fee refunds.
- The ABC Board's staff is not confirming and enforcing reports that should be filed by municipal law enforcement agencies prior to refunding municipal license fees.
- The concerns of local governments that the ABC Board's policy and procedures do not include written notification to local governments regarding expired licenses.

The above activities show that the ABC Board may not be operating effectively and efficiently and is not achieving its potential in furthering the public interest.

4. <u>Enforcement Data Procedures.</u> The ABC Board's investigators inconsistently or inaccurately entered case record information into the Alaska Public Safety Information

Subject: Alcohol sales and manufacturing violations

#### Dear Alaska Chiefs of Police,

Some of you may know that in the past couple of years there was work in progress on reporting certain crimes to the State of Alaska. I don't know if or when that reporting will come to fruition; therefore, I am asking for your cooperation in reporting violations of local ordinances, federal and state laws and regulations relating to the manufacture and sale of alcoholic beverages in the state. During the last legislative audit of the ABC Board I was asked if police departments were reporting as required. Many were not reporting. Although the auditors accepted my answer that I knew the departments were enforcing these laws "because that is what they do" I believe we all have a responsibility to follow the statutes and regulations.

#### Alaska Statute Sec. 04.11.610. Refund to municipalities states the following:

- (a) Biennial license fees, excluding annual wholesale fees and biennial wholesale license fees, collected within a municipality shall be refunded semi-annually to the municipality.
- (b) If the officers of a municipality fail to actively enforce local ordinances, laws of the United States and the state, and the regulations relating to the manufacture and sale of alcoholic beverages in the state, the commissioner of public safety may deny the refund provided for under (a) of this section until the board finds the enforcement of the ordinances, laws, and regulations is resumed.
- (c) The Department of Public Safety shall recover any amounts erroneously refunded under (a) of this section. The Department of Public Safety shall schedule repayments of erroneously refunded amounts over a sufficient period of time to minimize financial hardship to the municipality involved.

Several of you do report to the ABC Board on a quarterly basis. A couple of you report daily or weekly. I am sending this email for expediency sake (I have a tendency to respond more quickly to an email than a formal written letter). It is not my desire to add more work to your load; however, it seems as though this law and its companion regulation have not been enforced over the years.

#### Regulation 13 AAC 104.610. Refunds to municipalities states the following:

- (a) For the purposes of AS 04.11.610 a municipality's failure to actively enforce local ordinances, laws of the United States and the state, and the provisions of this chapter relating to the manufacture and sale of alcoholic beverages in the state includes the failure of the municipality's peace officers to comply with AS 04.21.070.
- (b) The director shall recommend that the commissioner of revenue deny the refund of biennial license fees under AS 04.11.610 if the director determines that the municipality's peace officers have not provided the director with quarterly reports of violations of AS 04 occurring on licensed premises within the municipality.

Alaska Statute Sec. 04.21.070. Enforcement states the following:

Sec. 04.21.070. Enforcement.

Peace officers shall investigate and report to the board violations of this title.

I have cc'ed Gil Nelson, my administrative assistant who maintains the reports from police departments. In an effort not to create more work than is absolutely necessary, you may send an email during the first week of April (1<sup>st</sup> quarter), first week of July (2<sup>nd</sup> quarter), first week of October (3<sup>rd</sup> quarter), and first week of January (4<sup>th</sup> quarter) to Gil and me for our files, and for my review semi-annually when the refunds to municipalities are processed. I appreciate your cooperation and invite you to ask questions or give feedback in this process. Thank you.



Dear Chiefs and Chiefs' Delegates,

It is time to submit your second quarterly report for 2013. I have already heard from a number of you with the Soldotna Police Department being first in this quarter with Seward and Juneau being very close second and third, respectively. I appreciate the timeliness of all reports and to those departments who report more frequently when issues arise in connection with licensed premises.

We still have a few chiefs who are not reporting consistently for each quarter. We have others who consistently report no enforcement activity. As you know, municipalities have two statutory requirements and one regulatory requirement, 1) AS 04.21.070 states peace officers shall investigate and report to the board violations of this title, 2) AS 04.11.610 states that if officers fail to actively enforce alcoholic beverage laws, ordinances and regulations the municipal refund may be denied, and 3) 3 AAC 104.610 states the director shall recommend denial of the license fees if peace officers fail to provide quarterly reports of violations of AS 04 occurring on licensed premises within the municipality. Municipal refunds is a subject of discussion and decision-making for the board of directors at the next board meeting to be held in Fairbanks on July 23rd. The time of this discussion is yet to be determined; however, the agenda will be posted on our website at <a href="http://commerce.alaska.gov/dnn/abc/Home.aspxb">http://commerce.alaska.gov/dnn/abc/Home.aspxb</a> about one week prior to the meeting. If you have concerns I would encourage you to dial in to the meeting. The phone number will also be posted on our website.

The ABC Board has joined the Alaska Records Management System (ARMS) through the Department of Public Safety. As we have been invited and trained, police departments are being invited to join. This is excellent technology that allows for sharing valuable law enforcement information. The more departments that join the more information we can share in a less time-consuming and time-delayed manner. This should assist all of us in many ways and in particular between you and the ABC Board in this required reporting. Dear Chiefs and Chiefs' Delegates,

It is time to submit your second quarterly report for 2013. I have already heard from a number of you with the Soldotna Police Department being first in this quarter with Seward and Juneau being very close second and third, respectively. I appreciate the timeliness of all reports and to those departments who report more frequently when issues arise in connection with licensed premises.

We still have a few chiefs who are not reporting consistently for each quarter. We have others who consistently report no enforcement activity. As you know, municipalities have two statutory requirements and one regulatory requirement, 1) AS 04.21.070 states peace officers shall investigate and report to the board violations of this title, 2) AS 04.11.610 states that if officers fail to actively enforce alcoholic beverage laws, ordinances and regulations the municipal refund may be denied, and 3) 3 AAC 104.610 states the director shall recommend denial of the license fees if peace officers fail to provide quarterly reports of violations of AS 04 occurring on licensed premises within the municipality. Municipal refunds is a subject of discussion and decision-making for the board of directors at the next board meeting to be held in Fairbanks on July 23rd. The time of this discussion is yet to be determined; however, the agenda will be posted on our website at <a href="http://commerce.alaska.gov/dnn/abc/Home.aspxb">http://commerce.alaska.gov/dnn/abc/Home.aspxb</a> about one week prior to the meeting. If you have concerns I would encourage you to dial in to the meeting. The phone number will also be posted on our website.

The ABC Board has joined the Alaska Records Management System (ARMS) through the Department of Public Safety. As we have been invited and trained, police departments are being invited to join. This is excellent technology that allows for sharing valuable law enforcement information. The more departments that join the more information we can share in a less time-consuming and time-delayed manner. This should assist all of us in many ways and in particular between you and the ABC Board in this required reporting. Licenses

Every year ABC Board staff deal with licensees who for various reasons do not renew their licenses before the final deadline of February 28<sup>th</sup>. Alaska Statute 04.11.270(b)(1) states that on or before November 1<sup>st</sup> the director shall mail a renewal application to each licensee whose license will expire on December 31<sup>st</sup> of that year. In accord with the same statute, the application is mailed to the licensee at the mailing address furnished by the licensee. AS 04.11.430(b) states the mailing address of a licensee must be kept current and on file in the main office of the board.

Each year 20 to 30 licenses are allowed to expire. Two or three of those are not intentional. The Board, in accord with 3 AAC 304.160(e), has required the licensee to come before the Board to request reinstatement of the license. Also under 3 AAC 304.160(e) the licensee must submit a complete application, all required fees and penalty fees, and proof of good cause for the failure to file and pay by February 28<sup>th</sup>. This process gives the Board the opportunity to instill in the licensee the importance of being responsible for the renewal of their license.

For the most part, licensees who allow their license to expire continue to operate but stop the sales of alcoholic beverages until they can come before the Board. However, when the licensee holds a beverage dispensary license they must essentially close the business which affects the livelihood of innocent parties. In 2010 staff allowed a licensee in Anchorage to cater to a second premises in Wasilla where the licensee unintentionally allowed the Wasilla license to expire. This justifiably required the licensee to clear his bar in Wasilla and have the alcohol catered from Anchorage. It did not seem like a good solution then and when it became an issue in April of this year with the Blue Loon it became apparent it was even less of a good solution. In the case of the Blue Loon, another licensee volunteered to cater over an eight-week period but did not provide the services and responsibility expected under a caterer's permit.

During the process of dealing with this licensee it came to light from Assistant Attorney General Harriet Milks, assigned to the ABC Board, that this situation could be handled through the



Board's delegation of authority given to the director in AS 04.06.090. Therefore, I request that delegation of authority to temporarily renew a license that was unintentionally allowed to expire, and that you approve the following procedure:

- 1. As soon as is practical and as close to possible as February 28th, the Records and Licensing Supervisor will notify investigators of those licenses that expired.
- Investigators will respond, or request assistance from state or local police to respond to the licensed premises to ensure the licensee is not operating on an expired license.
- If the licensee is operating the licensee will be advised to immediately cease the selling of alcoholic beverages.
- 4. The investigator will have posted on the premises a sign stating that no sales of alcoholic beverages are allowed.
- 5. If the licensee expresses a desire to operate prior to the next Board meeting (where the licensee will have an opportunity to request resurrection and renewal of his or her license) the licensee will be directed to contact the Director.
- 6. The licensee will be required to submit his or her renewal application along with the \$500 late fee (AS 04.11.280(b)(3)), and an explanation for the failure to renew on time.
- 7. In accord with AS 04.11.520 the Director will notify the local governing body within 10 days of receipt of the renewal application.
- 8. If the local governing body does not protest the Director may issue a temporary license until the next board meeting.

**RE: Recreational Site License** 

The recreational site license was discussed during public testimony at the board of directors' meeting held on May 30, 2013. You decided a special interim meeting was in order to take additional testimony and to decide the appropriate step to take to deal with requests for recreational site licenses that do not fit perfectly the examples given in statute.

#### Sec. 04.11.210. Recreational site license.

- (a) The holder of a recreational site license may sell beer and wine at a recreational site during and one hour before and after a recreational event that is not a school event, for consumption on designated areas at the site.
- (b) The biennial fee for a recreational site license is \$800.
- (c) In this section, "recreational site" includes a location where baseball games, car races, hockey games, dog sled racing events, or curling matches are regularly held during a season.

The special meeting of the board was held on June 11, 2013 where the policy written April 11, 2011 was discussed. The policy (copy attached) evolved from two applications before the board at the December 13, 2010 board meeting. One was for a billiards establishment and the other an athletic club. The policy had been objected to from various people from different walks of life.

At the end of the June 11, 2013 meeting you decided the Chair and the Director would work together to develop a draft proposal for regulation for discussion at the July 23, 2013 meeting. The draft proposal is attached for discussion and approval.

3 AAC 304 is amended by adding a new section to read:

#### 3 AAC 304. Recreational Site License

- (a) A recreational site license authorizes the licensee to sell beer and wine on licensed premises located on the recreational site.
- (b) A license may be issued only if an application is approved by the local governing body and the board, and the applicant does not hold a beverage dispensary license or a restaurant or eating place license.
- (c) A recreational site license must be based upon a competitive spectator sporting event with a designated sport season, and with a starting time and an ending time.
- (1) A competitive spectator sporting event includes baseball games, softball games, football games, soccer matches, dog sled races, hockey games, basketball games, curling matches, gymnastic meets, volleyball meets, car races, boating races, snow machine races, skiing races, and leagues or tournaments that includes golf, bowling, and billiards.

Subject: Policy on Recreational Site

Licenses

At the Board of Directors' meeting held in Anchorage, December 13-14, 2010 a discussion took place regarding recreational site licenses. Two separate applications were considered and approved at that meeting (The Summit, license #5004 and Beluga Billiards, license #5009). The recreational activities did not fit neatly under AS 04.11.210; however, the Board of Directors approved the licenses and requested that Assistant Attorney John Novak draft proposed changes to the statute.

Mr. Novak provided language for a proposed change that was considered by the Board at the meeting held in Juneau, March 24, 2011. After discussion by the members Mr. Novak offered his suggestions as policy as opposed to initiating a statute change. The members of the board agreed. The following is the policy by which we will consider recreational site license applications that includes the language of AS 04.11.210.

A recreational site license authorizes the licensee to sell beer and wine on licensed premises located on the recreational site. A license may be issued only if an application is approved by the local governing body and the board, and the applicant does not hold a beverage dispensary license or a restaurant or eating place license.

An event-based recreational site license will allow the licensee to sell beer and wine one hour before and one hour after an event. An event based recreational site license includes the following spectator sporting events, or other spectator sporting events having substantially similar characteristics - baseball games, softball games, football games, soccer matches, running events, skiing events, dog sled races, hockey games, basketball games, curling matches, gymnastic meets, volleyball meets, car racing events, and snow machine races.

An activity-based recreational site license will allow the licensee to sell beer and wine during times the recreational activity is taking place. An activity-based recreational site license includes the following recreational activities, or other recreational activities having substantially similar characteristics - baseball, softball, football, soccer, running, skiing, skating, dog sledding, curling, gymnastics, zip lines, volleyball, climbing, hiking, fitness activities, golf, bowling, billiards, hiking, rafting, and boating.

A recreational site license may not be issued if the licensed premise is within 200 feet of the property line for real property that is owned by, leased to, or rented to any public or private school, church, college, or university.

We have reviewed the attached regulations from the Alcoholic Beverage Control Board. I have reviewed this project under a specific delegation dated June 28, 2013 from the Regulations Attorney. A duplicate of this memorandum is being furnished to Shirley A. Coté, the director, along with a copy of the regulations.

The Department of Law has reviewed the attached regulations against the statutory standards of the Administrative Procedure Act. Based upon our review, we find no legal problems. This memorandum and the attached duplicate memorandum dated June 28, 2013 constitute the written statement of approval under AS 44.62.060(b) and (c) that authorizes your office to file the attached regulations.

The regulation changes were adopted by the Alcoholic Beverage Control Board after the close of the public comment period. The regulations establish requirements for a package store licensee that enters into a standing shipment order agreement with a purchaser for the periodic shipment of wine of the licensee's choice to the purchaser.

The certification order for the regulations states that this action is not expected to require an increased appropriation. Therefore, a fiscal note under AS 44.62.195 is not required.

We have made a few technical corrections to conform the regulations with the drafting manual under AS 44.62.060 and 44.62.125. The corrections are shown on the attached copy of the regulations.

RE: Municipal Refunds

#### Introduction:

During the legislative audit of 2009 the auditors pointed out on page 10 (copy attached) under 3. Licensing and Administrative Procedures, bullet seven that staff was not confirming and enforcing reports that should be filed by municipal law enforcement agencies prior to refunding municipal license fees. In 2010 the auditors returned and we discussed the issue of municipalities enforcing alcoholic beverage laws and at that time they seemed to accept my explanation that from my experience and contacts with police across the state for many years that part of the everyday function of the police included the enforcement of alcoholic beverage laws. This issue was not addressed in the follow-up report of September 28, 2010. However, I took steps to ensure this issue does not arise in the next audit of late 2014 or early 2015 (the ABC sunset is June 30, 2015).

#### Relevant statutes and regulations:

Alaska Statute Sec. 04.11.610. Refund to municipalities states the following:

- (a) Biennial license fees, excluding annual wholesale fees and biennial wholesale license fees, collected within a municipality shall be refunded semi-annually to the municipality.
- (b) If the officers of a municipality fail to actively enforce local ordinances, laws of the United States and the state, and the regulations relating to the manufacture and sale of alcoholic beverages in the state, the commissioner of commerce, community, and economic development may deny the refund provided for under (a) of this section until the board finds the enforcement of the ordinances, laws, and regulations is resumed.
- (c) The Department of Commerce, Community, and Economic Development shall recover any amounts erroneously refunded under (a) of this section. The



Department of Commerce, Community, and Economic Development shall schedule repayments of erroneously refunded amounts over a sufficient period of time to minimize financial hardship to the municipality involved.

#### Regulation 3 AAC 304.610. Refunds to municipalities states the following:

- (a) For the purposes of AS 04.11.610 a municipality's failure to actively enforce local ordinances, laws of the United States and the state, and the provisions of this chapter relating to the manufacture and sale of alcoholic beverages in the state includes the failure of the municipality's peace officers to comply with AS 04.21.070.
- (b) The director shall recommend that the commissioner of commerce, community, and economic development deny the refund of biennial license fees under AS 04.11.610 if the director determines that the municipality's peace officers have not provided the director with quarterly reports of violations of AS 04 occurring on licensed premises within the municipality.

Alaska Statute **Sec. 04.21.070. Enforcement** states the following: Peace officers shall investigate and report to the board violations of this title.

#### Actions taken:

I developed a simple report form (copy attached) for police departments to use to capture their quarterly statistics. Most of the departments use this form, or one fairly similar. I continue to accept e-mails and letters. Several departments report more frequently by sending their police reports as the violations occur. At the end of each quarter I send an e-mail reminder to the chiefs, or their designee.

In 2012 at the end of the first quarter six municipalities failed to report; second quarter – 10; third quarter – seven; fourth quarter – seven. Attached is an Excel spreadsheet containing the names of the 36 cities with and X to indicate a quarterly report has been submitted. It is not always the same municipalities failing to report consistently and at the end of the third quarter I called each police department personally that had no report filed and still seven did not report.

#### Questions:

- 1. During 2012 every municipality reported for at least one quarter. Biennial license fees are refunded semi-annually. Shall we divide the semi-annual fees by two and if the municipality reports for one quarter but not the other then should I request that the Commissioner withhold one half of the semi-annual fee?
- 2. Two communities with a high number of liquor licenses report no violations or even warnings in the last quarter of 2012. If a police department provides a quarterly report should that be interpreted that the laws are "actively enforced?"

- 2. <u>Licensing Revenues</u>. Licensing fee revenues recorded in the ABC Board's database does not agree with nor is reconciled to the same revenue as it is recorded in the State accounting system. The failure to reconcile has resulted in overpayments to municipalities and missed payments by licensees. Timely, complete, and accurate reconciliation between the two systems would likely resolve these problems and provide information for the board and director to take immediate action regarding noncompliant licensees.
- Licensing and Administrative Procedures. The ABC Board members and director are not
  providing appropriate guidance and oversight to staff to ensure compliance with state
  laws, and with its decisions.

The ABC Board does not consistently adhere to the statutory requirement of notifying the local governing body within ten days of receipt of an application per AS 04.11.520. This important requirement allows time for the local government to review and possibly protest the issuance, renewal, relocation or transfer of a license.

The ABC Board is also not enforcing the law requiring the return of caterers and special event permits within 48 hours. Other deficiencies in the ABC Board's licensing files, recordkeeping, database, and administrative processes include:

- No current written policy and procedures to give guidance in situations where licensees are involved in bankruptcy proceedings.
- Staff routinely failed to properly use existing checklists for verifying the completeness of licensing applications.
- Instances where staff had not submitted local government protests in a timely manner to the board for review and action.
- Significant occurrences of expired and/or unpaid licenses being incorrectly listed as active license holders.
- Failure to detect instances where required wholesale affidavits had not been filed by wholesale licensees.
- Municipalities being over or under paid for municipal license fee refunds.
- The ABC Board's staff is not confirming and enforcing reports that should be filed by municipal law enforcement agencies prior to refunding municipal license fees.
- The concerns of local governments that the ABC Board's policy and procedures do not include written notification to local governments regarding expired licenses.

The above activities show that the ABC Board may not be operating effectively and efficiently and is not achieving its potential in furthering the public interest.

4. <u>Enforcement Data Procedures.</u> The ABC Board's investigators inconsistently or inaccurately entered case record information into the Alaska Public Safety Information

Subject: Alcohol sales and manufacturing violations

#### Dear Alaska Chiefs of Police,

Some of you may know that in the past couple of years there was work in progress on reporting certain crimes to the State of Alaska. I don't know if or when that reporting will come to fruition; therefore, I am asking for your cooperation in reporting violations of local ordinances, federal and state laws and regulations relating to the manufacture and sale of alcoholic beverages in the state. During the last legislative audit of the ABC Board I was asked if police departments were reporting as required. Many were not reporting. Although the auditors accepted my answer that I knew the departments were enforcing these laws "because that is what they do" I believe we all have a responsibility to follow the statutes and regulations.

#### Alaska Statute Sec. 04.11.610. Refund to municipalities states the following:

- (a) Biennial license fees, excluding annual wholesale fees and biennial wholesale license fees, collected within a municipality shall be refunded semi-annually to the municipality.
- (b) If the officers of a municipality fail to actively enforce local ordinances, laws of the United States and the state, and the regulations relating to the manufacture and sale of alcoholic beverages in the state, the commissioner of public safety may deny the refund provided for under (a) of this section until the board finds the enforcement of the ordinances, laws, and regulations is resumed.
- (c) The Department of Public Safety shall recover any amounts erroneously refunded under (a) of this section. The Department of Public Safety shall schedule repayments of erroneously refunded amounts over a sufficient period of time to minimize financial hardship to the municipality involved.

Several of you do report to the ABC Board on a quarterly basis. A couple of you report daily or weekly. I am sending this email for expediency sake (I have a tendency to respond more quickly to an email than a formal written letter). It is not my desire to add more work to your load; however, it seems as though this law and its companion regulation have not been enforced over the years.

#### Regulation 13 AAC 104.610. Refunds to municipalities states the following:

- (a) For the purposes of AS 04.11.610 a municipality's failure to actively enforce local ordinances, laws of the United States and the state, and the provisions of this chapter relating to the manufacture and sale of alcoholic beverages in the state includes the failure of the municipality's peace officers to comply with AS 04.21.070.
- (b) The director shall recommend that the commissioner of revenue deny the refund of biennial license fees under AS 04.11.610 if the director determines that the municipality's peace officers have not provided the director with quarterly reports of violations of AS 04 occurring on licensed premises within the municipality.

Alaska Statute Sec. 04.21.070. Enforcement states the following:

Sec. 04.21.070. Enforcement.

Peace officers shall investigate and report to the board violations of this title.

I have cc'ed Gil Nelson, my administrative assistant who maintains the reports from police departments. In an effort not to create more work than is absolutely necessary, you may send an email during the first week of April (1<sup>st</sup> quarter), first week of July (2<sup>nd</sup> quarter), first week of October (3<sup>rd</sup> quarter), and first week of January (4<sup>th</sup> quarter) to Gil and me for our files, and for my review semi-annually when the refunds to municipalities are processed. I appreciate your cooperation and invite you to ask questions or give feedback in this process. Thank you.



Dear Chiefs and Chiefs' Delegates,

It is time to submit your second quarterly report for 2013. I have already heard from a number of you with the Soldotna Police Department being first in this quarter with Seward and Juneau being very close second and third, respectively. I appreciate the timeliness of all reports and to those departments who report more frequently when issues arise in connection with licensed premises.

We still have a few chiefs who are not reporting consistently for each quarter. We have others who consistently report no enforcement activity. As you know, municipalities have two statutory requirements and one regulatory requirement, 1) AS 04.21.070 states peace officers shall investigate and report to the board violations of this title, 2) AS 04.11.610 states that if officers fail to actively enforce alcoholic beverage laws, ordinances and regulations the municipal refund may be denied, and 3) 3 AAC 104.610 states the director shall recommend denial of the license fees if peace officers fail to provide quarterly reports of violations of AS 04 occurring on licensed premises within the municipality. Municipal refunds is a subject of discussion and decision-making for the board of directors at the next board meeting to be held in Fairbanks on July 23rd. The time of this discussion is yet to be determined; however, the agenda will be posted on our website at <a href="http://commerce.alaska.gov/dnn/abc/Home.aspxb">http://commerce.alaska.gov/dnn/abc/Home.aspxb</a> about one week prior to the meeting. If you have concerns I would encourage you to dial in to the meeting. The phone number will also be posted on our website.

The ABC Board has joined the Alaska Records Management System (ARMS) through the Department of Public Safety. As we have been invited and trained, police departments are being invited to join. This is excellent technology that allows for sharing valuable law enforcement information. The more departments that join the more information we can share in a less time-consuming and time-delayed manner. This should assist all of us in many ways and in particular between you and the ABC Board in this required reporting. Dear Chiefs and Chiefs' Delegates,

It is time to submit your second quarterly report for 2013. I have already heard from a number of you with the Soldotna Police Department being first in this quarter with Seward and Juneau being very close second and third, respectively. I appreciate the timeliness of all reports and to those departments who report more frequently when issues arise in connection with licensed premises.

We still have a few chiefs who are not reporting consistently for each quarter. We have others who consistently report no enforcement activity. As you know, municipalities have two statutory requirements and one regulatory requirement, 1) AS 04.21.070 states peace officers shall investigate and report to the board violations of this title, 2) AS 04.11.610 states that if officers fail to actively enforce alcoholic beverage laws, ordinances and regulations the municipal refund may be denied, and 3) 3 AAC 104.610 states the director shall recommend denial of the license fees if peace officers fail to provide quarterly reports of violations of AS 04 occurring on licensed premises within the municipality. Municipal refunds is a subject of discussion and decision-making for the board of directors at the next board meeting to be held in Fairbanks on July 23rd. The time of this discussion is yet to be determined; however, the agenda will be posted on our website at <a href="http://commerce.alaska.gov/dnn/abc/Home.aspxb">http://commerce.alaska.gov/dnn/abc/Home.aspxb</a> about one week prior to the meeting. If you have concerns I would encourage you to dial in to the meeting. The phone number will also be posted on our website.

The ABC Board has joined the Alaska Records Management System (ARMS) through the Department of Public Safety. As we have been invited and trained, police departments are being invited to join. This is excellent technology that allows for sharing valuable law enforcement information. The more departments that join the more information we can share in a less time-consuming and time-delayed manner. This should assist all of us in many ways and in particular between you and the ABC Board in this required reporting.
