



Director, ABC Board

ABC Board Stakeholders Group

The Stakeholders Group met on March 25, 2014. Of the 62 designated members invited 33 showed up at the Dena'ina Convention Center in Anchorage. We also had 17 other stakeholders and guests present to observe. We had 22 presenters amongst the five subcommittees in a show of cooperation for the materials discussed over the past 14 months. The results of the polling will go back to the subcommittees for consideration. The group is still on track for bill consideration of Title 4 revisions.

Legislation

During this legislative session I spent time writing fiscal notes and bill analyses and answered questions during hearings on the last four bills listed below:

HB140 Notice of Regulation Adoption: requires boards and commissions to submit board approved regulations to the Governor before transmittal to the Lt. Governor for filing. The Governor has 30 days before having to transmit to the Lt. Governor. It passed the Senate 16 to 4 and was sent back to the House with an amendment. On April 20, 2014 the House held the bill under unfinished business.

HB213 Golf Course Alcoholic Beverage Licenses: allows for service of spirits in addition to beer and wine; allows a person 16-21 of age or a person under the age of 16 accompanied by a person over 21, with the consent of a parent or guardian to enter for dining or golfing. On January 21, 2014 the bill was referred to House Labor & Commerce. On February 12, 1014 Rep. Millet joined as a co-sponsor and that was the last action.

HB309 Craft Distillery License: allows distilleries to sell to persons present one gallon for off-premise consumption; allows sales to licensees under Title 4 and in another state or country in any amount; requires warning signs and alcohol server education course. On April



11, 2014 the bill passed the House 30-4 with three excused absences and three absences. It passed the Senate on April 17, 2014 twenty to zero and is awaiting transmittal to the Governor.

HB336 Alcohol Sales Near School/Church: increases the distance between the boundary line of a school or church from 200 feet to 400 feet. On April 14, 2014 the bill passed the House 22 to 15 and was referred to Senate Labor & Commerce and Senate Finance. On April 16, 2014 the Senate Finance referral was removed.

HB357 Access to Licensed Premises: allows spouses of military personnel to purchase alcoholic beverages at a club; allows access of under 21 persons if the person is a guest of a member of the club, or the spouse accompanying a guest and the guest possesses a valid active duty military or armed forces identification card. On April 11, 2014 the bill passed the House with 36 yeas, two excused absences and two absences. On April 16, 2014 the bill was moved out of Senate Labor and Commerce and moved to Senate Rules.

Legislative Audit

Three of the auditors worked out of our conference room during the week of March 24th and spent a little time at the Stakeholders Group meeting. As expected, they have many questions that staff and I are available to answer as expeditiously as possible. One issue brought to my attention was corrected with the termination of our agreement with the Alaska Marine Highway System as the ABC Board has no authority to waive fees (in exchange for travel for investigators). The agreement was made a decade or longer ago, with a renewal upon my appointment in 2009.

Licensing Unit

The most significant event to report for the Licensing Unit is that Records & Licensing Supervisor Christine Lambert is leaving us. Her last day is May 16th, making this her last board meeting. Chris has done a phenomenal job in her position. Fortunately for us, and to her credit, she has maintained an open line of communication with the business registration examiners and all others within and outside the agency. Chris has always ensured that everyone in the agency has access to the same information she and her staff have created in the database. Chris also ensured that crucial data was maintained on the shared computer drive. She put in place written procedures and updated and created forms that made processes easier to follow and provide assurances the proper steps were completed. Chris will be a huge loss to our agency.

Inv. IV Bob Beasley is the hiring manager for our agency and he has gone through the extremely complicated and time-consuming process of posting this position.



Enforcement Unit

On March 31, 2014 Investigator Beasley was the guest speaker at the annual NACE (National Association for Catering and Events) Convention in Anchorage. He did a presentation on Title 4 regarding caterer's permits, special events permits and restaurant caterer's permits.

Investigator Joe Bankowski began employment with the ABC Board on April 10th, and started his Field Training with Investigator Steve Johnson in Juneau for one week before his arrival date in Anchorage on April 21st.

Investigators assisted troopers in Bethel regarding their investigation of two establishments that were allowing patrons to bring in their own alcohol in violation of AS 04.16.090 for operating a bottle club.

The new Written Order Database under DCCED went live on March 19, 2014 and is up and running well. That was the last system to be transferred. We have received excellent technical support which includes the updates in our website. Our licensing information is now available on our website under license search.

Inspections

Investigator Johnson in Juneau has conducted 171 premises inspections so far this fiscal year. Investigator Finney in Fairbanks has conducted 131 premises inspections so far this fiscal year. The Anchorage investigator position has been vacant since November 2013 but inspections will begin again at the end of April.

As of March 31st, 787premises have had compliance checks. With one quarter left in the fiscal year the industry is running an 89.6 percent success rate, down .2 percent from the last reporting of January 22nd. The most significant change came with the Kenai Peninsula Borough who had a success rate of 97.8 percent with 46 checks and 45 passes to a decrease to



87.8 percent with 115 checks completed and 101 passes. The checks have taken place in seven of the eight regions.

Marijuana Initiative

A joint Senate and House of Representatives met on Saturday, March 29th to provide a briefing from departments affected along with testimony from the public. Administrative Director Jeanne Mungle and I presented on behalf of DCCED. Director Mungle presented on the cost of implementation for our department and I presented on the need for regulations. Special Assistant to the Commissioner's Office, Leslye Langla is the point person for our department.

In 2013 The Chickaloon Trading Post located at 172S Lamont Circle, Unit C transferred their license to Liquor Stores USA North, Inc., d/b/a Brown Jug. This area located outside the Wasilla city limits was according to City Planner, Tina Crawford unpopulated. In 2014 the area was annexed by the City of Wasilla. On March 17, 2014 we received an application from Brown Jug for a transfer to 509 Parks Highway, a more heavily traveled and populated area of Wasilla.

As the city is allowed one transfer per decade, and that transfer has been effected for this decade the City of Wasilla was concerned enough to call us for advice in the transfer of this license. The City does not protest the license.

I conferred with Assistant Attorney General Harriet Milks who advised she knew of no statutes that prohibited such an action. This puts the number of licenses one more over the population limit. By population, Wasilla at 8,207 is permitted three package store licenses. This license transfer would increase the current number to seven.

On April 7, 2014 I received a call from Don Horrell, the licensee for the Tazlina Liquor, a package store, License #1122 that he was concerned that a license, Brown Bear Liquor, License #4100, also a package store had been transferred within the 5-mile radius of another package store license, Basin Liquor, License #96 owned by Bonnie Wilson. I assigned the case for investigation to Inv. Finney (copy of his report attached).

Evidently, it was known there was a 5-mile radius issue in 2001 when the original license was issued. On February 14, 2001, after an informal conference the board voted to approve the license. Discussions ensued after the approval and the board meeting so the item was placed back on the agenda for the May 2001 board meeting. The Board voted not to reconsider and the approval stood.

Up until a recent transfer of the license the licensee renewed every biennial period. However, now we learn there was no indication of operation – not until the new licensee opened for business. Bonnie Wilson and Don Horrell would like to appeal the approval of the transfer of the license that was approved at the May 30, 2013 board meeting.

INFORMATION:

In response to the initial denial of the transfer of licenses #4100, an informal conference was held in Juneau._ On February 14th, 2001 the transfer of package store license# 4100, known as Cub Spirits and Party Store, was approved by a vote of 3 to 0 after legal and factual arguments.

ABC Board Chairman Klein stated that council for the Board and council for the licensees were in agreement that this decision was in the discretion of the Board. At this informal conference were the ABC Board, staff, and counsel. Counsel for Don and Cindy Rhodes was Dan Coffey, and the Board was represented by Assistant Attorney General, Linda Kesterson. After this approval, the ABC's Staff and counsel asked for reconsideration.

On May 18th, 2001 a letter was sent to licensees, Doug and Cindy Rhodes from Director Douglas B. Griffin stating that after considering additional public input and advice from the Board's legal counsel, the decision was made not to reconsider the approval of the transfer granted at the February 14th, 2001 meeting. Therefore the transfer is approved.

On May 8th, 2013 license years 2013/2014, liquor license #4100 for Brown Bear Liquor was issued a temporary license. However, this license was not open for business until April 11, 2014.

During this investigation the question was raised, "Did this license operate the minimum required for 2013?" Since the license was a seasonal license May 1 to October 31, and changed to a full time license on October 29, 2013.

Ellen Tubbs received a temporary license on May 8, 2013, but did not operate until April 11, 2014. It is apparent by those dates that license#4100 could not have operated the minimum amount of hours required in 2013. Further, I can find no evidence that this license, while belonging to Doug and Cindy Rhodes, although was renewed and fees paid, ever operated.

INTERVIEW - BONNIE WILSON, BASIN LIQUOR #96:

Bonnie Wilson, owner of Basin Liquor, license #96, was surprised to learn that the license had been issued in 2001. She stated she was under the impression that the license had been denied and never issued. She further stated she thought the license at Brown Bear liquor was a new license. Ms. Wilson lives close to the Brown Bear, and stated she has never seen any sign of a liquor license. Nor has anybody in the community including locals, Alaska State Troopers, venders.

INFORMATION:

Investigator Hamilton was surprised as well that there was a package store license at that location, since during his compliance checks, he found no other license at that location. I conducted an inspection of the Brown Bear Roadhouse in 2011, and was unaware there was a package store license at that location.

The response I received from Odom was that no alcohol was sold to that license number from 2001 to the time of the transfer.

K & L Distributors stated that an account for Cub Spirits & Party Store licenses #4100 that was opened on August 3, 2001 and the only activity on this account has been from May 13, 2011 through October 31, 2011.

INTERVIEW - CINDY RHODES, FORMER OWNER CUB SPIRITS AND PARTY STORE #4100:

On April 17, 2014 I spoke to Cindy Rhodes on the telephone. She stated that they did not operate the package store much, as it was just her and her husband there to run things, and that the package store was located in the same small building. There was no signage, hours of operation or cash register for the package store sales, nor was there any heat or electricity. Sales were rung up inside the Bar.

INFORMATION:

On April 17, 2014, I contacted Bonnie Wilson from Basin Liquor, and Don Horrell, owner of Tazlina Liquor, license #1122 regarding their concerns about Brown Bear Liquor. Both Bonnie Wilson and Don Horrell stated they desire to protest the issuance and transfer of license #4100 to Brown Bear Liquor.

INTRODUCTION

The purpose of this Memo is to outline the issues associated with the request by the staff for the Board to reconsider its approval of the application for transfer of location and ownership of this package license which occurred after an informal conference in February in Juneau. At that time, after presentations by both counsel for the Board and counsel for the Rhodes and after hearing from another licensee in the area, the Board approved the relocation of this package license. The issue now before the Board is whether or not to reconsider its prior decision to approve the transfer of location. Then, if reconsideration is granted, the next question is whether the Board should reverse its prior position.

PRIOR INFORMAL CONFERENCE

In response to the initial denial of this location transfer, an informal conference was held with the ABC Board, staff, and counsel on February 14, 2001 in Juneau. At the informal conference, the ABC Board heard factual arguments concerning the reasons for and against relocation and also legal arguments pertaining to limitations that exist in state statutes applicable to the siting of liquor licenses in unorganized areas. Both Linda Kesterson, attorney for the Board, and Dan Coffey, attorney for the Rhodes, agreed that the ABC Board had the discretion, under the law, to make this decision. Coffey argued that the facts of the matter supported the relocation and the other licensee in the area stated facts in opposition to the relocation.

After the legal and factual arguments, Board Chairman Klein stated, "... and to summarize what we've heard from Ms. Kesterson and Mr. Coffey, they appear to be in vehement agreement that this is one which is strictly up to us as to how we perceive this transfer." (See transcript page 14, Line 20).

The Board then decided to reconsider its earlier denial of the transfer of location. Upon reconsideration, the Board voted 3 to 0 to approve the transfer of location. The factual basis for the approval is stated by various Board members during their deliberations and is not repeated here. However, its is the Rhodes' position that the factual basis for the decision is sound and should be upheld on the merits. The question here is not whether there is a solid basis in fact for the Board's decision (there clearly is), but whether, based upon a conflict of laws, there should be a reconsideration of this matter.

Since the initial informal conference, the ABC Board's staff and legal counsel expressed concern about the Board's approval of this transfer of location based upon the provision of AS 04.11.340(3). They have asked for a reconsideration by the Board to resolve the issue raised in the Executive Director's letter to the Licensee dated March 5, 2001. While agreeing with the staff that there are two (2) conflicting statutes, the Rhodes oppose reconsideration of a decision which was clearly justified on the merits.

CONFLICT OF LAW

Essentially, there are two conflicting statutes which deal specifically with relocation of licenses. On one hand, AS 04.11.400(a)(1), provides that "... the board may prohibit relocation of an existing license (1) outside an established village, incorporated city, unified municipality, or organized borough if after the issuance or relocation there would be ... (B) more than one license of each other type,..., in a radius of five miles of the licensed premises...".

This statute gives the Board discretion which was the subject of the "vehement agreement" between counsel at the informal conference. What this provision states is that, even if there are population limitations, the Board may grant a relocation.

On the other hand, AS 04.11.340 provides, that "an application requesting approval for the relocation of licensed premises **shall be denied** if...(3) the license would be relocated out of the established village, incorporated city, unified municipality, or population area established under AS 04.11.400(a) within which it is located."

This statutes directs the Board to deny a relocation if the license is being relocated outside of the population area established under AS 04.11.400, the same statute which gives the Board discretion to act even if there are population limitations.

The first statute clearly provides that the Board has discretion to approve the relocation regardless of the population limitation. The second statute clearly requires the Board to deny a request for relocation. The general rule of statutory interpretation requires that meaning be given to both statutes, if at all possible. Here, however, there is no clear way to resolve these conflicting statutes and give meaning to both statutes. Thus, resolution of this statutory conflict by the ABC Board is impossible.

PROPOSED RESOLUTION

Given the following:

- 1) that there can be no resolution of this conflict at the Board level (or, for that matter, at the administrative hearing officer level); and
- 2) that the Board approved this transfer of location at the informal conference held in February based on the argument that AS 04.11.400(a) gives the Board the discretion to permit such a transfer; and
- 3) that the facts on which the Board made its early decision are sound and fully support the decision;

the Board should allow its February decision to stand.

NO ADMINISTRATIVE REMEDY AT THE HEARING OFFICER LEVEL

If the Board does not believe that the February decision should stand, there is no reason to require an administrative hearing on this matter. The conflict between AS 04.11.400 and AS 04.11.340 in their respective grant of authority on one hand, and prohibition of discretion on the other, makes this an issue for the court, not for an administrative hearing. Like the Board, an administrative hearing officer could only recognize the conflict. He or she could not resolve it. Therefore, to require an administrative hearing would be a total waste of time and money.

CONCLUSION

In conclusion, any challenge to a Board decision to either allow or disallow this transfer of location, should be heard in Superior Court. Since the factual basis for the decision is sound, the Board should be uphold its earlier decision and allow this transfer to be completed. Let anyone who is opposed to the approval make the challenge. In such event, the Rhodes will, undoubtedly, be a party to the proceeding and would, in fact, bear the burden of litigation. To reconsider and to then deny the transfer might result in litigation which would not otherwise occur.

My concerns are that I have and always have complied with the rules and regulations of the ABC Board and I do not understand how this license was obtained. I followed all the requirements and regulations in obtaining my liquor license. I posted, did my signatures of my area, had my establishment approved after inspection of my facilities, and all other requirements that the ABC Board required. At the time of receiving my license the law was (because of population) that all license had to be five (5) miles apart. I have just become aware that there is a problem with this rule.

There has never been an operating packaged liquor store at this establishment. There was at no time a separate building for the packaged liquor store operating and I have lived in Glennallen since May of 1971 and I know there was never a package store at this address.

I do not care if some one applies for a license as long as they follow all the rules and regulations that one must do to obtain a license, when this does not happen it is unfair to the rest of us who did obtain their license legally. This to me makes the ABC Board unfairly enforcing the laws and regulations of all licensees.

I am the past owner of Copper Basin Distributors Inc. of which I operated for 38 years in the Copper Basin area, including Tok, Valdez, Paxson and all areas in between. I personally along with my past employees made deliveries to the Brown Bear Rhodehouse each week. Delivering Pepsi, Frito Lay, Wonder products, full line of grocery items and was the agent for Lyden Transport I did deliver to the Brown Bear Bar and at no time did I deliver product to a package liquor store at this establishment.

For many years my wife and I would dine on Friday night there and I would have lunch once or twice a week with friends from Glennallen. I was at that establishment many times over the years and never witnessed a package store being open on this property I was surprised to learn that Cindy and Doug Rhodes (the past owners of Brown Bear) had been able to obtain a package liquor license, as the rule was no license could be with in five miles of another package license. Mrs. Wilson who owns Basin Liquors is no more than a mile from Brown Bear. I along with Mrs. Wilson had thought the license was never issued. I have just learned that the license was first issued in 2001 and then transferred last October and as I do read the local paper and I never saw the transfer, nor did I see a posting at the post office. I do realize that I could have missed both postings.

My understanding of the law is the license must operate thirty (30) days a year for at least eight hours (8) a day. I hope that this license is looked at closely as I know this not to be true. This license transfer is unfair to the rest of us who have always followed the rules and regulations of the ABC Board. This is especially unfair to Mrs. Wilson who has owned and operated Basin Liquor that is a short distance away.

The ABC Board can easily go to Copper Valley Electric, Copper Valley Telecom, and the Alaska State Troopers who would be able to establish if any services provided to the building stated as the package liquor store. There is still no electric meter on that building as of this date.

Joseph Bankowski will start in his position as an ABC Board Investigator III on April 10, 2014. Inv. Bankowski possesses a basic certificate through the Alaska Police Standards Council. From 2011 up until he accepted a position with us he served as a Juneau police officer. For four months prior to being hired by the City of Juneau Inv. Bankowski was a Children's Services Specialist and before that a Facility Supervisor with Juneau Youth Services for about a year and a half. Inv. Bankowski holds a Bachelor's Degree in Criminology.

Alaska Administrative Code 3 AAC 304.505(b) states, "Consistent with federal, state, and local law, the board's investigative personnel may carry firearms in the performance of their duties, if individually authorized by the board. In the same code, (a)(6) states, "the board's investigative personnel may exercise specified peace officer powers upon the written concurrence of the commissioner of public safety filed with the lieutenant governor and the director, but only if necessary for the enforcement of the criminally punishable provisions of AS 04 and regulations adopted under AS 04."

Inv. Bankowski will be involved in the compliance check and shoulder tap operations in addition to other investigations of violations relating to Title 4. I request your approval to arm Inv. Bankowski so that I may seek the concurrence of the commissioner and follow the procedures set forth in regulation and department policy. I have attached a copy of Commissioner Folger's letter that was updated from Commissioner Master's letter of June 3, 2009 giving concurrence to the concept in general.

MEMORANDUM OF AGREEMENT BETWEEN THE ALCOHOLIC BEVERAGE CONTROL BOARD AND THE DEPARTMENT OF PUBLIC SAFETY

In accord with Alaska Statute 04.06.110 the director and the persons employed by the Alcoholic Beverage Control Board may, with the concurrence of the Commissioner of the Department of Public Safety, exercise the powers of peace officers when those powers are specifically granted by the Board.

Upon hiring an investigator the Director will make a recommendation to the Board to grant the powers of peace officers to the Investigator. Once those powers are specifically granted by the Board, the Director will seek concurrence from the Commissioner of Public Safety by submitting a Special Police Commission Application to the Commissioner's Office. Special Commission applicants who request to carry firearms will need to adhere to the Alcoholic Beverage Control Board's Firearms Policy which must require special commission applicants to meet the Alaska Police Standards Council's minimum criteria for certification.

The Commissioner of the Department of Public Safety will renew concurrence of each investigator in possession of a special commission on a bi-annual basis as special commissions are valid for two years. New applications for a special commission will be reviewed by the Department of Public Safety Special Commission Committee during their monthly meeting.

Dear Chairman Klein:

I write to memorialize in a single document my concurrence as Commissioner of the Alaska Department of Public Safety regarding the enforcement activities and investigative efforts authorized to be undertaken by investigators of the Alcoholic Beverage Control Board.

Alaska Statues 11.81.900(b)(44) defines "peace officer" as "a public servant vested by law with a duty to maintain public order or to make arrests, whether the duty extends to all offenses or is limited to a specific class of offense or offenders." Alaska Statutes 04.06.110 authorizes the ABC Board to allow its investigators to enforce the criminally punishable provisions of Title 4 of the Alaska Statutes as well as the Alaska criminal laws prohibiting prostitution and gambling. Under the same statute, however, the Commissioner of the Department of Public Safety must "concur" in that decision of the ABC Board before the investigators are authorized to exercise those powers.

The ABC Board, through its Director, has authorized ABC investigators, pursuant to 13 AAC 104.505, to inspect premises licensed to sell alcohol, investigate licensees, applicants, transferees and other persons with respect to applications, investigate the possession and sale of alcoholic beverages, or licensed premises, issue notices of violation, seize alcohol subject to forfeiture, serve subpoenas for board adjudicative proceedings, execute search warrants, and take such other action as is considered necessary by the Director provided all of those efforts relate to compliance with or violation of Title 4 of the Alaska Statutes and regulations promulgated to fully enact those statutes. The ABC Board, through its Director, additionally has authorized ABC investigators to engage in undercover investigative efforts that involve the use of persons under the age of 21 years to determine if persons that are under the age to legally consume or possess alcohol. These investigative efforts are known as "compliance checks" and "shoulder taps". I hereby concur in the decision of the ABC board to authorize its investigators to engage in these activities provided they are conducted in accord with all applicable policies and/or directives of the ABC Board and its Director.

The ABC Board generally has authorized ABC investigators who meet the firearm related qualifications and successfully complete the firearm training and proficiency requirements set forth in ABC policies and procedures as well as the Department of Public Safety Operating Procedures Manual to possess firearms, whether loaded or unloaded, in performance of the authorized activities and investigative efforts described in the above paragraph. I hereby concur in the decision of the ABC Board to generally authorize ABC investigators to possess firearms, whether loaded or unloaded, in performance of the authorized activities and investigative efforts described in the above paragraph provided the firearm possession is in accord with all applicable policies and/or directives of the ABC Board and its Director, that must include meeting the qualifications and successfully completing the firearms training and proficiency requirements set forth in the Department of Public Safety Operating Procedures Manual. Additionally, each individual authorized by the Board possess firearms will require concurrence of the DPS Commissioner or Designee.

Alaska Administrative Code 13 AAC 105.505(b) must be complied with before individual investigators are authorized to possess firearms in performance of authorized activities and investigative efforts. That regulation allows ABC investigators to possess firearms in performance of authorized activities and investigative efforts provided doing so does not violate a federal, state, or local law and the ABC Board specifically authorizes individual investigators to do so. The regulation additionally requires that the Commissioner of Public Safety concur in an individual authorization before an ABC investigator may possess a firearm in performance of authorized activities and investigative efforts.

At this present time, the ABC Board has not authorized any ABC investigators to possess firearms in performance of authorized activities and investigative efforts. It is my expectation that the ABC Board Director will propose for ABC Board consideration the granting of such authorization only for investigators who meet firearm related qualifications and successfully complete the firearm training and proficiency requirements set forth in ABC policies and procedures as well as the Department of Public Safety Operating Procedure Manual. I will carefully consider in the future whether or not to concur in a decision of the ABC Board to authorize and individual investigator to possess firearms in performance of authorized activities and investigative efforts.

This letter supersedes the letter dated June 3, 2009, from previous Commissioner Joseph A. Masters.

Mr. Russell provided additional information at the July 24, 2013 board meeting; however, you denied this duplicate license as the room was in a separate building from the parent license. Mr. Russell would like the board to reconsider your decision of July 24, 2013 as his option #1. He has also presented two other options for your consideration, 2) connect the main building with a covered breezeway, and 3) remodel the facility to connect the two buildings with more than a deck.

Chairman Klein & ABC Board Members:

First, I would like to express my appreciation to Director Cote and her staff. As I have worked through my issue Director Cote and her staff have been available to answer questions, provide direction, and have shown a genuine desire to help me come to a solution that meets my needs as a business owner as well as adheres to the law and is in keeping with the direction given them by the ABC Board.

In late 2012 George Inlet Development, LLC finalized the purchase of George Inlet Lodge from Sun Dogs, Inc. As part of that purchase, we applied for a transfer of the liquor license held by Sun Dogs, Inc. to George Inlet Development, LLC. This transfer was considered and approved at your February 12, 2013 meeting. Because we were required to submit facility drawings as part of the liquor license transfer, the ABC Staff called us to get further clarification on how we were operating. Their questions led them to note we were likely out of compliance with the regulations because our three private dining rooms had fixed bars that our current license did not cover.

Once we were alerted to the problem we immediately applied for duplicate licenses to cover the three private dining rooms. On May 30, 2013 the ABC Board voted to approve duplicate licenses for Private Dining Room #1 & Private Dining Room #2-3, but asked that the motion for the duplicate license for Private Dining Room #4 come back before the Board at its July 24th meeting.

During the July 24, 2013 meeting the ABC Board expressed concern that Private Dining Room #4 (PDR 4) was not on the same piece of property as the rest of the facility and was in a building that was not physically connected to the rest of the facility. After a motion to approve the duplicate license failed to receive a second, the motion was voted down 4-0.

The discussion between the board identified some discrepancies regarding how these types of situations have been handled in the past. Two instances that were pointed out included the liquor license for the Alyeska Resort, which had been issued duplicate licenses for buildings that were miles apart from one another, and a hotel and restaurant separated by a parking lot in Fairbanks where the proprietor was required to have separate licenses for both the hotel bar and the restaurant.

These conflicting situations, and only a few minutes of discussion during the ABC Board meeting, left me with unclear direction on how to move forward to solve the problem of needing a duplicate license for PDR 4. Director Cote suggested I come to the Board during this meeting, ask for some time to discuss this issue with the Board, and receive further direction on what solutions might be agreeable. Following this informal discussion we would bring a formal proposal to a future board meeting for official action.

I have attached a list of proposed solutions in order of our preference. My hope is that I will have an opportunity during your April 29th Board Meeting to discuss these options and get some direction as to a solution you believe will ultimately be agreeable to the Board.

I appreciate your consideration in this matter.

The Following Options Were Considered As Possible Solutions But Were Deemed Untenable:

Combining the two lots so all of the buildings would be on one piece of property.

This was considered as a solution to address some of the concerns expressed by the Board during it July meeting. Although it would not solve the problem of the buildings being physically separated from one another, it would solve the issue of them being on separate lots. PDR 4 sits on lot 2. The main lodge and the rest of the PDRs all sit within the tidelands property leased from the State of Alaska. Because the tidelands are leased, it would be impossible for us to combine the two pieces of property.

Treating PDR 4 as a stand-alone restaurant and applying for its own liquor license.

Since the Board decided PDR 4 did not qualify for a duplicate license, we then surmised that PDR 4 might then qualify as its own restaurant. Following that logic, we discussed with ABC Director Cote the possibility of applying for a separate license for PDR 4 as a stand-alone location. However, upon further discussion, we were told PDR 4 would not qualify as a stand-alone restaurant because it did not have its own kitchen.

For these reasons we are asking the ABC Board to consider the following options:

Option 1:

Have the duplicate license for PDR 4 brought back before the Board for reconsideration.

When I presented to the Board in July of 2013 I was not aware of the issues that were going to be addressed by the Board. Now that I am aware of those issues I feel like I can more adequately address the concerns expressed in July.

George Inlet Lodge is located 12 miles from downtown Ketchikan on the south end of town. We are 2.5 miles from the nearest residence (located back towards Ketchikan) and 1 mile from the Beaver Falls power plant and the George Inlet Cannery. Guests come to George Inlet Lodge as part of one of three organized tours provided by our company. They are assigned to their dining room based on the tour type, group size, and available staffing. Guests do not have the ability to choose where they would like to eat but are subject to assignment by company staff. The main dining room, PDR 1, PDR 2-3, and PDR 4 are all served from the kitchen located adjacent to the main dining room. PDR 4 does not have its own kitchen facility. Dishes from all PDRs, including PDR 4, are washed in one central location. Food is

stored, prepped, cooked and served to all PDRs, including PDR 4, from one location. The distance from the kitchen door to the door of PDR 4 is 40' along the wood deck that connects the two buildings.

Most of the lodge facility is located on tidelands leased from the State of Alaska and managed by the Ketchikan Gateway Borough. Lot 2, where PDR 4 is located, would have no value to the company without the rest of the facility located on the tidelands, as its size would not allow for any meaningful business enterprise to take place there on its own. The Ketchikan Gateway Borough has issued one address for the entire facility, 11728 South Tongass Highway. One driveway services the both the tideland lot and lot 2. Water is provided to the entire facility through one distribution point. All of the facility is hooked into one septic and waste water discharge system. Other permits for the facility including drinking water, wastewater, DEC Food Establishment permits, etc.. are issued for all buildings located at this address. For all intents and purposes, all other agencies and jurisdictions treat George Inlet Lodge as one piece of property and one facility.

In addition, there was no opposition to our application. In my opinion, this was based on a number of factors including our distance from any other land owner, our distance from town, historical use of the property, the fact that we are a well-established local business providing jobs and generating tax revenues, and the fact that we had no violations under the liquor license.

This is our preferred option as it would be the least disruptive to tour operations, could be handled expeditiously, and would not require major facility renovations.

Option 2:

Connect PDR 4 to the main building with a covered breezeway.

This option may address the Board's concern of the buildings being physically separated as it would connect the roofs of the two buildings and provide another physical connection between the two other than just the deck. This option would be more costly than a reconsideration of the duplicate license but less costly and time consuming than option 3. This option would also be less intrusive as we tried to maintain some of the look and feel of the historic cannery building.

Option 3:

Remodel the facility to physically connect the two buildings with more than just the deck.

This option would address the Board's stated concern of the building being physically separated but it would still not address the concern raised over the two buildings being on separate pieces of property. Our proposal would be to enclose deck area separating the main lodge and PDR 4, making it one large physical facility. This solution would allow us to expand our current gift shop space but would be a costly and time consuming project. However, our current gift shop is small but highly profitable. We maintain a large selection but don't carry a significant inventory. The small size allows the gift shop to

be managed by one person, makes taking inventory efficient, and allows for quick reordering when inventory starts to run low. This expansion would more than quadruple our current gift shop space, requiring us to maintain a more costly inventory, require additional staffing to run and maintain, and limit our ability to protect from inventory loss when compared to our current model. While the potential for increased profits is a possibility, bigger is not always better.

In addition, George Inlet Lodge is an historic building. The main lodge was an old cannery building that was salvaged and floated over 70 miles to its current location. Care would need to be taken to maintain the historical integrity of the building's look and feel.

The cost, the time, and the dramatic change to the gift shop operation, among other considerations, make option number three the least desirable of all three.

The Breeze Inn in Seward and the Shelifof Lodge in Kodiak are owned by the same licensee, Juris Mindenbergs. In February 2014 Mr. Mindenbergs came to the ABC Board office and said he had not received the renewal application, and not until he received the reminder letter in January did he realize he needed to renew the two licenses. The renewal application was mailed to the same address as the reminder sent in January and it was not returned as undeliverable.

In accord with AS 04.11.270(b)(1) the director shall mail a renewal application to each licensee before November 1st stating that unless renewed the license will expire on December 31st. This application shall be mailed to the licensee at the licensed premises or to an address furnished by the licensee. The licensee is required to submit the application and the fee prior to January 1st. If not date stamped by December 31st, a \$500 penalty fee is attached.

Records & Licensing Supervisor Christine Lambert took the usual extra step in the requirement and in October sent an email to all licensees who were up for renewal, as long as the licensees provided an email address on the prior application. No email address was provided for The Breeze Inn. One was provided for the Shelikof Lodge, however, we failed to enter it into our database.

At the board meeting of May 30, 2013 Assistant Attorney General Harriet Milks advised the waiver of late fees are not allowed for in statute; however, I maintain that if it is clearly the fault of board staff that the board should consider a refund. I have no evidence that we did not fulfill our responsibilities in giving notice as required. We did fail to enter the one email address for the Shelikof Lodge.

Attached are copies of the letters of renewal sent along with the second warning letter that the license is about to expire. Mr. Mindenbergs's email of appeal is also attached for your consideration.



RE: Regulation proposal for license not required

Over the past couple of weeks we have been dealing with a situation in Bethel. As some of you will remember, about four years ago Bethel removed their local option but enacted an ordinance that prohibited sales. Six establishments applied for liquor licenses and the board denied the licenses on the grounds that the city was not arbitrary, capricious, and unreasonable in their protest. I received an anonymous call asking if a restaurant could allow patrons to bring their own alcoholic beverages into the restaurant. I advised they could not and a call to Inv. Beasley followed with the specifics in Bethel. The owners of the restaurant in question were contacted and advised to cease the practice. During that conversation, it came to light that the VFW was doing the same thing. We began working with the state troopers in an attempt to rectify the situation with the VFW.

What we discovered, and in conference with Assistant Attorney General Harriet Milks she confirmed that we have two statutes that are in conflict with each other. Under AS 04.11.020 it seems as though the practice is permitted - a license is not required if equal contributions (their own alcohol) are made; it is a private gathering; and no profits are made by the house. However, under AS 04.16.090, prohibition of bottle clubs a person may not maintain a place where alcoholic beverages are brought for consumption by members of a club unless licensed by the ABC Board. I have included the specific language of each statute below:

Sec. 04.11.020. Exceptions: License or permit not required.

- (a) A license or permit is not required to authorize sales made by a person under a judgment and decree of foreclosure, under the bankruptcy law of the United States, or under order of the board or a court under AS 04.16.220.
- (b) A license or permit is not required to serve alcoholic beverages in exchange for valuable contributions at a private gathering of a bona fide group of co-workers or of a professional, social, or fraternal organization if equal contributions are made by all in attendance and only the amount required to purchase the alcoholic beverages is contributed. All other applicable provisions of this title and regulations under this title shall be observed at these private gatherings.



Sec. 04.16.090. Prohibition of bottle clubs.

- (a) A person may not maintain a place in which alcohol beverages are received or kept, or to which alcoholic beverages are brought, for consumption by members of the public or by members of a club, corporation, or association, unless the person is authorized to do so under this title.
- (b) A person may not maintain, operate, or lease premises for the purpose of providing, for a consideration, a place for drinking alcoholic beverages by members of the public or other persons, unless the person is authorized to do so under this title.
- (c) For the purposes of this section, "consideration" includes but is not limited to cover charge, the sale of food, ice, mixers, or other liquids used with alcoholic beverage drinks, or the furnishing of glassware or other containers for use in the consumption of alcoholic beverages.

In our attempt to work with the VFW, the Alaska State Troopers, and Representative Bob Herron I recommend a new regulation for a clarification of AS 04.16.090 with language such as, "A patriotic organization who otherwise meets the requirements of AS 04.11.110(b) shall be exempt from the prohibitions described in (a) of this title if located within an area, other than a local option area under AS 04.11.491, where no liquor licenses exist."

The first proposal is to clarify names on licensed premises. The second and third proposals are necessary clean-up of the particular regulations and the fourth is a new subsection that would allow investigators to assist licensees and their agents or employees who live in remote areas who may not have the same access to alcohol server education courses as those in or near the larger populated areas.

1. 3 AAC 304.185(a). Licensed premises

From time to time investigators conducting compliance checks or inspections observe that the doing business as (d/b/a) name and the name displayed on the business do not match. Under 3 AAC 304.185(a) it states, "The address of the licensed premises and the business name under which the licensee is doing business at that address must be indicated on the license application."

Over the years a reasonable interpretation has been that the name on the license and the name on the establishment should match. However, in consultation with Assistant Attorney General Harriet Milks her interpretation is that the business name must be on the application; however, there is no requirement that the name on the establishment must be the same as on the application. That leads to frequent enough difficulty while doing field work that I propose additional verbiage:

"The address of the licensed premises and the business name under which the licensee is doing business at that address must be indicated on the license application and the same name at or near the entrance of the business."

2. 3 AAC 304.025(c). Tie-breaking vote



The second sentence under (c) should be removed to align with the change in AS 04.06.060 that allowed for the director to cast a tie-breaking vote during board meetings.

3. 3 AAC 304.125(c). Director - his or her

If the director considers it necessary to provide adequate public notice, or if the director is requested to do so by a local governing body or village counsel, the director will, in his <u>or her</u> discretion,......

4. 3AAC 304.505 – add (8) for recertifying alcohol server education course

See attached memorandum from Inv. Bob Beasley explaining this recommendation:

- 3 AAC 304.505. Powers of investigative personnel. (a) The board's investigative personnel may
- (1) conduct inspections of licensed premises and investigations of licensees, applicants, transferees and other personnel with respect to applications, the possession and sale of alcoholic beverages, or licensed premises;
 - (2) issue notices of violation;
 - (3) seize alcoholic beverages which are subject to forfeiture under AS 04.16.220;
 - (4) serve subpoenas issued by a hearing officer in a board adjudicative proceeding;
 - (5) execute search warrants;
- (6) exercise specified peace officer posers upon the written concurrence of the commissioner of public safety filed with the lieutenant governor and the director, but only in necessary for the enforcement of the criminally punishable provisions of AS 04 and regulations adopted under AS 04;
- (7) take such actions as is considered necessary by the director to assure the enforcement of AS 04 and is not in conflict with a law or regulation.
- (b) Consistent with federal, state, and local law, the board's investigative personnel may carry firearms in the performance of their duties, if individually authorized by the board.
- (8) <u>Investigative personnel of the board may administer, proctor or verify testing for</u> recertification purposes, all alcohol server education courses approved by the state.

Director Coté:

As you are aware, there have been times when our investigative personnel have been conducting either inspections or compliance checks in remote communities throughout the state and have encountered licensees and employees whose alcohol server education cards have expired, and there are no instructors available to administer the recertification exams.

Although recertification testing can be done through the internet, in many occasions those communities do not have internet availability. The last time a situation like this occurred was on Prince of Whales Island where a licensee and both employees had expired alcohol server education cards.

During that situation, I was able to contact Alaska CHARR by telephone and have the tests sent to them by fax, and I proctored the exams. When they were done with the testing, I faxed the answer sheets back, and the CHARR instructor verbally acknowledged to me their passing scores and recertification status.

3 AAC 304.465(e) allows internet-based courses for those who are employed in rural premises, which are those licensed premises not on a statewide road system or further than 50 miles on a road system from a community where a course is offered at least once every month. However, this section of the regulation also requires that the student be under supervision of the licensee or the licensee's manager when testing, and that the licensee or licensee's manager certify to the course provider that the student did not receive outside help in taking the test and that no copies of the test have been kept.

It would be beneficial to licensees, their agents and employees if the board's investigative personnel were officially authorized to proctor or administer tests for recertification purposes only, any approved alcohol server education course in the state. The student would still be responsible for payment of testing charges or fees to the actual course provider.
