RE: Director's Report – Alcohol Business

Licensing Section

Since the last meeting, the licensing section has processed 32 last-minute renewals. The section is happy to welcome Erwin Domingo, our new Business Registration Examiner, whose first day was April 1, 2015. Records & Licensing Supervisor, Sarah Oates, provided much-needed assistance to the Title 4 stakeholder's steering committee cleaning up revision language in the statutory draft for Senate Bill 99. Ms. Oates was commended by that group for providing technical assistance and subject matter expertise. Ms. Oates has been training Jane Sawyer in board meeting preparation, and Ms. Sawyer assisted with the agenda for this meeting.

Enforcement Section

The enforcement section attended a week long law enforcement conference sponsored by the Alaska Peace Officers Association. With all enforcement officers present in Anchorage last week, the team was able to meet and map out a plan for alcohol enforcement while Title 4 revisions (Senate Bill 99) wait for the legislature to return next year. The enforcement team continued conducting inspections and compliance checks on licensees across the state. On March 23, 2015, the Anchorage enforcement team moved from 2400 Viking Drive to a suite in the Atwood building. The team is co-located with the Revenue investigators. Their phone numbers remain the same.

Title 4 Revisions Introduced in SB 99

The Title 4 revisions were introduced in the legislature by Senator Peter Micciche in Senate Bill 99. The bill was introduced late in the session and had two hearings in the Senate Labor and Commerce Committee. Due to the size and breadth of the bill, it will be held over the interim and work will continue toward passion when the legislature resumes work in January, 2016. Chuck Kopp, aide to Senator Micciche, has indicated he would like to see one or two public hearings on the bill over the interim. ABC staff will work closely with the Title 4 steering committee and Mr. Kopp to accomplish the needed work on the bill in time for the next session.



Legislation relating to the ABC

HB 116 extending the ABC's sunset date to June 30, 2018, passed both houses and is awaiting transmittal to the Governor. Your director testified three times in three committees on the bill, along with the auditor who completed our sunset audit. Legislators responded positively to my reports of the board coming into compliance with the recommendations of the audit and to hearing of our stakeholder work.

Other Agency Business

The ABC has agreed to partner with the Department of Health and Social Services (DHSS) on their new Partnerships for Success grant program. The grant provides a strategic prevention framework for educational programming for reducing underage drinking in Alaska. Over the past three years the prevention section of the Division of Behavioral Health at DHSS has been instrumental in working with the ABC board in the Title 4 stakeholder's group. We look forward to continuing our collaboration with DBH and the other partner agencies involved in this grant.

The ABC has a new Administrative Officer. John Calder's first day was April 1, 2015. John brings a wealth of administrative and leadership experience from his military service and contract work teaching survival training to military officers. John is the ABC's first ever Administrative Officer. We look forward to John providing needed leadership in the administrative functions of the agency.

The ABC staff will be moving to their new office space in the Atwood building in May. Currently the move is set for May 4, assuming the necessary construction is completed by the time. The staff will be housed in Suite 1600, while the enforcement team will remain on floor 6 of the Atwood with the Revenue investigators.

FINDING OF EMERGENCY

The Alcoholic Beverage Control Board finds that an emergency exists and that the attached regulations are necessary for the immediate preservation of the public peace, health, safety, and general welfare. The facts constituting the emergency include the following:

Effective February 24, 2015 Alaska Statute (AS) 17.38 significantly expands the circumstances in which a citizen may lawfully possess, transport, and transfer marijuana. Alaska Statute 17.38.040 expressly makes it unlawful to "consume marijuana in public." Alaska Statute 17.38.900 defines "consumption" as "the act of ingesting, inhaling, or otherwise introducing marijuana into the human body." But AS 17.38 does not define "in public."

Testimony before the legislature and local governing bodies has revealed widespread concern that persons charged with enforcement of Alaska's existing drug laws as well as the new marijuana law will lack sufficient guidance as to the meaning of "in public" to effectively enforce the new law, and that confusion and disorder will result, putting the public at risk.
