

NOTICE OF DEFENSE AND REQUEST FOR HEARING

TO: ALCOHOLIC BEVERAGE CONTROL BOARD

T & M Enterprises, dba Spirits of Alaska, ("T & M") by and through undersigned counsel hereby files a Notice of Defense and Request for Hearing pursuant to AS 44.62.390. Specifically, on May 1, 2015, the Board denied T & M's application for renewal of its license under AS 04.11.480(a) based on its decision to uphold a protest filed by the Anchorage Municipal Assembly.

T & M hereby respectfully requests a hearing. AS 44.62.390(a)(1). T & M's defenses to the Board's action are as follows:

1. On April 29, 2015, the Director issued to T & M Enterprises, Inc., dba Sprits of Alaska, a Notice of Suspension immediately suspending all sales of alcohol after the Board voted to uphold a local governing body's protest of T & M's renewal application and said Notice directed T & M to immediately stop selling alcoholic beverages. This decision to immediately suspend the license was an unconstitutional taking of T & M's valuable property right because T & M was not provided the required notice and opportunity to be heard in a meaningful, impartial administrative hearing in full compliance with the Administrative

Procedures Act prior to the suspension in violation of art. I, Sec. 7 of the Alaska Constitution and AS 04.11.510(c).

2. The Board erred in upholding the protest because the decision to protests by the Anchorage Municipal Assembly (MOA) was arbitrary and capricious as a matter of law and/or fact.

3. The Board erred in upholding the protest because T & M was not afforded the opportunity to defend its renewal application before the local governing body in the manner as provided by the local governing body in violation of the MOA's code and ordinances including but not limited to 3 AAC 304.145(d), MCA 2.30.120(H) and in violation of art. I, Sec. 7 of the Alaska Constitution.


4. The Board erred in upholding MOA's protest because it was arbitrary, capricious and unreasonable as the MOA denied T & M the due process rights established by the MOA's ordinances, specifically including, but not limited to, the right to have the opportunity to defend the renewal application and against the protest by having access to the political process and fully engaging in permissible ex-parte communication with the Anchorage Assembly members as provided under MCA 2.30.120(H).

5. T & M has requested an informal conference, and reserves the right to supplement these defenses both before and after said informal conference as the time to do so under AS 44.62.390(a) and (b) is tolled pending the informal conference.

License renewal Denial based Protest from Municipality of Anchorage

Dear Director Franklin:

I write to formally notify you and the Alcohol Beverage Control Board ("Board") that my office represents T&M, Enterprises, Inc ("T&M") incidental to the above referenced matter. As such, I respectfully request that all future communications and correspondence be directed to me and the address and contact information set forth above. I also write to insist that you, or the Board immediately correct the unconstitutional action taken yesterday of taking the license away before T&M was afforded its constitutional protections under Alaska due process clause.

I anticipate that, pursuant to AS 04.11.510(b)(1), as required by 3 AAC 304.150(a)(2), a written notice of the denial will be immediately furnished to my office on behalf of T&M stating the reason(s) for the denial and informing T&M of its entitlement to an informal conference with either the director or the board, and right to a full due process formal hearing conducted by the office of administrative hearings (AS 44.64.010). Please forward the required notice to my attention at my office address above. If your office has already sent this immediate notice to my

client directly, I respectfully ask that you forward a copy to my attention at the above address/fax number or email address: darrylthompson@akdltlaw.com .

Further, at this time, T&M also maintains the decision to immediately force it to close down and cease all sales was in error. T&M respectfully requests a stay the effect of the board's decision upholding the protest and denying the renewal of T&M's liquor license until such time as T&M is afforded the full due process rights provided under 3 AAC 304.150(a)(2), AS 04.11.510(b)(1) under AS 44.62.330-630. Until the notice and full opportunity to participate in first an informal conference, and then a formal hearing if necessary, T&M has not been provided the anticipated and mandated due process rights consistent with the potential deprivation of its established property interest in this license.

It is established law in Alaska that T&M has a property right in its license that is protected by the due process clause of the Alaska Constitution. See Rollins v Sate, 991 P.2d 202, 210 (Alaska 1999). Rollins is instructive and makes clear that the actions taken yesterday to immediately force the store closure was in error and is a pre-hearing deprivation of my client's property interest, in violation of due process. T&M's interest in the liquor license is "not merely a privilege subject to withdrawal or denial at whim of the state" but is "of considerable value". Id. To be clear, in Rollins, the court was considering the rights of a license holder who had her license renewal denied. Before this property right can be taken, due process requires that the license holder be provided with notice and an opportunity to be heard in a meaningful, impartial hearing. Rollins, citing Thorn v. State, Dep't. of Public Health, 774, P2d 1326, 1329 (Alaska 1989) (due process requires a "meaningful hearing"); Frontier Saloon, Inc. Alcohol Beverage Control Board, 524 P2d 657, 659, (Alaska 1974)(due process requires notice and an opportunity to be heard prior to a taking of a valuable property right). The court in Rollins noted that she received the procedural safeguards to which she was entitled; namely adequate notice and an opportunity to be heard in a meaningful, impartial administrative hearing in full compliance with the Administrative Procedures Act. Id.


T&M has not yet been provided the procedural safeguards to which it is entitled prior to yesterday's taking of its valuable property right, namely the procedural safeguards as set forth in AS 04.11.510(b)(1), required under 3 AAC 304.150(a)(2) when the board upheld a local governing body's protest and a renewal application was denied and made effectively immediately. Those procedural safeguards include the right to notice and a meaningful impartial hearing under the Administrative Procedures Act ("APA"). The actions taken by the ABC Board to close the store taken at the first regular meeting after having received the protest on its renewal does not comport to that which is required under Alaska's due process clause as interpreted by the Alaska supreme court or its own regulations. The Alaska supreme court and the governing statutes and regulations require notice and opportunity to be heard in a meaningful impartial

hearing in accordance with APA. Because yesterday's board meeting is not that required meaningful, impartial hearing conducted in accordance with the APA, the action of taking the license yesterday was an unconstitutional pre-hearing deprivation and a taking of my client's property without affording to it the due process required by Alaska's constitution and the ABC Board's own statutes and regulations.

Based on the above, I am respectfully asking at this point, the Board, or you correct this error and withdraw the order of closure until such time as T&M has been provided the required notice and opportunity to be heard in a meaningful, impartial administrative hearing in full compliance with APA. Failure to take immediate action is likely to result in the filing of an action in the superior court to prevent the irreparable harm occurring as a result of this unconstitutional taking.

I look forward to receiving on behalf of T&M the Notice as required by AS 04.11.510(b)(1) and required by 3 AAC 304.150(a)(2). I also look forward to written confirmation that the unconstitutional taking yesterday has been rescinded until such time as T&M has been provided its pre-deprivation constitutional due process rights, which includes the referenced notice and the opportunity to engage in a meaningful, impartial hearing in full compliance with the APA.

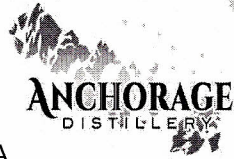

I am writing to address the Board's April 29th decision to uphold the protest of License #4158, which was held by my restaurant, Bombay Deluxe, Inc. Firstly, I would like to thank you for giving me the opportunity to explain the circumstances surrounding the protest put forth by the Municipality of Anchorage.

Bombay Deluxe, Inc. did receive a letter around March 17th, 2015 regarding the payment of municipality taxes. However, my wife and I welcomed the birth of a baby girl on the very same date. My wife is the financial officer of Bombay Deluxe, Inc. and was unable to review our establishment's incoming mail during this time due to the delivery of our daughter as well as extenuating medical circumstances. I also did not see the letter from the Municipality of Anchorage due to the extensive family support required during this time. For this I accept full responsibility.

I did receive a registered letter regarding the denial of License #4158 on Saturday, May 9th. This letter came as quite a surprise, as Bombay Deluxe, Inc. was making preparations for a typically busy Mother's Day weekend. However, we immediately ceased all sales of alcoholic beverages and waited in anticipation for a resolution on the next business day. Following my receipt of the registered letter, I also discovered the misplaced protest letter from the Municipality of Anchorage at my restaurant. Payment was made in full on Monday morning, May 11th to the Municipality of Anchorage.

I accept full responsibility if I failed to review in a timely manner any communications from the Municipality of Anchorage. However, I am requesting understanding regarding this matter, as it was a product of missed communication and extenuating family circumstances as opposed to willful negligence. In light of the extenuating family circumstances, as well as a complete resolution of the matter that initiated the Municipality of Anchorage's protest, I am requesting that Bombay Deluxe, Inc. be approved for a renewal of License #4158. Bombay Deluxe, Inc. is proud to serve Alaska residents and I personally appreciate the Alcoholic Beverage Control Board's efforts to support Anchorage establishments.
