WHEREAS, MT Four, LLC has made an application with the Alaska Alcohol and Marijuana Control Office (AMCO), formerly the Alcoholic Beverage Control (ABC) Board, and has paid the required fee for a new Beverage Dispensary-Tourism Liquor License #5507 with Restaurant Designation Permit, to be used for Hyatt House Anchorage located at 5141 Business Park Blvd., Anchorage, Alaska, 99503; and

WHEREAS, the Assembly must enter any protest to the AMCO within 60 days following receipt of the application; and

WHEREAS, the Anchorage Municipal Clerk received a copy of this application on July 6, 2016 and has determined that the last day for the Assembly to file a protest is September 4, 2016 and

WHEREAS, the Assembly Meeting on August 23, 2016 is the last scheduled regular meeting of the Anchorage Assembly prior to the expiration of the protest period; and

WHEREAS, the Municipal Clerk reports the following status concerning this location:

- 1. Any ABC Board violations and/or incidents that would lead to an ABC Board violation are attached; and
- 2. No taxes owing to the Municipality of Anchorage; and
- 3. Special Land Use Permit required by AMC 21.03.040C.4.a has not been approved; and
- 4. Approvals from Anchorage Fire Department and Municipal Health and Human Services **have been** received; and
- 5. Approval from the Building Safety has not been received; and

WHEREAS, protest by the Assembly is in order pending Assembly confirmation that outstanding items required for this location have been completed.

NOW, THEREFORE, THE ANCHORAGE ASSEMBLY RESOLVES:

- Section 1. The Anchorage Assembly hereby enters its PROTEST for the new Beverage Dispensary-Tourism Liquor License #5507 with Restaurant Designation Permit until these conditions are met:
  - Special Land Use Permit required by AMC 21.03.040C.4.a has been approved by the Assembly.
  - Approval from Building Safety
- Section 2. A copy of this Assembly Resolution may be presented to the AMCO as proof that the Anchorage Assembly, as the local governing body, has stated its protest in order to allow the Director of the AMCO to hold processing of the new Beverage Dispensary-Tourism Liquor License #5507 with Restaurant Designation Permit under local protest, until receipt by the Director of confirmation from the Municipal Clerk that the conditions in Section 1 have been met, and this protest is lifted as authorized by this Assembly Resolution.
- Section 3. The Anchorage Assembly hereby authorizes the Municipal Clerk, upon Municipal Clerk's confirmation that all Assembly conditions in Section 1 have been met, to provide written notification to the AMCO that this protest by the Anchorage Assembly is lifted, without further action by the Assembly.

Please find below the Tourism Compliance letter required for the Beverage Dispensary Tourism application.

- 1) The Hyatt House Anchorage serves the travelers to the city, providing overnight accommodation and meal services for those coming to Alaska on business and pleasure. As an airport hotel, many of the summer seasonal guests are embarking or disembarking on a cruise ship and require overnight stays that meet their travel needs. The hotel also services in-state visitors to Anchorage for medical, business travel and personal travel for shopping or entertainment. The Hotel Group (Manager/Operator of the subject hotel) promotes travel to Anchorage via advertising, both written and webbased, and the sales team travels to the lower 48 to attend travel and tourism trade shows that promote visitors to Alaska.
- 2) Yes the hotel offers room rentals 144 rooms.
- 3) Yes the hotel offers food services providing breakfast, lunch and dinner by buffet, room service, and table service through the H Bar restaurant.
