A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY STATING ITS PROTEST REGARDING THE TRANSFER OF OWNERSHIP FOR RESTAURANT/EATING PLACE LIQUOR LICENSE #5191 FOR YUK'S, LLC dba NOODLE WORLD ALASKA WITH RESTAURANT DESIGNATION PERMIT LOCATED AT 2844 E TUDOR RD., ANCHORAGE AK, 99507 AND AUTHORIZING THE MUNICIPAL CLERK TO TAKE CERTAIN ACTION.

WHEREAS, Yuk's, LLC has made an application with the Alaska Alcohol and Marijuana Control Office (AMCO), formerly the Alcoholic Beverage Control (ABC) Board, and has paid the required fee for the transfer of ownership of Restaurant/Eating Place Liquor License #5191, to be used for Noodle World Alaska, located at 2844 E Tudor Rd., Anchorage, Alaska, 99507; and

WHEREAS, the Assembly must enter any protest to the AMCO within 60 days following receipt of the application; and

WHEREAS, the Anchorage Municipal Clerk received a copy of this application on July 25, 2016 and has determined that the last day for the Assembly to file a protest is September 23, 2016; and

WHEREAS, the Assembly Meeting on September 13, 2016 is the last scheduled regular meeting of the Anchorage Assembly prior to the expiration of the protest period; and

WHEREAS, the Municipal Clerk reports the following status concerning this location:

- 1. No ABC Board violations and/or incidents that would lead to an ABC Board violation; and
- 2. No taxes owing to the Municipality of Anchorage; and
- 3. Special Land Use Permit, required by AMC 21.03.040C.4.b, has not been completed; and
- 4. Approvals from the Anchorage Fire Department, Municipal Health and Human Services Department, and Building Safety **have been** received; and

WHEREAS, protest by the Assembly is in order pending Assembly confirmation that outstanding items required for this location have been completed.

NOW, THEREFORE, THE ANCHORAGE ASSEMBLY RESOLVES:

- Section 1. The Anchorage Assembly hereby enters its PROTEST for a new Restaurant/Eating Place, Liquor License #5191 until this condition is met:
 - Special Land Use Permit required by AMC 21.03.040C.4.b has been approved by the Planning Director.
- Section 2. A copy of this Assembly Resolution may be presented to the AMCO as proof that the Anchorage Assembly, as the local governing body, has stated its protest in order to allow the Director of the AMCO to hold processing of the transfer of ownership of Restaurant/Eating Place, Liquor License #5191 with Restaurant Designation Permit under local protest, until receipt by the Director of confirmation from the Municipal Clerk that the conditions in Section 1 have been met, and this protest is lifted as authorized by this Assembly Resolution.
- Section 3. The Anchorage Assembly hereby authorizes the Municipal Clerk, upon Municipal Clerk's confirmation that all Assembly conditions in Section 1 have been met, to provide written notification to the Alaska Alcohol and Marijuana Control Office that this protest by the Anchorage Assembly is lifted, without further action by the Assembly.






STATE OF ALASKA ALCOHOL BEVERAGE CONTROL BOARD Licensed Premises Diagram




