



# Westmark Inn Skagway Tourism Statement



Westmark Inn Skagway is located in Skagway, Alaska and captures the spirit of the Klondike Trail with its Victorian décor, rustic setting and warm Alaskan hospitality. The Inn's 113 guestrooms accommodate travelers in turn-of-the-century style and are located adjacent to the Historic District and close to shopping and entertainment. Hotel and land tours are a primary component to Holland America Line's Land + Sea Journey, which combines an Alaska cruise and a land tour segment of 3 to 12 days during the months of May through September. For those wanting to explore and learn more about the area, the following attractions are within walking distance: Klondike Gold Dredge, White Pass & Yukon Route Railroad, Skagway Museum, and the National Park Service Visitor Center. The Skagway cruise ship docks as well as the Alaska State Ferry terminal are also within close proximity.

Onsite dining venues include The Chilkoot Room, Chilkoot Café (espresso), Bonanza Bar & Grill, and Glacial Lounge for friendly service and fine food and drink.

As incentives to travelers, there is complimentary shuttle service to the ferry terminal and airport; or free parking to those with vehicles. Guests can earn Alaska Airlines Mileage Plan miles and Westmark GuestRewards. Amenities include: cable television, coffee makers, free Wi-Fi, and tour booking services.

## **Renovations and Improvements**

To improve the safety and security of restaurant guests and employees, renovations were made in 2012 to close off a corridor passing through an employee housing unit and creating separate stand-alone restaurants. Full guest room renovations have occurred in recent years with the first phase commencing in 2013, and are ongoing until all rooms are completed. An espresso café upgrade took place in 2015, and minor refurbishments (floors/paint/furniture) in the Glacial Lounge area in 2016 as well.


