I am writing to you regarding the employment of a 15 year old minor. I understand that I am to receive an e-mail and certified letter about violation, but have not received either. In the meantime, I wanted to write and explain my error. My husband and I were approached by this young man stating that he wanted to work in the kitchen and learn to be a cook. I reviewed the work permit and it seemed to me that as long as his parents gave permission, it would be allowed. I sent in the permit within seven days of his starting and got denied due to the regulation stated clearly on my RDP that I obviously had not reviewed.

# Upon receipt of the denial, I immediately told the young man that he could not work, intern, or volunteer here.

I absolutely understand the regulation now and will always comply. I apologize that I did not even consider this to be a question of the alcohol license since he was to work in the kitchen and would be no where near alcohol. Please accept my sincere apology. I should have researched the situation more, as we have never had anyone under 16 even apply. My husband and I are determined to run Grape Tap ethically and with the utmost integrity.

I received our reprimand for expanding our outdoor seating Saturday, September 17<sup>th</sup> during our "Bear Naked BBQ" event. Let me assure you first and foremost that there was zero malicious intent nor nefarious plans in the works. We were not intending to defraud anyone or break any laws. This mistake was made purely out of inexperience and poor prior planning. We take full responsibility for our actions and are willing to pay any monetary consequences that may occur. We simply did not realize the number of people who would be showing up and made an executive decision on the day in question to elongate our predetermined outdoor area. We did not widen it and we placed signs stating "No beer beyond this point" along the perimeter. We did the best we could in light of it being a Saturday and no opportunity to contact the appropriate officials in order to get the necessary approval.

Since then we have dialed back the barriers to our original footprint and keeping it that way unless we are approved for anything larger. We understand the problem and have worked to rectify the situation. There should no longer be a concern in the future and we have taken care of it. That being said, attached you will find a new plan we would like to formally submit for future use or events. You will see we extended the footprint in order to include more standing room outside. While we do not foresee us needed such an extension currently, we do not want to be caught in the same situation as before. Please let me know if you need anything else form us and, as usual, we will provide it immediately. Thank you in advance.

Dear Cynthia Franklin,

By way of introduction, my name is Dawn M Harris. I am the General Manager of the Great Alaskan Bush Company. This is my 28th year with the company.

Please accept my sincerest apologies for not paying attention to the directions while obtaining the catering permit for our charity car wash events dated June 10<sup>th</sup> and June 17<sup>th</sup>. This year was the first year I chased the permits down myself. I was not aware that I needed to take the permit I received from APD to the ABC. I did get it signed by an APD representative but failed to take it to ABC from lack of knowing that step. This is my own fault and I take sole responsibility for not reading the permit form in its entirety. In past events, the owner, office manager or a GABC representative filed the permit request for me. This year the owners were out of state, the office manager retired and the representatives that usually filed these are no longer with the company. I assure you this will not happen in future requests for a catering permit. I am well aware of the proper procedures now.

My servers (1 bartender at each event) have valid IDs and TAPs card on files. No one was over served and both events were without incident. The area of service was roped off and IDs were checked before being served. No one under 21 was allowed in the service area.

Again, I apologize for my ignorance in this situation. I would never intentionally break laws and/or ignore regulations and procedures. Please inform me on the next step in rectifying this violation.



Hello, my name is Joanna Pitsilionis and I am the owner of the Red Diamond Liquor Barn in Soldotna, Alaska license number 2592. I have owned this business for approximately 8 years.

The first thing I regret to inform you is that I received the letter I am responding to on Friday the 29<sup>th</sup> of July at approximately 4 pm. The address to which is was mailed (p.o. box 2917) is no longer mine, but belongs to my father, he is 70 years old and in sick health, he accepted the certified letter and did not provide to me until Friday 29<sup>th</sup>. When I saw the post mark on the letter of June 16<sup>th</sup> I felt as though I would faint. Not only do we have a violation but we have failed to respond to it in a timely manner. I am correcting the mailing address with your office Monday morning.

Nonetheless I now have the letter of violation in front of me and hope to explain the circumstances of what has occurred. I ask it be known I take full responsibility for my incompetence in this matter.

In August of 2015 I decided to leave Alaska with my young children and spend the winter overseas with my extended family in Europe. I am a single mother my children both under 5 years old. I felt extremely overwhelmed and needed a break. It was the first time I had left a manager behind to manage my business. Approximately at the end of March 2016 I was notified the manager suddenly and with no warning walked out deserting her position. I called my old partner Daniel Navarre to and asked him to step in until my return, he in fact did, at this point I discover the business had been neglected, all the "old" employees soon quite, the bills where unpaid, and under these extraordinary circumstances Daniel literally had three employees to cover a store open from 6 am to 1 am seven days a week. He immediately hired new employees and a new manager. Internally there were many problems. I returned to Alaska approximately April 20th and since then have been trying to reestablish this business.

Once I returned one of the first things I told the new manager was to make sure all employees had correct and current certifications, I recall telling her they had a to get this within a month of their hire. It has been a struggle to stabilize the staff, we went through many new hires, as well as untangle the mess the business was in. There are so many moving parts as we are a gas station c-store and liquor store. The certification classes here in in Soldotna are once every two weeks, and although I knew and informed the new manager that we must be current we were in a frantic state of catch up, many unknowns, passwords missing, money mismanaged, no employees.... it was truly a struggle for everyone here. When Mr. Hamilton arrived we had two clerks who had been working here approximately two months, another who had worked for us in past but card was expired, and the manager who had also been with the store for approximately 3 months the "older" two employees had certification. In short, the "new" hire was without certification. I was not present, the manager tried to explain the circumstances to Mr. Hamilton. I was called at home and immediately reached out to instructor who conducts the classes. Of all days, there was a class within two hours of Mr. Hamilton arrival. I instructed all staff without current cards attend class and called into work the two clerks who did in fact have current certifications. Everyone passed the class.

Right now everyone who sells alcohol at this store has certification.

I have never had such an infraction in the past. I am truly embarrassed that I am explaining all this. It was incompetence and neglect on my part because I know how serious this is. I understand I have been IVED

I don't know what else to say. This truly was the first time this has happened since I have owned this business. I earn my living doing this, we went through a very difficult winter financially and I can't even imagine what situation I would be in if I was shut down. I truly feel shame explaining all this, and for something that could have been avoided.

There is also an issue of my DBA changed to Liquor Store on the violation, my liquor license is DBA Red Diamond Liquor Barn, I'm not sure what is being referred here?

Please understand this is the complete truth, I and everyone here attest to the above. I hope we can resolve this.

Also can you please update my address to P.O.Box 151 Kenai Alaska 99611, as the Box 2917 is my Fathers address of business.

- (a) A person may not knowingly enter or remain on premises (1) in which alcoholic beverages are manufactured, sold, offered for sale, possessed for sale or barter, trafficked in, or bartered in violation of
- (A) AS 04.11.010; or
- (B) a municipal ordinance adopted under AS 04.21.010(a) or (b); or
- (2) licensed under this title during hours in which the person's presence on the premises is a violation of a municipal ordinance adopted under authority of AS 04.16.010(d) providing for hours of closure that are outside the hours of closure prescribed by AS 04.16.010(c).
- (b) A person who violates this section is guilty of a violation.

# Sec. 04.21.030. Responsibility of licensees, agents, and employees. The licensee has a duty to exercise that degree of care that a

The licensee has a duty to exercise that degree of care that a reasonable person would observe to ensure that a business under the person's control is lawfully conducted. This duty of the licensee includes, but is not limited

- (1) to ensuring the compliance by agents or employees with this title and regulations adopted under this title, including acting with reasonable diligence to determine that agents or employees are advised of the provisions of this title and the regulations adopted under this title, either by securing the agent's or employee's written acknowledgement of posted instructions or otherwise; and
- (2) to ensuring the compliance of the premises with public health, fire, and safety codes and ordinances of the state or municipality having jurisdiction.
- **3AAC 304.515 Inspection.** (a) Licensees are considered to consent to the entry upon the licensed premises and inspection of the licensed premises at all reasonable times and in a reasonable manner by investigative personnel of the board or by other peace officers acting in their official capacity for the

purpose of enforcing statutes and regulations related to alcoholic beverages.

(b) Licensees shall do all things reasonably necessary investigative personnel appropriate cooperate with and to employees of the board and peace officers acting in their official capacity to enforce the statutes, regulations ordinances related to alcoholic beverages, including permitting entry upon and inspection of the licensed premises and providing access, upon request at reasonable times, to business records at the written direction of the director.

It was the 4<sup>th</sup> employees last day so they were sitting around talking and lost track of time. They were not intoxicated and left immediately after the police reminded them of the time. Mr. Stroms actions were uncalled for.

Further measures taken were the locks being changed and we had an employee meeting to stress the importance of following our policies.

As you know we run a pretty tight ship and this kind of behavior is unacceptable. I am disappointed that the officer didn't call us as we have a pretty good rapport with JPD and they usually call us if anything looks suspicious.

We have never had any issues with our licenses at our establishments and would appreciate leniency of this first violation.
