RE: Hoarfrost Distilling # 5436

This is a request for reconsideration of a distillery license in the City of Fairbanks. At its meeting on April 26, 2016, the board denied the application because the applicant did not obtain a Certificate of Occupancy from the City of Fairbanks and the City of Fairbanks refused to lift its January 26, 2016 protest.

The applicant requested an informal conference with the director. The conference was held and the applicant presented an explanation of the construction schedule and the reasons the Certificate of Occupancy could not be obtained. The applicant kept in good contact with the director after the conference and met the deadlines set for obtaining the certificate. The City of Fairbanks provided notification to AMCO on October 7, 2016 that its protest was lifted because the applicant had obtained the Certificate of Occupancy. An AMCO enforcement officer visited the premises and performed a preliminary inspection.

Recommendation is to reconsider and grant the license.
