

RESOLUTION 15-04-01

TITLE: Opposing the Opening of Liquor Stores in Bethel

WHEREAS The Association of Village Council Presidents (AVCP) is the recognized tribal organization and non-profit Alaska Native regional corporation for its fifty-six member indigenous Native villages within Western Alaska and supports the endeavors of its member villages; and

WHEREAS AVCP fully supports its member villages in all aspects of their self-determination, health and well-being; and

WHEREAS Sobriety in our villages is a self-determination, public health and well-being issue of the greatest importance; and

WHEREAS Alcohol abuse causes significant disruptions and damage in the lives of our people, which is evidenced by alarmingly high rates of social disorder, including domestic violence, child neglect/abuse, criminal activity, increased rates of fetal alcohol spectrum disorders, and the continually rising incidents of preventable death; and

WHEREAS The availability of alcohol for purchase at liquor stores in Bethel will increase access to alcohol locally, and negatively impact the flow of alcohol to outlying villages in the AVCP Region.

NOW THEREFORE BE IT RESOLVED that the Association of Village Council Presidents Executive Board strongly urges the Bethel City Council to protest the liquor applications of Bethel Spirits, LLC, a wholly-owned subsidiary of the Bethel Native Corporation, the Alaska Commercial Company, and any other business establishment that is in the process of applying, or whose application is currently pending before the Alcoholic Beverage Control Board.
