



## MEMORANDUM

RE: Discussion of Policies

The Director is seeking a brief policy discussion with the board on the following seven topics. The purpose of the discussion is to bring the board up to date on director decisions and get general guidance from the board regarding issues that have arisen on multiple occasions but which are not directly addressed in statute or regulation.

### 1) Permits Directive

- a. On December 30, 2015, I issued the *attached* Permits Directive. I included the concepts in the directive in an end-of-year email that I sent to all licensees who have an email on file with the office.
- b. The permits directive is intended to keep the administration of catering, special event and wine auction permits within their stated legal purposes. The directive specifically addresses issues for which the board was questioned in its last legislative audit, and for practical issues.
  - i. Issuance of catering permits to cover an unlicensed period.
  - ii. Issuance of catering permits to "no premises" licenses.
  - iii. Issuance of catering permits for extended period of times that do not represent an "events-based" analysis of the applications.
  - iv. Issuance of catering permits based on applications submitted very close in time to the event which do not permit staff and director to adequately review the application or get questions answered.

### 2) Premises Certification for Dededesignation

- a. A careful review of 3 AAC 304.660 anticipates a two-step process for temporary dedesignation of license premises for the holder of a beverage dispensary or restaurant eating place license.
  - i. Step 1- Certification- an inspection of the premises with a determination by the board that the premises is appropriate for temporary dedesignation
  - ii. Application for temporary dedesignation for specific events
- b. Application (*attached*) appears to have been skipping step one resulting in dedesignation without preliminary determination by board of appropriateness of premises for the presence of minors.



- c. Discussion with board about enacting a two step process through revision of the application process.
- 3) Permitted Events at Brewery, Winery and Distillery Licensed Premises
    - a. Certain license types have restrictions prohibiting sales and service of alcohol after 8 pm, service of more than a set amount of alcohol, and offering live entertainment
    - b. The Director and Enforcement Supervisor have noted an increasing amount of permit applications for Catering permits on said licensed premises to extend hours and privileges
    - c. Policy discussion with board on how to accommodate events at Brewery, Winery, and Distillery licensed premises without effectively allowing such premises to regularly operate outside of the restrictions imposed by their license type (example- *attached*)
  - 4) Wholesale Licenses in Personal Storage Units
    - a. Trend in applications for AS 04.11.160(b) malt beverage and wine licenses where proposed premises is a personal storage unit.
    - b. Some of these appear to be businesses whose principal place of business is really out of state and that should be subject to the restrictions in AS 04.11.060, requiring them to obtain an AS 04.11.160(a) wholesale license and to maintain wholesale distribution points in the state of Alaska in order to be privileged to distribute alcohol to Alaska licensees.
    - c. Policy discussion
      - i. Is a personal storage unit with nothing else a principal place of business that would entitle an applicant to get an AS 04.11.160(b) license?
      - ii. Does it matter if they ship the alcohol to the unit and deliver it to the licensee from there or if they ship it directly to the licensee?
  - 5) Cross-Marketing of Alcohol and Marijuana
    - a. Status of public consumption of marijuana continues to be touted as a gray area with events such as Northwest Cannabis Classic stating they can permit attendees to consume marijuana
    - b. Catering permits applied for regarding service of alcohol at marijuana events
    - c. Marketing of "Cannabis inspired" beer, *attached*; policy discussion with board if breweries begin making beer that is being marketed as marijuana beer
  - 6) Determining Population Criteria
    - a. The director publishes the new population numbers annually on or before April 30



- b. Population numbers are provided by CED which updates them annually
  - c. 3 AAC 304.905 provides that in determining population criteria, the CED figures will be adjusted downward by subtracting populations for prisons, universities and military bases
  - d. Around April 25, 2015, the director discovered that the prior administration had continued to use old numbers for the adjustment when the administrative assistance could not get responses on current numbers from DOC, military bases, or the university system. At that point it was too late to get current numbers for adjustments for the 2015 population figures.
  - e. The current administrative assistant worked diligently to get current figures for the adjustments. The prior adjustments (*attached*) were more than seven years out of date. This will result in what appears to be a dramatic change (*attached*) in the population numbers as the adjustments have increased steadily in the years that correct adjustment numbers were not obtained, but appear to abruptly jump given the recent obtaining of the correct adjustment numbers.
- 7) Delegation Drawer Update
- a. As promised, the director has brought the board items delegated at the previous meeting as well as items delegated at the two meetings conducted long enough that delegated matters would also require a renewal. The intent of the director and staff is to close the gap and ultimately have the board review all items previously delegated to determine which are still appropriate for delegated issuance of licenses by the director after a passage of time.
  - b. The director is delighted to report to the board that ALL items delegated at the February 10, 2016 meeting of the board have been resolved. Only older delegated items appear on today's agenda.

Dear Licensee,

I hope your holidays were happy and bright. I am looking forward to a busy and amazing 2016 as your ABC Director. I have a few things to share as we move into 2016. This email might be a bit long, but I hope you will read it and keep it for reference.

#### ANNOUNCEMENTS FOR LIQUOR LICENSEES

1. OPERATING REQUIREMENTS- January 1-December 31, 2016
  - a. The board clarified at its September meeting that the requirement that a licensed premises be operated for 30 8-hour days during a calendar year is exactly that. No four hour days will “count” as eight hour days beginning in 2016. I will send letters in January to any licensee that had operating hours in 2015 that do not satisfy the statutory requirement.
2. WAIVER OF OPERATIONS
  - a. Only 1<sup>st</sup> and 2<sup>nd</sup> waivers are grouped for the board as consent agenda items. The board looks closely at 3<sup>rd</sup> waivers and has a stated policy of denying 4<sup>th</sup> waivers. The board can impose conditions when granting any waiver.
  - b. DEADLINE FOR WAIVERS TO BE FILED without incurring late fee in 2016 is Friday, November 4, 2016.
3. REMINDERS FOR LICENSES EXPIRING IN 2015
  - a. If you have not filed your renewal application by December 31, 2015, you must include the \$500 late fee and get your application to us immediately. Your license expires by operation of law on February 28, and if your renewal application is not postmarked by February 28, 2016, your application will be returned because your license has expired. Don't let this happen to you!
  - b. We are carefully checking applications for compliance with the statutory requirement that only a licensee can apply for renewal. We have received a lot of

feedback that this has never been required before, but the statute is clear and is being enforced on this round of renewals. Please make sure that your renewal application is signed by an owner of the license.

- c. We are carefully reviewing ownership of entities for these renewals. Of 5 renewals received yesterday, all 5 needed stock transfers. If the controlling interest of your license ownership entity has changed, you must not only report the change, you must complete a stock transfer. Please be mindful of this when you complete your renewal.

#### 4. CATERING PERMITS

- a. WILL NOT BE ISSUED FOR “NO PREMISES” LICENSES OR LICENSES WITH PREMISES NOT OPERATIONAL. AS 04.11.230 provides that active, valid, BDL holders can get a catering permit for an event “held off of the licensed premises”. If there is not licensed premises, a BDL holder is not eligible for a catering permit. The most recent legislative audit dinged the board and staff for issuing catering permits inappropriately for regular operations of licenses. We are carefully following the statutes in the issuance of catering permits. They cannot and will not be issued for any purpose other than that listed in statute.
- b. PLEASE OBSERVE THE FULL BUSINESS DAY rule. We had a lot of requests for catering permits in 2015 coming in just hours before an event was due to start or at the end of the day on Friday. Staff is carefully reviewing catering permits and will not be rushed into issuing a permit because the applicant was too busy to get it in earlier. Please give us a full business day to look at your catering permit application. Thanks for your consideration.

#### OTHER ABC BOARD NEWS

As many of you know, we were assigned a new board and new duties in 2015 and as a result we slightly expanded our staff. The Marijuana Control Board was seated in July of 2015 and has been making rules for the marijuana industry. The rules adopted by the MCB on November 20, 2015, as amended on December 1, 2015, can be found here:

<https://www.commerce.alaska.gov/web/Portals/9/pub/FinalRegsThrough12-1-15.pdf> . We expect to begin taking applications for marijuana establishments toward the end of February, 2016, and to issue some licenses toward the end of May, 2016.

1. Bob Beasley, our longtime Enforcement Supervisor, retired effective October 30, 2015. Our new Enforcement Supervisor, James Hoelscher, has excellent qualification and is extremely easy to talk to. You are more than welcome to drop him a line and say hi, and are always welcome to ask him questions.

- a. James is in the process of creating a new FAQ database for liquor licensing questions. We want everyone to get the right answer every time, even though many of you have very fact-specific questions.
  - b. We have created an electronic mailbox for liquor enforcement questions. Using this e-mail is the quickest way for us to answer your questions. Please email [Alcohol.enforcement@alaska.gov](mailto:Alcohol.enforcement@alaska.gov) with your enforcement questions.
  - c. James has enforcement officers located in Juneau (Steve Johnson), Fairbanks (Rich Finney), and Anchorage (Joe Hamilton, Joe Bankowski, and Jeff Rukes). We expect to recruit two additional officers in the coming months.
2. Sarah Oates is our Records and Licensing Supervisor. Many of you have met or spoken with Sarah over the years. She has created an email box for liquor licensing questions that is monitored by her four Business Registration Examiners, Jane Sawyer, Maxine Andrews, Christina Thibodeaux and Shilo Senquiz. Please email [Alcohol.licensing@alaska.gov](mailto:Alcohol.licensing@alaska.gov) for liquor licensing questions.
  3. John Calder came to the agency in April of 2015 as our first Administrative Officer. John coordinated the marijuana regulations public comment process, is responsible for budgeting, recruitment, and his two administrative staff in Anchorage, Joe Samaniego and Naomi Johnston. John is monitoring the marijuana questions and has set up an email box for that purpose.   4. The ABC got a new board member in 2015. Tom Manning holds an industry seat on the board. He is part owner of Duck Creek Market, a liquor licensed establishment in Juneau. Tom joins Bob Klein (Chair, Industry), Ellen Ganley (Public Member), Marvin Yoder (Public Member) and Bobby Evans (Rural Public Member) on the ABC Board.

We have been continuing to strengthen our website as a way to communicate with our licensees and the public. Please feel free to visit the website and explore anytime. It is in the Department of Commerce, Community and Economic Development, located at <https://www.commerce.alaska.gov/web/abc/>.

I appreciate your support as the office undergoes a lot of changes in a short time. Thanks for your patience and for doing what you do. Everyone here at the board enjoys working with each of you throughout the year.

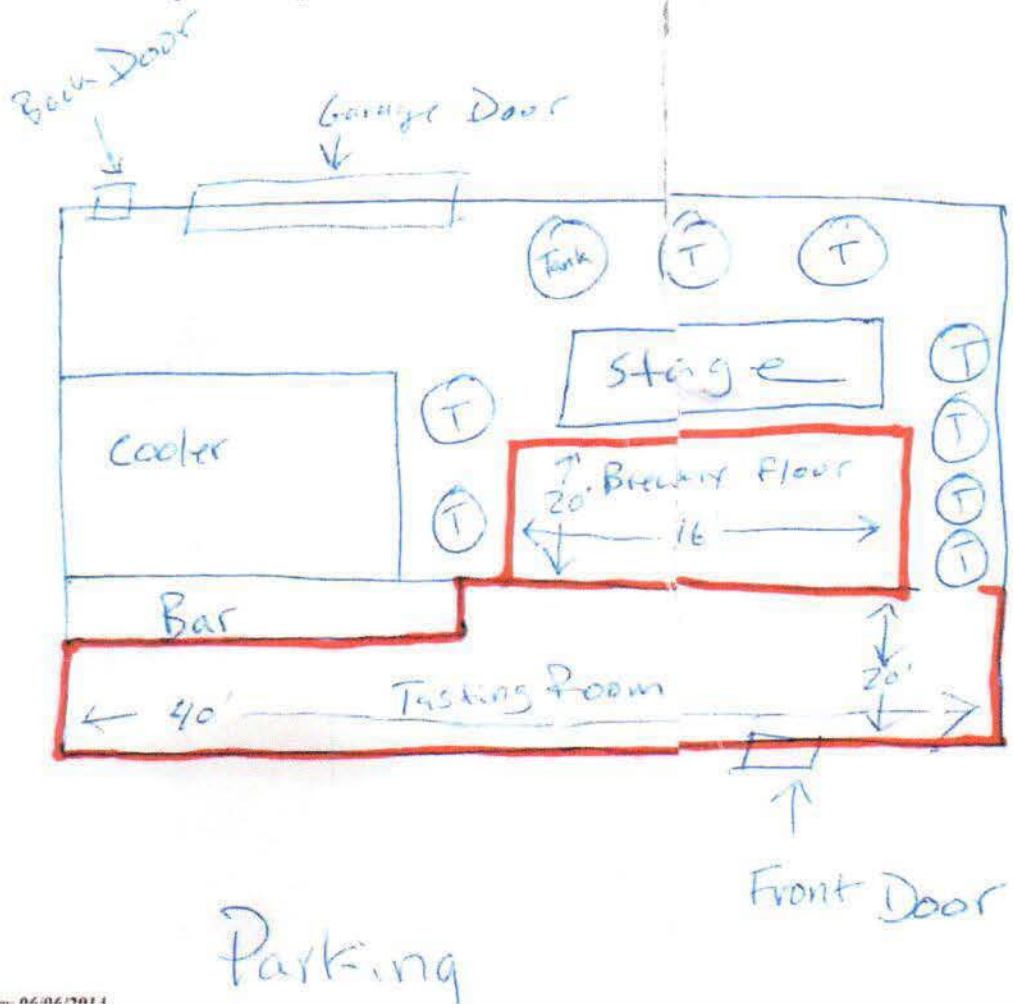


