A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY STATING ITS PROTEST REGARDING A NEW RESTAURANT/EATING PLACE LIQUOR LICENSE #5431 AND RESTAURANT DESIGNATION PERMIT FOR JOHNNY CHICAGO'S, LLC dba JOHNNY CHICAGO'S LOCATED AT 751 E 36TH AVE., UNIT 107, ANCHORAGE, AK 99503 AND AUTHORIZING THE MUNICIPAL CLERK TO TAKE CERTAIN ACTION.

WHEREAS, Johnny Chicago's, LLC has made an application with the Alcoholic Beverage Control (ABC) Board and has paid the required fee for a New Restaurant/Eating Place Liquor License #5431 and Restaurant Designation Permit, to be used for Johnny Chicago's, located at 751 E 36th Ave., Unit 107, Anchorage, Alaska 99503; and

WHEREAS, the Assembly must enter any protest to the ABC Board within 60 days following receipt of the application; and

WHEREAS, the Anchorage Municipal Clerk received a copy of this application on November 6, 2015 and has determined that the last day for the Assembly to file a protest is January 5, 2015; and

WHEREAS, the Assembly Meeting on December 22, 2015 is the last scheduled regular meeting of the Anchorage Assembly prior to the expiration of the protest period; and

WHEREAS, the Municipal Clerk reports the following status concerning this location:

- 1. No ABC Board violations and/or incidents that would lead to an ABC Board violation;
- 2. No taxes owing to the Municipality of Anchorage;
- 3. Administrative site plan review, required by AMC 21.50.500, has not been completed;
- 4. Approvals from the Anchorage Fire Department, Building Safety, and Municipal Health and Human Services Department **have been** received; and

WHEREAS, protest by the Assembly is in order pending Municipal Clerk confirmation that outstanding items required for this location have been completed.

NOW, THEREFORE, THE ANCHORAGE ASSEMBLY RESOLVES:

- Section 1. The Anchorage Assembly hereby enters its PROTEST for a New Restaurant / Eating Place, Liquor License #5431 with Restaurant Designation Permit until this condition is met:
 - Administrative site plan review required by AMC 21.50.500 has been approved by the Planning Department and confirmed by the Municipal Clerk.
- Section 2. A copy of this Assembly Resolution may be presented to the Alcoholic Beverage Control Board as proof that the Anchorage Assembly, as the local governing body, has stated its protest in order to allow the Director of the Alcoholic Beverage Control Board to hold processing of the New Restaurant/Eating Place, Liquor License #5431 with Restaurant Designation Permit under local protest, until receipt by the Director of confirmation from the Municipal Clerk that the conditions in Section 1 have been met, and this protest is lifted as authorized by this Assembly Resolution.
- Section 3. The Anchorage Assembly hereby authorizes the Municipal Clerk, upon Municipal Clerk confirmation that all conditions in Section 1 have been met, to provide written notification to the Alcoholic Beverage Control Board that this protest by the Anchorage Assembly is lifted, without further action by the Assembly.
