River's Edge Hotels, LLC is currently under contract to purchase the property and assets of the business/property commonly known as Rivers Edge Resort & Chena Alaskan Grill and located at 4200 Boat Street, Fairbanks, AK. Included in this sale is the transfer of the liquor license (#3849) from the current owner to the River's Edge Hotels, LLC.

Pursuant to the "tourism statement" requirement we are providing the statement below demonstrating that the establishment encourages tourism.

The Rivers Edge Resort and Chena Alaskan Grill is a full service hotel and restaurant providing 94 rooms and serving breakfast, lunch and dinner. Visitors can enjoy an alcoholic beverage with their meal that can be served at the restaurant or at their room.

A requirement by the majority of tour companies is that any restaurants/hotels they visit and use for accommodations provides liquor service. By offering this service at our establishment we are encouraging both the existing level of tourism and growth in the tourism market.

At the front desk we offer information and reservations for activities/tours on the Chena river, gold mining, and tours to Northern Alaska and Barrow along with our own city tour of Fairbanks and the University Museum. In addition to the large tour companies, we also invest in multiple marketing outlets including The Milepost, State of Alaska's Tourism marking program, etc.

During the last few years substantial improvements have been made to the facilities including but not limited to, new WIFI equipment, full kitchen remodel (in progress), new flat screen TV's for the guest rooms, and upgraded common area bathrooms. The hotel and restaurant were built with the specific purpose to serve the visitor market and encourage growth in tourism. We plan to continue further investment in the business to remain competitive and grow the business.




