Cynthia Franklin reminds the board that they had approved the Skagway Spirits license (the only distillery license allowed by population in Skagway) with delegation a number of months ago, and that the applicant is nowhere near being ready to open. She informs the board that the only thing that Skagway Spirits is waiting on before issuance of the license is a preliminary inspection.

The board agrees that they want to wait until the October, 2016 board meeting to make a decision about this, which will give Investigator Johnson an opportunity to check out Skagway Spirits and the owner to speak to the board.

Joel Probst, representing Alaska Stillman, provides testimony regarding Skagway Spirits and submits documents from TTB's website and photos of the Skagway Spirits building. He additionally requests that the board table the Alaska Stillman application until the October meeting.

Donna Nass, Wage and Hour Investigator, identifies herself for the record and states that the audit is not concluded because Fantasies has interfered with the audit by not providing the records that were requested and by having their attorney submit a letter saying that the Department of Labor may not interview any employees, which is something that is allowed by statute. She asks the board if the dollar amount of what's due to employees makes a difference. She states that there are approximately 40 employees involved and the low-ball amount owed is around \$500,000.

Brian Stibitz, legal counsel for Fantasies on 5th, provides testimony and answers board questions.

Cynthia Franklin reminds the board that they have already held a AS 04.11.510(b)(2) hearing for the objections received and that they are entitled to deny renewal of the license based on AS 04.11.330(a)(1).

Tom Manning asks for clarification on the basis for denial.

Cynthia Franklin states that the denial would be based on the objections and the best interests of the public.
