Dear Director Franklin and Board members:

The Kodiak Regional Rural Forum meets 3 times per year and has the participation of representatives from the tribal governments and city governments of Kodiak's rural communities: Old Harbor, Akhiok, Ouzinkie, Port Lions and Larsen Bay. In addition the forum has representatives from the Akhiok, Afognak, Old Harbor and Ouzinkie Native Corporations as well as the Regional ANLCSA corporation, KONIAG, Inc. The forum is a consortium addressing regional rural concerns and has been meeting for 12 years.

It was a surprise to the Forum's participants that the ABCB was considering the transfer of Mr. Sargent's package store license to the Kodiak Airport location. Moreover, the individual rural municipal governments would have expected to be noticed regarding the proposed transfer. The impacts of a liquor store at the Kodiak Airport will be primarily if not exclusively borne by the Kodiak' rural communities and the individuals living there. Yet, these communities were not noticed or consulted about the proposed license transfer. Consequently, the Forum's first request is for the ABCB to postpone your decision on the Wayne Sargent license transfer until your April meeting. This will allow each community time to discuss the issue and comment.

Director Franklin attended and presented at the Forum's January 27-29 sessions. Ms. Franklin clarified the Board's legal guidelines regarding comment on license transfers and informed the Forum regarding statutory notice requirements. Although disappointed with the notice guidelines, the Forum understands that NOW is the time to make comment. After considerable discussion the Forum, as represented by the following signors, STRONGLY OPPOSES THE TRANSFER OF A LIQUOR STORE LICENSE TO THE KODIAK AIRPORT AREA.

Each Kodiak rural community faces present and multi-generational issues with alcohol abuse. While a Kodiak Airport liquor store will not solve these problems, it will encourage additional alcohol consumption and transportation and exacerbate existing concerns. In addition, the Kodiak Area Native Association and its various healthy lifestyle programs as well as each community tribal council have all worked to educate about and reduce alcohol abuse. Why, after all of this effort, would the ABCB place a license at a location that is strategically selected to increase alcohol sales and abuse by Kodiak's rural residents? Such a decision simply serves to undermine existing and long-term prevention efforts in Kodiak's Alaska Native community. This is contrary to the wishes and desires of virtually all of the leaders in the Kodiak Native community and should not be done.

l oppose this application for the following reasons:

- 1) It was not widely advertised or posted.
  - a. Only 14 notices were sent by the Kodiak Island Borough Clerk to the few businesses and government entities located at the airport. The application included a hand drawn diagram showing the location of shelves within a room, but no map or diagram showing the location of the package store at the airport. The only indication that it is will be located at the airport is an address, and the list of property owners notified, e.g. USCG, DOT, Alaska Airlines, etc..
  - b. It was first posted on the Kodiak Island Boroughs web site on December 22, 2015, buried within a 169 page agenda packet. The Assembly held a "public hearing" on this issue during their January 7, 2016 regular meeting.
  - c. There were two major holidays between these dates:
  - d. I only discovered this was an unusual and controversial application while reviewing the regular Borough Assembly meeting agenda packet a few days prior to the hearing on January 7, 2016. Upon my request the Assembly moved to postpone the hearing to a special meeting on January 14, 2016, to give myself and others additional time to perform research and solicit input.
- 2) The primary customer for this package store will clearly be the Kodiak Island villages served by the small air service located within the same building. To the best of my knowledge the villages are all unofficially "damp" so this location is literally on their front door step. If approved the village residents will need to walk by this store whenever traveling to and from their villages. None of the villages and local Native Corporations and Health organizations were notified, other than the bland and unrevealing standard Assembly meeting notifications and "liquor license transfer" ads in the newspaper.
- 3) I contacted several people during the week before the initial hearing, including: two businesses located at the airport; the Kodiak Island Area Native Association Village Public Safety Officer representative; and a few of the village elders. None of them were aware of the application and

all were very concerned.

- 4) Several people opposed the application.
  - a. The two airport business owners and several village elders I spoke with were opposed but wished to remain anonymous. Four village residents and leaders submitted e-mains to the Borough opposing it.
  - b. Three assembly members voted to oppose it during the January 14 hearing and the Assembly voted to not-oppose it with a 4/3 vote. The emails and vote tally were not included in the returned application.
- 5) The Kodiak State Trooper detachment response to the application states: "the state airport and airlines serving the airlines next door have reported on multiple occasions of drunken persons who have been denied boarding or trespassed from the airport."
- 6) The Kodiak Island Borough will be holding a Regional Leadership Forum on January 27-29, and the leaders and representatives from the villages will be attending, as will the Director of the Alaska Alcohol and Marijuana Control Office, Cynthia Franklin. I'm sure this will be a topic of intense interest.
