He states that the establishment is known as a bar, and that it is likely that persons under the age of 21 would come to and remain on the premises for purposes other than dining, in violation of 3 AAC 304.725(a)(3).

Adam Wool provides testimony, mentioning types of events that he holds on his premises and access to the balcony, reading written letters of support from former Fairbanks North Star Borough (FNSB) Mayor, Luke Hopkins, and current FNSB Mayor, Karl Kassel (submitted at the meeting), and reading 3 AAC 304.725(d).

Ellen Ganley states that as a resident of Fairbanks, she knows the Blue Loon as both a bar and as a place to go watch movies, and she's intrigued by the FNSB mayors' letters of support. Bobby Evans states that this is another example of the board trying to stretch the rules to accommodate one person, and that he is not in favor of it.
