Reconsideration of Renewal

At the April 6, 2017, meeting, the board approved with delegation the renewal of this beverage dispensary license in Fairbanks. The renewal was protested by the City of Fairbanks for issues related to the fire alarm and sprinkler systems. The protest has not yet been lifted.

Investigators Chiesa and Stonecipher report that the business is closed and appears to have been closed for some time. The building is for sale or lease and a sign on the door says "Temporarily Closed for Renovation." The license has not been surrendered to the office in accordance with 3 AAC 304.195.

Recommendation: Uphold the protest with a 30-day abeyance.

Please be advised that at the Regular Meeting of January 23, 2017, the Fairbanks City Council voted to **PROTEST** on the following Liquor License Renewal application until certain items are addressed:

Lic. #	DBA	License Type	Licensee	Premises Address
2124	McCoy's on 28th	Beverage Dispensary	636, LLC	636 28th Ave.

The Council voted to PROTEST the license until the following violations that were listed in the Fairbanks Fire Department memo dated January 17, 2017 are addressed and corrected:

- 1) Fire alarm system has deficient components that require repair or replacement, does not monitor the status of the sprinkler system and is required to report to an approved monitoring agency; and
- 2) Sprinkler system has deficient components, other than previously mentioned (in the memo), that require repair or replacement.

Also, the City Council voted to require that a sprinkler system be installed in the boiler room within one year (January 23, 2018).
