Beverage Dispensary Third Waiver Request

In April of 2015, the board first considered a transfer of this license from Zachery and Anjanette Steer, DBA Sheep Mountain Lodge near Palmer, to Nine Oh Seven Corporation, DBA "907 Club" in Big Lake. Due to protests, objections, appeals, and court actions, the transfer process for this license was considered at six different board meetings between 2015 and 2017. In July of 2017, the board voted to approve the transfer with delegation. The first and second waivers of operation for the 2015 and 2016 licensing years were submitted by the licensee in January of 2017 but were not brought to the board until September of 2017, when they were approved. This application is for a third waiver, for the 2017 licensing year.

Mr. Steer has since rescinded the application for transfer to the Nine Oh Seven Corporation and is working on a transfer application to a different entity. He has stated that he expects that application to be ready for board consideration in January of 2018.

Recommendation:

Evaluate the request against 3 AAC 304.170.
