On August 1, 2016, a regular transfer (without security interest) of this license was finalized, transferring it from Scruff N Pork's Inc. (Curtis Hatcher) to Wildeberry LLC (Robert and Amber Hannum).

Mr. Hatcher and Mr. Hannum agreed that if Mr. Hannum defaults on payments due, Mr. Hannum will voluntarily agree to complete the process of re-transferring the license back to Scruff N Pork's Inc.

This 2017 license transfer from Wildeberry LLC, DBA Grizzli's, to Papa Sugar Daddy's LLC, no DBA, was found complete by AMCO on March 24, 2017. The transfer application is a "regular" transfer, not an involuntary retransfer. No documents indicating a security interest approved by the board under AS 04.11.670 and 3 AAC 304.107 were submitted. The transferee of this 2017 transfer is not the same entity as the one who originally transferred the license to Wildeberry in 2016.

The Board tabled this application for transfer of ownership, transfer of location, and DBA change at the April and July 2017 meetings pending resolution of objections from the Department of Labor and from multiple creditors. The City of Fairbanks does not protest. The objections have not been withdrawn.

On March 30, 2017, AMCO received a letter from the lawyer for the Wildberry LLC Chapter 7 Bankruptcy Trustee indicating that bankruptcy was filed on February 21, 2017, and objecting to the transfer. This letter did not come to my attention until after the April board meetings.

Mr. Hatcher's information, provided to the board in April and attached to this memo, indicates he is trying to have the license transferred back to him under AS 04.11.360(4)(b) because of a private agreement between himself and Mr. Hannum. However, because a security interest in the license was neither requested nor established at the time of license transfer from Mr. Hatcher to Mr. Hannum, there can be no involuntary re-transfer, even if desired by both parties.

The board tabled this matter at the September 2017 meeting at the request of Mr. Hatcher, as his counsel was unavailable to attend the meeting. Mr. Hatcher's attorney, Mr. Gazewood, provided additional information, as did Mr. LeRoy, the attorney for Kenneth Battley, the bankruptcy trustee.

This signed and notarized document is agreed upon between Robert L. Hannum Sr. and Curtis L. Hatcher.


AMCO Board,

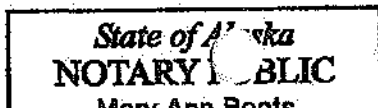
Robert, as stated in our contracts, has voluntarily agreed to retransfer Liquor License #1377 back to Curtis Hatcher.

Dear Ms. McConnell:

I have previously alerted your office that Wild Berry LLC, the owner of license 1377, filed a chapter 7 bankruptcy on February 21, 2017. Kenneth Battley is the Chapter 7 Trustee and I am his attorney. A copy of the Notice of Bankruptcy is attached.

I received last week a copy of a letter from Jason Gazewood to your office concerning the attempt to transfer that license from Wild Berry, LLC to Scruff-N-Pork's Inc., or to Papa Sugar Daddy's LLC, or Curtis L. Hatcher. Neither I nor the Trustee have received notice from Mr. Gazewood or Mr. Hatcher of an intended transfer of the license out of the Debtor's name into Mr. Hatcher's name.

I believe Mr. Gazewood's letter may be further documentation for the February 24, 2017 Transfer License Application for a "no premises" transfer from the Debtor, Wild Berry, LLC, to Papa Sugar Daddy's LLC and or Curtis L. Hatcher.

We think that Mr. Hatcher's application is deficient for several reasons.

1. If the transfer is intended to be an involuntary transfer back to the prior owner of the license, Mr. Hatcher, without satisfaction of the Debtor's creditors, it cannot be approved because it does not satisfy the conditions in 3 AAC 304.107: No lease or contract for sale of property was recorded in the Fairbanks Recording District, and none of the required notices containing the language required by 3 ACC 304.107(a)(1) were recorded or published in your file for this license. We think that Mr. Hatcher's claim to be secured by the license was an afterthought and was not part of the original transfer to Wild Berry, LLC, as is required by 3 ACC 304.107(a)(2).
2. If the transfer is intended to be a voluntary transfer which relies upon the January

5, 2017 Transferor Certification of the owner of Wild Berry, LLC, by Robert Hannum, Sr., that attempt at transfer is ineffective. Mr. Battley, the chapter 7 bankruptcy trustee of Wild Berry, LLC, revokes the approval of Mr. Hannum.

3. If the transfer is intended to be a voluntary transfer in which the creditors of the Debtor have been given notice, the application is deficient because it has not given all creditors of the Debtor, Wild Berry, LLC, notice of the application to transfer.

I am attaching a copy of the claims register in the bankruptcy showing that sixteen claims in the bankruptcy were filed for a total of \$2,395,849.20. These claims include claim #16 filed by Mr. Gazewood on behalf of Scruff-N-Pork's, Inc. That claim, copy attached, is filed, in part, as a secured claim, secured against the license #1377. But the claim does not contain the documentation necessary under 3 AAC 304.107(a) to establish that Scruff -N-Pork's Inc. holds a security interest in the license. In particular, (i) there was no recording of a contract or lease, (ii) the prior transfer of the license to Wild Berry, LLC did not make the disclosures required by 3 ACC 304.107(a)(2), particularly, that Scruff-N-Pork was retaining a security interest in the license, and (iii) there was no published notice in connection with the previous transfer that Scruff-N-Pork was retaining a security interest in the license.

The bankruptcy trustee's fiduciary duty to maximize the value of the Debtor's only asset, license #1377, for the benefit of all creditors according to their priorities. That is not occurring in this case.

Kenneth Battley, bankruptcy trustee, for the benefit of the creditors of Wild Berry, LLC, objects to any transfer of the license #1377 to Papa Sugar Daddy's LLC, and or Curtis L. Hatcher and or Scruff-N-Pork's Inc.
