A criminal history background report revealed that one of the shareholders had a felony drug conviction in 2013. The applicant says the conviction was later reduced to a misdemeanor. Depending on the content of the documents provided and sensitivity of the discussion, the board may need to evaluate whether the matter qualifies for discussion in executive session in accordance with AS 44.62.310(c).

Recommendation:

If the board finds that the shareholder has been convicted of a felony within the last 10 years, it may evaluate whether denial of the application is in the public interest under 3 AAC 304.180(a)(1)(D).
