She states that the Mat-Su Borough has lifted its protest to the application but has said that it has received a public appeal and an appeal from the applicant. She states that the matter needs to be tabled in order to meet the legal requirements for a public hearing.

Jenna Lundy-Conner identifies herself for the record as an employee of Mr. Button and provides testimony regarding the protest. She provides copies of the lifted protest from the Borough, the lifted objection from DEC, and a petition that she created. She states that Mr. Button is appealing the hours of operation that were put in the conditional use permit.

Robert Button identifies himself for the record and reiterates that the only condition he is appealing is the hours of operation, and he requests that the board make a decision today regarding the license.

Cynthia Franklin reminds the board and public that the testimony going on right now cannot be considered the public hearing, and she reminds everyone the difference between a protest and an objection. She additionally reads the language from AS 04.11.470 for the record and clarifies for the board that the statute does not require that there be a legal reason for any objection.

Bobby Evans motions to table the application until the next meeting. Ellen Ganley seconds the motion. Motion carries unanimously.

Audrey Renschen identifies herself for the record and tells the board that there are about fifteen people in the room who are objecting to the application and asks if she could submit a petition.

Cindy Bettine informs the board that she has a copy of Mr. Button's appeal to the Borough's conditions and states that his testimony today is inconsistent with his written appeal.

John Rush, an appellant, identifies himself for the record and states that he can testify during the February meeting.

Evelyn Rush and Millie Renkert, long-time residents of Rocky Lake and objectors to the application, identify themselves for the record and state that they've driven in to provide testimony.

Cynthia Franklin informs the board that the Petersburg Moose Lodge was issued an accusation, and that they and their attorney had an informal conference with her. By the time they got to this meeting, there had been numerous trainings by the licensee, and a problem member has been removed from the lodge. Director Franklin has made the decision to remove the accusation because of the trainings and the fact that the Petersburg police department has complete access to the lodge at all hours.

James Hoelscher informs the board that Little Italy has been issued two NOVs, the second is because the licensee has not responded to the first.

#### • ALCOHOL SERVER EDUCATION COURSE PROVIDERS

**A.** Access in Rural Communities

#### <u>12:24:05 PM</u> <u>TAB 19</u>

James Hoelscher provides the board background as to why this has come up. The most common NOV issued is for expired alcohol server education, and a common reason given by licensees in rural areas is because the classes are not provided online. Investigator Hoelscher states that his interpretation of the regulation is that if a person is unable to attend the in-person course that's provided once a month, that he/she should be able to take the course online, as the intent is to have people educated.

Cynthia Franklin adds that a common complaint from people who have expired server education cards is that they sign up for a class that's offered in-person by CHARR, but that nobody from CHARR comes to give the class. When the individuals call CHARR, they are told that because there are in-person courses provided in the community, they are not allowed to take the course online.

Dale Fox, Alaska CHARR, states that he is looking for clarification about providing online courses. He states that people who say they are unable to take the course are fibbing. He states that he has provided the class records, including sign-in sheets, to the investigators.

James Hoelscher clarifies that he does not want to replace an in-person course; he wants people to have alcohol server education available if they are unable to attend an in-person course so that they aren't working without any education.

Harriet Milks states that the "or" in the regulation requires that the applicant provide for the scenarios being described.

Bob Klein states that interface is crucial, and that the middle ground would be to provide an online course during specific hours with an instructor available immediately.

Dale Fox requests a definition of "rural" from the board.

Bob Klein requests that Mr. Fox determine which areas he wants to hold classes, and all other communities are considered "rural".

Bobby Evans states, as the rural member, that he agrees that they should have online classes available.

Harriet Milks states that she is concerned that the board is making policy decisions that will have an impact on communities without public notice given. She states that this decision is something that needs to be changed through a regulation.

James Hoelscher requests that the board require course providers to make the online courses available to communities that meet the current definition of "rural" in our laws.

Sarah Oates informs the board and the public that course providers will be contacted this year for review as required under AS 04.21.205(d).

Bob Klein instructs Investigator Hoelscher and Mr. Fox to meet before the February meeting and try to come up with a recommendation.

#### **REGULATIONS**

A. Update on Status of Open Projects

Cynthia Franklin updates the board on the status of open regulations projects.

Sarah Oates informs the board that AS 04.11.130(e) for consumption at breweries has been essentially copied to clarify the rules around consumption at wineries, with a minor change that would differentiate between wine and cider, the latter of which typically has an alcohol content more like that of beers.

Harriet Milks requests that subsection (a)(1) add cider, so that cider with an alcohol content of 8.5 percent or more is clearly covered under the regulation.

Tom Manning motions to accept the winery license draft to be put out for public notice, as amended.

Ellen Ganley seconds the motion. None opposed.

Cynthia Franklin informs the board that this amendment would require that all employees of licensees and permittees who sell or serve alcohol to the public or check ID receive alcohol server education.

Bobby Evans motions to approve the draft to be put out for public comment. Ellen Ganley seconds the motion. Motion carries unanimously.
